A RESOLUTION

- 1 Designating the week of July 23 through 29, 2023, as
- "Construction Opioid Awareness Week" in Pennsylvania.
- 3 WHEREAS, Opioids are deadly and are responsible for claiming
- 4 approximately 600,000 American lives between 1999 and 2021; and
- 5 WHEREAS, In 2021, drug overdose deaths in the United States
- 6 reached their highest point ever recorded with more than 106,000
- 7 deaths according to the Centers for Disease Control and
- 8 Prevention (CDC); and
- 9 WHEREAS, Nearly 75%, or 80,411, of overdose deaths in 2022
- 10 involved an opioid according to the CDC; and
- 11 WHEREAS, The construction industry, which involves physically
- 12 demanding labor and employs an aging workforce, has been
- 13 particularly vulnerable to the opioid epidemic; and
- 14 WHEREAS, Drug abuse issues in the construction industry
- 15 endanger not only the individual worker, but the companies they
- 16 work for, other workers on the jobsite and the general public
- 17 near jobsites; and
- 18 WHEREAS, The summer months are the busiest for the

- 1 construction industry and are an ideal time for promoting
- 2 awareness of the dangers of opioid abuse; and
- 3 WHEREAS, Many construction organizations have been utilizing
- 4 services and resources from the National Safety Council to
- 5 create an educational toolbox for members of the construction
- 6 industry, including materials to facilitate discussions with
- 7 workers about the dangers of opioids and prescription drug
- 8 abuse, and "Warn Me" stickers to place on workers' insurance
- 9 cards in the hopes of encouraging health care providers to
- 10 discuss opioid issues with those workers; and
- 11 WHEREAS, The following groups plan to promote the awareness
- 12 and dangers of opioids and prescription drug abuse within the
- 13 construction industry during the last full week in the month of
- 14 July:

- 14 RESOLVED, That the construction industry in Pennsylvania be
- 15 encouraged to promote awareness of the dangers of opioids and
- 16 prescription drug abuse with workers in the industry and
- 17 facilitate discussions and events such as "Drug Take Back"
- 18 events to combat the opioid and prescription drug abuse epidemic
- 19 in Pennsylvania's construction industry.
