3	WHEREAS, Former Senator Donald O. Oesterling, who served the
4	constituents of the 21st Senatorial District from 1964 to 1972,
5	died on Sunday, January 20, 2013, at the age of 85; and
6	WHEREAS, Senator Oesterling was originally from Butler, and,
7	after he attended Butler public schools, he enlisted in the
8	United States Navy Reserves and served in the Atlantic Theater
9	during World War II; and
10	WHEREAS, After earning his undergraduate degree from Capitol
11	University, Senator Oesterling served as President of Regal
12	Products, Inc., as a radio commentator; and
13	WHEREAS, After being elected to serve as Senator for the 21st
14	Senatorial District in 1964, he continued to serve until 1972;

2 WHEREAS, Senator Oesterling served on the Elections and 3 Reapportionment Committee, which he chaired, the Forests and 4 Waters, Game and Fish Committee, for which he was the Vice 5 Chair, and as Majority Caucus Chairman; and

6 WHEREAS, Even after his service in the Senate, Senator 7 Oesterling continued to be active in his community and worked on 8 a number of projects over the years, including serving as State 9 President of the Pennsylvania Elks, exalted ruler of the Butler 10 Elks and as a member of the American Legion and Veterans of 11 Foreign Wars; and

12 WHEREAS, Senator Oesterling is survived by his beloved wife, 13 Ann, their three children, Dawn, Michael and Peter, his two 14 brothers, Samuel and Thomas, as well as five grandchildren and 15 three great-grandchildren; and
