A RESOLUTION

1 2	Recognizing the month of May 2022 as "Stroke Awareness Month" in Pennsylvania.
3	WHEREAS, A stroke is the interruption of blood supply to the
4	brain; and
5	WHEREAS, The symptoms of a stroke include numbness in the
6	face, arm or leg, difficulty speaking, a severe headache,
7	difficulty walking or a lack of coordination and vision loss;
8	and
9	WHEREAS, More than 795,000 Americans experience a stroke each
10	year making it a leading cause of death and long-term disability
11	according to the National Institute of Neurological Disorders
12	and Stroke; and
13	WHEREAS, In 2017, 6,700 Pennsylvanians died of a stroke
14	making it the Commonwealth's fourth leading cause of death; and
15	WHEREAS, The most severe type of stroke is known as emergent
16	large vessel occlusion (ELVO), and it occurs when a clot
17	prevents the flow of blood and oxygen to the brain and kills up

1 to 2 million brain cells each minute until it is removed; and 2 WHEREAS, Revolutionary advancements in medical innovation 3 have made it possible to save more lives and prevent long-term disability among patients afflicted with a stroke such as ELVO, 4 5 provided that they are triaged and transported to the most 6 appropriate medical facilities for lifesaving care; and 7 WHEREAS, Level 1 stroke centers located throughout 8 Pennsylvania are staffed with highly trained neurointerventional care teams who perform a minimally invasive procedure called 9 10 mechanical thrombectomy, through which the clot responsible for the stroke is quickly located and removed restoring blood flow 11 12 to the brain; and

13 WHEREAS, During "Stroke Awareness Month," and year round, the 14 Society of NeuroInterventional Surgery's "Get Ahead of Stroke®" 15 initiative encourages collaboration among first responders, 16 providers, patient advocates and other interested stakeholders in developing and adopting a triage and transport system for 17 18 critical stroke patients to ensure that they are transported 19 directly to Level 1 stroke centers, which are best equipped to 20 provide lifesaving care; and

21 WHEREAS, The Department of Health's Bureau of Emergency 22 Medical Services is to be commended for taking the initial steps 23 necessary to improve the Commonwealth's triage and transport of 24 stroke patients through recent updates to the Pennsylvania Basic 25 Life Support (BLS) protocol; and

26 WHEREAS, It is fitting and proper that Pennsylvanians 27 recognize "Stroke Awareness Month" and acknowledge the 28 commendable work of organizations such as the Society of 29 NeuroInterventional Surgery which are dedicated to improving 30 systems of care for stroke patients to help save lives and
