INTRODUCED AND ADOPTED, MARCH 10, 2014

A RESOLUTION

- 1 Observing March 14, 2014, as "Charter Day" in Pennsylvania.
- WHEREAS, On March 4, 1681, King Charles II of England granted
- 3 William Penn a charter for land in the New World to make up for
- 4 a large debt that the king owed to Penn's father; and
- 5 WHEREAS, William Penn had initially decided to name the land
- 6 "Sylvania," which in Latin means "woods" and to which King
- 7 Charles II added the prefix "Penn" to the name in honor of
- 8 William Penn's father, Admiral Sir William Penn, who had served
- 9 England as a rear admiral and vice admiral of Ireland, a vice
- 10 admiral of England, a general in the first Dutch War and great
- 11 captain commander under the Duke of York; and
- 12 WHEREAS, William Penn wrote a Frame of Government of
- 13 Pennsylvania that established a democratic system containing
- 14 freedom of religion, fair trials using independent juries,
- 15 assemblies consisting of elected representatives of the people
- 16 and a separation of powers in the government, all ideas that

- 1 later influenced the Constitution of the United States; and
- 2 WHEREAS, William Penn described Pennsylvania as a "holy
- 3 experiment" and from it, he hoped, a nation based on justice
- 4 would grow; and
- 5 WHEREAS, William Penn's charter exists as the formal
- 6 beginning of the colony and the Commonwealth of Pennsylvania and
- 7 through it William Penn established democratic principles
- 8 foundational to the colonies that would eventually become the
- 9 United States of America; and
- 10 WHEREAS, Citizens benefit from learning more about the
- 11 overall history of this Commonwealth from its founding and how
- 12 the principles of governance within the Commonwealth date back
- 13 to the beliefs of William Penn; and
- 14 WHEREAS, The act of July 28, 1953 (P.L.676, No.210) provides
- 15 for the observance of March 14th of each year as Charter Day and
- 16 urges the people of this Commonwealth, the public schools and
- 17 other educational institutions and patriotic, religious,
- 18 historical and veterans' organizations to observe the
- 19 anniversary of the execution of the Royal Charter by King
- 20 Charles II; and
- 21 WHEREAS, The Pennsylvania Historical and Museum Commission
- 22 (PHMC), the Pennsylvania State Archives and the State Historical
- 23 Records Advisory Board work to inform our residents about the
- 24 Commonwealth's heritage, including sponsoring the 15th Annual
- 25 Charter Day event on Sunday, March 9, 2014, at all PHMC historic
- 26 sites and properties throughout the State; and
- 27 WHEREAS, This free event includes a presentation of the
- 28 original 1681 Charter at Pennsbury Manor, Penn's Pennsylvania
- 29 home; and
- 30 WHEREAS, The Charter is sometimes referred to as the

- 1 Commonwealth's "birth certificate" and the Charter on display
- 2 was William Penn's personal copy; and
- 3 WHEREAS, The Charter will be on display at Pennsbury Manor
- 4 until March 16, 2014; and
- 5 WHEREAS, Pennsylvania has 25 other State historic sites and
- 6 museums and numerous other historical organizations that
- 7 continue to operate, largely thanks to the assistance of
- 8 volunteers and other groups that have donated their money, time
- 9 and other resources so that residents can remain well informed
- 10 about the fabric of this Commonwealth's history; therefore be it
- 11 RESOLVED, That the Senate observe March 14, 2014, as "Charter
- 12 Day" in Pennsylvania; and be it further
- 13 RESOLVED, That residents, schools, other educational
- 14 institutions and patriotic, religious, historical and veterans'
- 15 organizations be urged to participate in the Charter Day
- 16 activities sponsored by the Pennsylvania Historical and Museum
- 17 Commission, the Pennsylvania State Archives, the State
- 18 Historical Records Advisory Board, the 25 other State historic
- 19 sites and museums or those offered by any of the many other
- 20 historical organizations within this Commonwealth; and be it
- 21 further
- 22 RESOLVED, That the volunteers and other residents who keep
- 23 history alive through their support and work for the PHMC, the
- 24 Pennsylvania State Archives, the State Historical Records
- 25 Advisory Board, the 25 other State historic sites and museums or
- 26 through the numerous other historical organizations within this
- 27 Commonwealth be honored for their efforts.
