- 6 September 14, 2022, at 58 years of age, following a long battle

- 9 Pyle, was born August 30, 1964, in Kittanning and graduated from
- 10 Ford City High School in 1982; and
- 11 WHEREAS, Representative Pyle earned a Bachelor of Arts degree
- 12 in Political Science from West Virginia University and a
- 13 Bachelor of Science degree in Social Studies Education from
- 14 Indiana University of Pennsylvania; and
- 15 WHEREAS, Representative Pyle began his career as an American
- 16 History, Government and Sociology teacher for the Armstrong
- 17 School District from 1992 to 2004; and

- 1 WHEREAS, Representative Pyle cared greatly for the welfare of
- 2 all his students and was named "Educator of the Year" in 1999 by
- 3 the Armstrong School District in recognition of his efforts with
- 4 drug abuse prevention; and
- 5 WHEREAS, Representative Pyle was named "Conservation Educator
- 6 of the Year" by the Armstrong Conservation District in 2000; and
- 7 WHEREAS, Representative Pyle was an active member of his
- 8 local community, serving as the Mayor of Ford City from 2001 to
- 9 2004; and
- 10 WHEREAS, Representative Pyle dutifully served the people of
- 11 the 60th Legislative District as their State representative for
- 12 16 years from 2005 to 2021; and
- 13 WHEREAS, A kidney cancer diagnosis in 2005 and his subsequent
- 14 battle with cancer over the years never prevented Representative
- 15 Pyle from being an ardent advocate of the needs of his
- 16 constituents and a dedicated servant to the residents of this
- 17 Commonwealth; and
- 18 WHEREAS, Representative Pyle's strong work ethic, good humor,
- 19 enthusiasm and genuine nature left a lasting impact upon many
- 20 members in both chambers of the General Assembly; and
- 21 WHEREAS, Representative Pyle's lifelong passion and
- 22 commitment to education will be hereafter memorialized by the
- 23 completion of the new Butler County Community College campus in
- 24 Ford City, a project made possible only by the vision, hard work
- 25 and dedication of Representative Pyle; and

- 27 28 years, Michele Pyle (née Buccieri), and their two daughters,
