INTRODUCED AND ADOPTED, MAY 7, 2014

A RESOLUTION

1 Designating May 2014 as "SAG-AFTRA Month" in Pennsylvania and
2 recognizing the artistic and economic contributions of SAG-
3 AFTRA members' work in the news media and the entertainment
4 industry.

5 WHEREAS, The Screen Actors Guild and the American Federation
6 of Television and Radio Artists were each formed in the 1930s
7 and merged in 2012 to form SAG-AFTRA; and

8 WHEREAS, SAG-AFTRA represents more than 160,000 members who
9 work as actors, broadcast journalists, dancers, television and
10 radio announcers, news editors, program hosts, puppeteers,
11 recording artists, singers, voice-over artists and other media
12 professionals; and

13 WHEREAS, SAG-AFTRA members work in movies, television and
14 radio, on the Internet and in other forms of media distribution;
15 and

16 WHEREAS, SAG-AFTRA works on behalf of its members to secure
17 the strongest possible protections for media artists, including
18 organizing all work done under its jurisdiction; negotiating

1 better wages, working conditions and health and pension benefits
2 for its members; protecting and expanding job opportunities of
3 members; enforcing member contracts; and protecting members
4 against unauthorized use of their work product; and

5 WHEREAS, SAG-AFTRA is a member of the American Federation of
6 Labor and Congress of Industrial Organizations that works
7 closely with other unions to seek protection for media artists
8 in the United States and abroad; and

9 WHEREAS, The SAG-AFTRA Philadelphia Local represents members
10 in eastern Pennsylvania and the SAG-AFTRA Ohio-Pittsburgh Local
11 represents members in western Pennsylvania; and

12 WHEREAS, The presence of a skilled professional community in
13 Pennsylvania helps to attract theatrical and commercial artistic
14 endeavors to this Commonwealth; and

15 WHEREAS, SAG-AFTRA works to create and expand job
16 opportunities for its members within this Commonwealth;
17 therefore be it

18 RESOLVED, That the Senate designate May 2014 as "SAG-AFTRA
19 Month" in Pennsylvania; and be it further

20 RESOLVED, That the Senate recognize the important artistic
21 and economic contributions of SAG-AFTRA members' work in the
22 news media and the entertainment industry.
