#### RELATING TO MOTOR AND OTHER VEHICLES -- BUS LANE TRAVEL FINE

It is enacted by the General Assembly as follows:

SECTION 1. Section 31-41.1-4 of the General Laws in Chapter 31-41.1 entitled

2 "Adjudication of Traffic Offenses" is hereby amended to read as follows:

(a) The penalties for violations of the enumerated sections, listed in numerical order, correspond to the fines described. However, those offenses for which punishments may vary according to the severity of the offense, or punishment that require the violator to perform a service, shall be heard and decided by the traffic tribunal or municipal court. The following violations may be handled administratively through the method prescribed in this chapter. This list is not exclusive and jurisdiction may be conferred on the traffic tribunal with regard to other violations.

3	of the Road" is hereby amended by adding thereto the following section:
4	31-15-20. Use of bus lane for travel.
5	(a) No person shall operate a motor vehicle for travel upon a designated bus lane, except
6	when making a turn, entering or leaving the roadway or a parking lane, or when required in the
7	course of official duty.
8	(b) Violations of this section are subject to fines enumerated § 31-41.1-4.
9	SECTION 3. This act shall take effect upon passage.
