It is enacted by the General Assembly as follows:

- 1 SECTION 1. Chapter 31-3 of the General Laws entitled "Registration of Vehicles" is
- 2 hereby amended by adding thereto the following section:

31-3-121. Special plate for the MASONIC GRAND LODGE CHARITIES OF

- 4 **<u>RHODE ISLAND.</u>**
- 5 (a) The administrator of the division of motor vehicles is empowered to make available
 6 special motor vehicle registration plates for the not-for-profit, 501(c)(3) Rhode Island
- 7 Corporation, MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND. The plates shall
- 8 be designed to reference the MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND.

9 (b) The special plate shall be displayed upon the same registration number assigned to the

10 vehicle for which it was issued, and shall be used in place of and in the same manner as the

11 registration plates issued to the vehicle. The original registration plates for the vehicle shall be

12 removed from the vehicle and returned to the division of motor vehicles. The registration

- 13 certificate for the plates shall be carried in the vehicle, in accordance with § 31-3-9. The
- 14 registration certificate shall be in effect for the special plate.
- (c) The MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND motor vehicle
 plates shall be the same size as regular motor vehicle plates, and shall be designed by the
 MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND in conjunction with the
- 18 division of motor vehicles, with the design approved by the Rhode Island state police.

1	(d) The MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND plates shall be
2	subject to a minimum pre-paid order of at least six hundred (600) sets of plates per plate type (i.e.
3	passenger, commercial, etc.). The MASONIC GRAND LODGE CHARITIES OF RHODE
4	ISLAND plates shall not be issued unless the minimum order(s) requirements are met. The initial
5	order will be handled by the MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND,
6	and shall not be submitted to the division of motor vehicles for production until the minimum
7	order(s) have been met, and the proper paperwork submitted to the division.
8	(e) The administrator of the division of motor vehicles shall develop application forms,
9	pre-payment procedures and any other procedures deemed necessary to carry out the purposes of
10	this section.
11	(f) In addition to the regular prescribed motor vehicle registration fee, the MASONIC
12	GRAND LODGE CHARITIES OF RHODE ISLAND plates shall be subject to a forty-dollar
13	(\$40.00) issuance surcharge.
14	(g) The forty dollar (\$40.00) issuance surcharge shall be allocated as follows: Twenty
15	dollars (\$20.00) shall be allocated to the general fund and the remaining twenty dollars (\$20.00)
16	shall be distributed annually to the MASONIC GRAND LODGE CHARITIES OF RHODE
17	ISLAND to assist in its charitable work. The distribution to the MASONIC GRAND LODGE
18	CHARITIES OF RHODE ISLAND shall be placed in a restricted account and shall be paid to the
19	MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND.
20	(h) A ten-dollar (\$10.00) surcharge for subsequent registration renewals shall be allocated
21	to the MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND.
22	(i) In consideration of the receipt of funds from the registration of the MASONIC
23	GRAND LODGE CHARITIES OF RHODE ISLAND license plates, the foundation must use any
24	Rhode Island sourced funds in, and for the benefit of, Rhode Island-based charitable
25	organizations.
26	(j) The MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND will be
27	required to submit an annual accounting report before such monies are distributed.
28	(k) There shall be no refunds for early cancellation of MASONIC GRAND LODGE
29	CHARITIES OF RHODE ISLAND plates.
30	SECTION 2. This act shall take effect upon passage.

EXPLANATION
