ESTABLISHING A REAPPORTIONMENT COMMISSION

<u>Introduced By:</u> Representatives Shekarchi, Blazejewski, Kazarian, Ackerman, Edwards, and Abney

It is enacted by the General Assembly as follows:

1 SECTION 1. Establishment of commission. - (a) There is hereby created a special 2 commission on reapportionment, which shall consist of eighteen (18) members: four (4) of whom 3 shall be from the house of representatives, to be appointed by the speaker; two (2) of whom shall be from the house of representatives, to be appointed by the minority leader of the house of 4 5 representatives; four (4) of whom shall be from the senate, to be appointed by the president of the senate; two (2) of whom shall be appointed by the minority leader of the senate; three (3) of whom 6 7 shall be members of the general public to be appointed by the speaker; and three (3) of whom shall be members of the general public to be appointed by the president of the senate. 8 9 (b) It shall be the purpose and responsibility of the commission to draft and to report to the

(b) It shall be the purpose and responsibility of the commission to draft and to report to the general assembly an act to reapportion the districts of the general assembly and the state's United States congressional districts and to perform the necessary functions incident to drafting such an act including, but not limited to, the division of the state into seventy-five (75) state representative districts, thirty-eight (38) state senatorial districts and two (2) United States congressional districts as near equal as possible, subject to the final 2020 census data provided by the United States Census Bureau.

- (c) Forthwith upon the passage of this act, the members of the commission shall meet and organize, and shall select from among themselves a chairman. Vacancies in said commission shall be filled in like manner as the original appointment.
- (d) The membership of said commission shall receive no compensation for their services.

3	(e) All departments and agencies of the state shall furnish such advice and information,
4	documentary and otherwise, to said commission and its agents as is deemed necessary or desirable
5	by the commission to facilitate the purposes of this act.
6	(f) The joint committee on legislative services is hereby authorized and directed to provide
7	suitable quarters for said commission, and provide technical and other assistance to the commission
8	as it may deem necessary to facilitate the purposes of this act.
9	(g) The commission is hereby authorized to accept from local, state and federal government
10	agencies, grants in money, services or other types of assistance in carrying out the purposes of said
11	commission.
12	SECTION 2. Reapportionment standards (a) All districts shall be single member districts.
13	(b) Congressional and state legislative districts shall comply with all requirements of the
14	United States Constitution. All state legislative districts shall comply with all requirements of the
15	United States Constitution and of the Rhode Island Constitution, and recognize pertinent or
16	applicable federal legislation and court precedent, including but not limited to, the Voting Rights
17	Act of 1965.
18	(c) Congressional and state legislative districts shall be as nearly equal in population as
19	possible, and:
20	(1) In no case shall congressional districts vary in population by more than one percent
21	(1%) from each other as determined by the population reported in the federal census in 2020; and
22	(2) In no case shall a single state senate district have a population which varies by more
23	than five percent (5%) from the average population of all senate districts as determined by the
24	population reported in the federal census in 2020, and in no case shall a single state representative
25	district have a population which varies by more than five percent (5%) from the average population
26	of all representative districts as determined by the population reported in the federal census in 2020.
27	(3) Congressional and state legislative districts shall be subject to the final 2020 census
28	data provided by the United States Census Bureau.
29	(d) Congressional and state legislative districts shall be as compact in territory as possible
30	and, to the extent practicable, shall reflect natural, historical, geographical, municipal and other
31	political lines and communities of interest, as well as the right of all Rhode Islanders to fair
32	representation and equal access to the political process.
33	(e) To the extent practicable, congressional and state legislative districts shall be composed
34	of contiguous territory.

The commission may engage such clerical, technical and other assistance as it may deem necessary

1	(f) To the extent practicable, the commission should endeavor to avoid the division of state
2	representative districts in the formation of state senate districts and the division of state senate
3	districts in the formation of United States congressional districts in any manner which would result
4	in the creation of voting districts composed of fewer than one hundred (100) potential voters.
5	SECTION 3. <u>Public access.</u> - (a) The commission shall set its own rules of procedure.
6	(b) The commission shall be subject to the provisions of chapter 42-46 ("open meetings")
7	and chapter 38-2 ("access to public records") of the general laws.
8	(c) The commission shall conduct public hearings prior to the issuance of its findings and
9	recommendations.
10	(d) Members of the public shall have access to the technical software used for district
11	mapping in a location to be determined, in the state house, on a sign up basis, during reasonable
12	business hours as determined by the commission.
13	(e)(i) The commission shall have the discretion to determine if there exists a public health
14	or other emergency or circumstance that could pose a risk to the health and safety of the public and
15	members and staff of the commission, that would affect public access to the state house to utilize
16	the technical software used for district mapping.
17	(ii) Due to the dangers to public health and safety posed by the ongoing COVID-19
18	pandemic, and to provide the public with alternative means of accessing information, the
19	commission, with public notice on the general assembly website, shall provide the public with
20	access to the web-based software program used for district mapping.
21	SECTION 4. Reporting date The commission shall report its findings and
22	recommendations to the general assembly on or before January 15, 2022.
23	SECTION 5. Severability The provisions of this act are severable, and if any provisions
24	hereof shall be held invalid for any reason, such invalidity shall not affect the validity of any other
25	provisions herein. This act shall be construed in all respects so as to meet any constitutional
26	requirements in carrying out the purposes and provisions of this act, and all steps shall be taken
27	which are necessary to meet constitutional requirements.
