It is enacted by the General Assembly as follows:

1 SECTION 1. Section 5-53.1-12.1 of the General Laws in Chapter 5-53.1 entitled  
2 "Solicitation by Charitable Organizations" is hereby amended to read as follows:

3 **5-53.1-12.1. Solicitation -- Requirements.**

4 Prior to orally requesting a contribution, or contemporaneously with a written request for  
5 a contribution, regardless of how the request is made, the following shall be clearly and  
6 conspicuously disclosed:

7 (a) The name of the professional solicitor and professional fund-raiser, the name of  
8 the entity that employed or otherwise engaged the professional solicitor or professional fund-  
9 raiser, and the fact that the solicitation is being conducted by a professional solicitor; and

10 (b) ~~If requested by the prospective donor, the~~ The percentage of the contribution to be  
11 retained by the professional fund-raiser or the company that employed or otherwise engaged the  
12 professional fund-raiser.

13 (c) Any solicitation that is subject to this section, regardless of how the solicitation is  
14 made, shall include the following statement:

15 "My name is [insert full name] and I am an employee of [insert name of fundraising  
16 company]. I am a paid representative soliciting charitable contributions on behalf of [insert name  
17 of charitable organization]. I am required by Rhode Island law to inform you that [insert name of  
18 fundraising company] receives no less than [insert percentage] percent of aggregate contributions

1 [in payment for its fundraising services.](#)

2 SECTION 2. This act shall take effect upon passage.

1           This act would require professional solicitors and professional fund-raisers to disclose the  
2 name of their employer and the percentage of the contribution solicited by the fundraiser that will  
3 be retained by the fundraising company. This act also would require that a specific statement be  
4 made with all solicitations.

5           This act would take effect upon passage.
