HOUSE RESOLUTION

CREATING A SPECIAL LEGISLATIVE COMMISSION TO STUDY WASTE AND ENERGY
INCINERATION IN THE STATE OF RHODE ISLAND

Introduced By: Representatives Brien, Ucci, Edwards, Reilly, and Chippendale

Date Introduced: January 26, 2012

Referred To: Placed on House Calendar

1 RESOLVED, That a special legislative commission be and the same is hereby created
2 consisting of five (5) members: five (5) of whom shall be members of the House of
3 Representatives, not more than three (3) from the same political party, to be appointed by the
4 Speaker.

5 In lieu of any appointment of a member of the legislature to a permanent advisory
6 commission, a legislative study commission, or any commission created by a General Assembly
7 resolution, the appointing authority may appoint a member of the general public to serve in lieu
8 of a legislator, provided that the majority leader or the minority leader of the political party which
9 is entitled to the appointment consents to the member of the general public.

10 The purpose of said commission shall be to make a comprehensive study on waste-to-
11 energy incineration in the state of Rhode Island.

12 Forthwith upon passage of this resolution, the members of the commission shall meet at
13 the call of the Speaker of the House and organize, and shall select co-chairpersons from among
14 the legislators.

15 Vacancies in said commission shall be filled in like manner as the original appointment.

16 The membership of said commission shall receive no compensation for their services.

17 All departments and agencies of the state, shall furnish such advice and information,
18 documentary and otherwise, to said commission and its agents as is deemed necessary or
19 desirable by the commission to facilitate the purposes of this resolution.

1 The Joint Committee on Legislative Services is hereby authorized and directed to
2 provide suitable quarters for said commission; and be it further

3 RESOLVED, That the commission shall report its findings and recommendations to the
4 House of Representatives no later than March 28, 2013, and said commission shall expire on June
5 27, 2013.
