1	WHEREAS, Ernest (Ernie) A. Almonte, CPA, CFE, CFF, CGFM, CITP, has served with
2	distinction as the State of Rhode Island and Providence Plantations' Auditor General for more
3	than 15 years; and
4	WHEREAS, Ernie has not only preserved, but also enhanced, the reputation of the Office
5	of the Auditor General, a widely respected government audit agency serving the General
6	Assembly and the public with independent, nonpartisan information on the operations of state and
7	local government; and
8	WHEREAS, Ernie has upheld and embraced the core values of the Office of the Auditor
9	General—integrity, reliability, independence, and accountability in accomplishing the mission of
10	the Office of the Auditor General; and
11	WHEREAS, During Ernie's tenure as Auditor General, he has overseen the release of
12	hundreds of audit reports that have improved accountability, enhanced transparency, and resulted
13	in cost savings and other efficiencies within state government operations and local municipal
14	operations; and
15	WHEREAS, His leadership as the Auditor General has enabled the Office of the Auditor
16	General to assist Rhode Island's municipalities in improving their finances and complying with
17	the general laws of the state, guiding them through fiscal challenges both large and small, and
18	ultimately helping them achieve fiscal stability; and

WHEREAS, Ernie is recognized as a national leader in the accounting profession through

1	his service to the American Institute of Certified Public Accounts (AICPA), where he most
2	recently served as Chairman of the Board and held other leadership positions; and
3	WHEREAS, Ernie has been a charismatic and energetic local leader in the accounting
4	profession, having served on the Board of Directors and as President of the Rhode Island Society
5	of Certified Public Accountants, the Rhode Island Government Finance Officers Association, and
6	the Rhode Island Chapter of Certified Fraud Examiners; and
7	WHEREAS, Ernie has also lent his considerable leadership skills to many other
8	organizations, including the National State Auditors Association, the New England
9	Intergovernmental Audit Forum, and the Rhode Island Employer Support of the Guard and
10	Reserve; and
11	WHEREAS, Ernie has been the recipient of numerous awards related to the performance
12	of his duties as Auditor General, including the Rhode Island Public Expenditure Council's Robert
13	M. Goodrich Distinguished Public Service Award, the Department of Army Outstanding Civilian
14	Service Medal, and the Giovanni da Verazzano Man of the Year Award for Outstanding Service
15	to the Rhode Island Community. He has also been named by Accounting Today as one of the Top
16	Most Influential People in the Accounting Profession in 2005 and 2008; and
17	WHEREAS, Ernie was a member of Bryant University's Class of 1978, and later earned
18	a Master's of Science degree in Taxation from Bryant University; and
19	WHEREAS, Bryant University conferred an honorary Doctor of Business Administration
20	degree upon Ernie in 2009; and
21	WHEREAS, Ernie advanced his governmental training through completion of the Senior
22	Executives in State and Local Government and Innovations in Governance programs at Harvard
23	University's John F. Kennedy School of Government; and
24	WHEREAS, Ernie became a Certified Public Accountant in 1981. He later achieved
25	recognition as a Certified Fraud Examiner, a Certified Information Technology Professional, and
26	a Certified Government Financial Manager, and became Certified in Financial Forensics; and
27	WHEREAS, Ernie is the devoted husband of Kathy and loving father of Christopher,
28	David, Stephen, Ryan, and Patrick; now, therefore be it
29	RESOLVED, That this House of Representatives of the State of Rhode Island and
30	Providence Plantations hereby congratulates Ernest A. Almonte on his completion of fifteen years
31	of exemplary service as the State of Rhode Island's Auditor General. This House of
