RELATING TO STATE AFFAIRS AND GOVERNMENT -- RHODE ISLAND COMMERCE CORPORATION -- RHODE ISLAND -- IRELAND TRADE COMMISSION

It is enacted by the General Assembly as follows:

SECTION 1. Chapter 42-64 of the General Laws entitled "Rhode Island Commerce Corporation" is hereby amended by adding thereto the following section:

42-64-42. Rhode Island-Ireland trade commission.

4 (a) There is hereby established the Rhode Island-Ireland trade commission. The
5 commission is advisory and shall consist of seven (7) members to be appointed as follows:

(1) Two (2) members who shall be appointed by the president of the senate, shall have knowledge of or current or past involvement in organizations that promote Irish affairs, or shall have interest in the well-being of trade relations between Rhode Island and Ireland; and two (2) members who shall be appointed by the speaker of the house, shall have knowledge of or current or past involvement in organizations that promote Irish affairs, or shall have interest in the well-being of trade relations between Rhode Island and Ireland. The members of the commission appointed by the speaker of the house shall serve for two (2) years or until their successor is appointed, and the members appointed by the president of the senate shall serve for three (3) years or until their successor is appointed, whichever period is later.

(2) Three (3) members of the commission shall be appointed by the governor, and shall serve for a term of four (4) years or until their successor is appointed. The members appointed shall include one representative from a public institution of higher education; one representative from the Rhode Island chamber of commerce, or its successor organization; and one public member who

| 6 | members may be reimbursed for expenses actually incurred in the performance of their duties, |

| 9 | (2) The commission shall meet and hold hearings at the places it designates throughout the |

| 11 | (3) The commission shall elect a chair from among its members. The chair may appoint |
| 12 | from among the commission members subcommittees and subcommittee chairs at the chair's |
| 13 | discretion. |
| 14 | (4) The commission shall keep records of all proceedings which shall be public and open |
| 15 | to inspection, shall adopt a seal, and shall exercise and perform the duties prescribed by this section. |
| 16 | (5) A majority of the members of the commission shall constitute a quorum for the |
| 17 | transaction of the business of the commission. |
| 18 | (c) The commission shall provide recommendations and information to the Rhode Island |
| 19 | commerce corporation established pursuant to § 42-64-4 and the director of the John H. Chafee |
| 20 | Center for International Business to promote, enhance and advance the relationship and trade with |

| 22 | (d) Role and responsibility. The role and responsibility of the Rhode Island-Ireland trade |
| 23 | commission shall be to study, research and advance analyses, proposals and recommendations for: |
| 24 | (1) Bilateral trade and investments between Rhode Island and Ireland; |
| 25 | (2) Policy issues of mutual interest to Rhode Island and Ireland; |
| 26 | (3) Promoting business and academic exchanges between Rhode Island and Ireland; |
| 27 | (4) Mutual economic support between Rhode Island and Ireland; |
| 28 | (5) Mutual investments in the infrastructure of Rhode Island and Ireland; |
| 29 | (6) Helping communities in Ireland and Rhode Island through the creation of educational |
| 30 | and economic opportunities; and |
| 31 | (7) Such other issues as requested by the Rhode Island commerce corporation. |
| 32 | (e) Reports. |
| 33 | The commission shall report its findings, results, and recommendations to the governor, |
| 34 | the speaker of the house, the president of the senate, and the secretary of commerce with a copy to |

| 9 | and bequests from individuals, corporations, foundations, governmental agencies, and public and |
| 10 | private organizations and institutions, to defray the commission's administrative expenses and to |
| 11 | achieve its purposes. |
| 12 | (g) All meetings of the commission shall comply with the provisions of chapter 46 of title |
| 13 | 42 ("open meetings"). |
| 14 | SECTION 2. This act shall take effect upon passage. |
