It is enacted by the General Assembly as follows:

2 is hereby amended by adding thereto the following section: 3 42-13-9. Restoration of stone bridge abutment in Portsmouth. 4 (a) The Stone Bridge abutment and property immediately to the south known as "Teddy's 5 Beach" is owned by the state and controlled through the department of transportation (the 6 "department"). In 2019, a portion of the Stone Bridge abutment eroded and collapsed into the 7 Sakonnet River. As a result, the department erected the fencing to close off the property for public use due to safety concerns. The Stone Bridge abutment continues to be closed for public use. In 8 9 addition, the Teddy's Beach property requires cleaning, maintenance, and management by the state. 10 (b) The department shall effectuate a complete and total restoration, reconstruction and 11 refurbishing (the "repair") of the Stone Bridge abutment. The department shall actively pursue and 12 seek any and all federal, state, and other sources of public funding that may be available to 13 accomplish this repair. 14 (c) The department, in conjunction the division of parks and recreation within the

(d) The department shall undertake the actions set forth herein for the possible future
transfer of the Stone Bridge abutment and Teddy's Beach property to the town of Portsmouth.
