### AN ACT

#### RELATING TO EDUCATION - REGIONAL VOCATIONAL SCHOOLS

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 16-45-7 of the General Laws in Chapter 16-45 entitled "Regional

Vocational Schools" is hereby amended to read as follows:

**16-45-7. Annual appropriations.** -- (a) The general assembly shall appropriate any sum

as it may deem necessary for the purpose of reducing local district area vocational technical

5 school tuition. Such sums shall be appropriated on a per pupil basis. In making this determination,

6 the general assembly shall set a specific dollar amount of aid to be provided for each student. Aid

7 shall be distributed to each vocational school district based upon the number of students in

8 attendance at said schools as of October 1 of each year. By way of guidance, the intent of this

provision is to provide uniform funding of regional vocational schools throughout the state. All

districts which send students to state operated schools which are funded through the operations

aid formula shall not be entitled to receive funds under this section for students attending those

(b) Each year one hundred percent (100%) of the approved regional vocational school

expenditures for the reference year is appropriated. Such sums shall be appropriated on a per

pupil basis. In making this determination, the general assembly shall set a specific dollar amount

16 of aid to be provided for each student. Aid shall be distributed to each vocational school district

based upon the number of students in attendance at said schools as of October 1 of each year. By

way of guidance, the intent of this provision is to provide uniform funding of regional vocational

schools throughout the state. The commissioner of elementary and secondary education shall be

- 1 responsible for approving regional vocational technical school budgets and eligible programs and
- 2 shall promulgate rules and regulations for the approval of budget expenditures and operation of
- 3 the schools. All funds provided by this section will be ineligible for reimbursement under the
- 4 provisions of chapter 7 of this title.
- 5 SECTION 2. This act shall take effect upon passage.
