RELATING TO MOTOR AND OTHER VEHICLES - REGISTRATION OF VEHICLES

Introduced By: Senator Maryellen Goodwin

Date Introduced: February 28, 2013

Referred To: Senate Special Legislation and Veterans Affairs

It is enacted by the General Assembly as follows:

1           SECTION 1. Chapter 31-3 of the General Laws entitled "Registration of Vehicles" is  
2 hereby amended by adding thereto the following section:

3           **31-3-94. Special plate for home and hospice care of Rhode Island.** – (a) [The](#)  
4 [administrator of the division of motor vehicles is empowered to make available special motor](#)  
5 [vehicle registration plates for the not-for-profit entity Home and Hospice Care of Rhode Island.](#)  
6 [The plates shall be designed to reference Home and Hospice Care of Rhode Island.](#)

7           [\(b\) The special plates shall be displayed upon the same registration number assigned to](#)  
8 [the vehicle for which it was issued, and shall be used in place of an in the same manner as the](#)  
9 [registration plates issued to the vehicle. The original registration plates for the vehicle shall be](#)  
10 [removed from the vehicle and returned to the division of motor vehicles. The registration](#)  
11 [certificate for the plates shall be carried in the vehicle, in accordance with section 31-3-9. The](#)  
12 [registration certificate shall be in effect for the special plate.](#)

13           [\(c\) The Home and Hospice Care of Rhode Island motor vehicle plates shall be the same](#)  
14 [size as regular motor vehicle plates, and shall be designed by the Home and Hospice Care of](#)  
15 [Rhode Island in conjunction with the division of motor vehicles, and with final approval from the](#)  
16 [Rhode Island state police.](#)

17           [\(d\) The Home and Hospice Care of Rhode Island plates shall be subject to a minimum](#)  
18 [prepaid order of at least nine hundred \(900\) sets of passenger plates per plate type \(i.e. passenger,](#)  
19 [commercial, etc\). The Home and Hospice Care of Rhode Island plates shall not be issued unless](#)

1 the minimum order(s) requirements are met. The initial order will be handled by the Home and  
2 Hospice Care of Rhode Island, and shall not be submitted to the division of motor vehicles for  
3 production until the minimum order(s) has been met, and the proper paperwork submitted to the  
4 division.

5 (e) The administrator of the division of motor vehicles shall develop prepayment  
6 procedures and any other procedures deemed necessary to carry out the purposes of this section.

7 (f) In addition to the regular prescribed motor vehicle registration fees, the Home and  
8 Hospice Care of Rhode Island plates shall be subject to a forty dollar (\$40.00) issuance surcharge.

9 (g) The forty dollar (\$40.00) issuance surcharge shall be allocated as follows:

10 Twenty dollars (\$20.00) shall be allocated to the general fund, and the remaining twenty  
11 dollars (\$20.00) shall be distributed annually to the Home and Hospice Care of Rhode Island in  
12 furtherance of their mission to provide compassionate and skilled care to those who are seriously  
13 ill in the state of Rhode Island.

14 (h) The Home and Hospice Care of Rhode Island will be required to submit an annual  
15 accounting report before such monies are distributed.

16 (i) In consideration of the receipt of funds from the registration of the Home and Hospice  
17 Care of Rhode Island, the organization must use any Rhode Island sourced funds in and for the  
18 benefit of the state of Rhode Island.

19 (j) There shall be no refunds for early cancellation of the Home and Hospice Care of  
20 Rhode Island plates.

21 SECTION 2. This act shall take effect upon passage.
