SENATE RESOLUTION

EXPRESSING ITS DEEPEST CONDOLENCES ON THE PASSING OF CLIFTON R. LARGESS, JR.

1 WHEREAS, Clifton R. Largess, Jr., was born in Worcester, Massachusetts, the son of the 2 late Clifton R., Sr., and Winifred K. (Warnke) Largess. Clifton received a bachelor's degree in chemistry from the College of the Holy Cross in 1942 and then, like millions of other young men 3 at the time, enlisted in the armed forces to serve in World War II. Clifton enlisted in the United 4 States Navy and, since he already had an aviation license, he was trained to be a combat aviator; 5 6 and 7 WHEREAS, After completing the necessary training, Clifton left Pearl Harbor on 8 Christmas Eve in 1943 to serve in the Pacific Theater. From this day forward, Clifton saw combat 9 action in most parts of the Pacific. He flew off of aircraft carriers in the dead of night and took 10 part in the dangerous bombing of Truk Lagoon, Japan's primary base in the Pacific. Clifton also 11 served our nation during the Korean War, and in both wars he served our nation with honor, valor 12 and courage; and 13 WHEREAS, Clifton completed General Line School in Newport in 1949 and graduated 14 from the Naval War College in 1955. In 1964, he received a master's degree in International 15 Relations from George Washington University. Clifton served in the United States Navy for thirty-one years, retiring in 1973 with the rank of Captain. For his service to our nation, he was 16 awarded five Distinguished Flying Crosses, the Bronze Star, and seven Air Medals; and 17 WHEREAS, After retiring from the Navy, Clifton was the commanding officer of the 18

Navy program at the University of Rochester, where he taught for seven years. He was a member

- 1 of the Jamestown Rotary Club, Fleet Reserve Association, Veterans of Foreign Wars, and the
- 2 American Legion. He was a communicant of St. Mark Church and was a charter member of the
- 3 Knights of Columbus. He was the loving husband for sixty-four years of Mary R. (Curran)
- 4 Largess, a retired Stewardess from American Airlines, whom he met and married in 1945 coming
- 5 home from serving in World War II. Together they had eight children; and
- 6 WHEREAS, Besides his wife, Clifton R. Largess, Jr., leaves behind four sons, Clifton R.
- 7 Largess III, Mark W. Largess, Matthew C. Largess, and Stephen L. Largess, two daughters, Mary
- 8 C. Lee and Catherine M. Woodward; a brother, Donald Largess, a sister, Jean Largess; and eleven
- 9 grandchildren. He was the father of the late John J. and Daniel P. Largess, and the brother of the
- 10 late Kenneth and Robert Largess; now, therefore be it
