1	SECTION 1. Title 39 of the General Laws entitled "PUBLIC UTILITIES AND
2	CARRIERS" is hereby amended by adding thereto the following chapter:

5	39-29-1. Short title This chapter shall be known and may be cited as "The Statewide

7	39-29-2. Legislative findings. – The purpose of this chapter is to establish statewide
8	interconnection standards for small generator facilities in order to facilitate the development of
9	distributed renewable energy in Rhode Island.
10	39-29-3. Definitions. – When used in this chapter, the following terms shall have the
11	following meanings:
12	(1) "Commission" means the Rhode Island public utilities commission;
13	(2) "Electric distribution company" means a company as defined in subsection 39-1-
14	2(12), supplying standard offer service, last resort service, or any successor service to end-use
15	customers, but not including, the Block Island power company or the Pascoag utility district;
16	(3) "Statewide interconnection standards" means the standardized procedures governing
17	the process whereby a small generator facility is connected to an electric power system owned,

Island with a capacity not exceeding forty (40) megawatts.													

39-29-4. Statewide interconnection standards. – The commission shall review and make a determination regarding the establishment of statewide interconnection standards. In making its determination, the commission shall consider relevant federal laws and rules as well as interconnection standards that have been developed by states and other appropriate entities. The commission shall issue a public report by September 15, 2011 containing its findings and making a determination regarding the advisability of establishing statewide interconnection standards. If the commission determines that statewide interconnection standards should be established, the commission shall proceed to develop such standards. In any development of interconnection standards pursuant to this section, the commission may establish different standards for different tiers of facilities based on generating capacity and may develop any necessary interconnection agreements and related forms as appropriate.

SECTION 2. This act shall take effect upon passage.
