2	of Ryan J. Ferris, the loving husband for almost fourteen years to Danielle Ferris, and the
3	cherished father of two young daughters, Mia and Paisley; and
4	WHEREAS, Born in Worcester, Ryan Ferris was the treasured and thoughtful son o
5	Kathleen and William Lafond, and the late Jeffrey Ferris, and the loving brother of Julie Parlec

7	WHEREAS, A longtime resident of Harrisville and a hard-working family man, Mr
8	Ferris was employed in the maintenance division of Wright's Farm Restaurant in the Village of

11	Burrillville Ambulance and Rescue Association. He later served as a dedicated member of the
12	Harrisville Fire Department for seventeen years, and was posthumously promoted to

14	WHEREAS, Mr. Ferris had served as a member of numerous firefighter organizations
15	including, as a delegate to the Northern R.I. Firefighters League, and as President of the
16	Harrisville Hose Co. in 2014, and Vice President in 2015; and
17	WHEREAS, There is no doubt that Ryan Ferris left this world far too soon. He was an
18	extraordinary individual whose personal integrity and dedication enriched the community and the
19	lives of all who knew him; now, therefore be it
