A N A C T

RELATING TO MILITARY AFFAIRS AND DEFENSE - EMERGENCY MANAGEMENT

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 30-15-6 of the General Laws in Chapter 30-15 entitled "Emergency
2 Management" is hereby amended to read as follows:

3 **30-15-6. Advisory council.** -- (a) There is hereby created the Rhode Island emergency
4 management advisory council (hereinafter in this chapter called the "council"). The council will
5 consist of ~~forty (40)~~ forty-one (41) members as follows:

6 (1) Twenty-two (22) ex officio members as follows:

7 (i) The lieutenant governor;

8 (ii) The adjutant general;

9 (iii) The director of administration/statewide planning;

10 (iv) The director of health;

11 (v) The director of transportation;

12 (vi) The director of human services;

13 (vii) The superintendent of state police;

14 (viii) The public utilities administrator;

15 (ix) The director of the department of environmental management;

16 (x) The director of mental health, retardation, and hospitals;

17 (xi) The director of elderly affairs;

18 (xii) The chairperson of the state water resources board;

19 (xiii) The chairperson of the governor's commission on disabilities;

- 1 (xiv) The chairperson of the Rhode Island public transit authority;
- 2 (xv) The executive director of the coastal resources management council or his or her
3 designee;
- 4 (xvi) The executive director of the American Red Cross, Rhode Island chapter;
- 5 (xvii) The executive director of the Rhode Island emergency management agency;
- 6 (xviii) The state court administrator;
- 7 (xix) The executive director of the commission on the deaf and hard of hearing;
- 8 (xx) The director of the Providence emergency management agency;
- 9 (xxi) The executive director of E-911 emergency telephone system division;
- 10 (xxii) The federal security director of the transportation security administration for
11 Rhode Island; and
- 12 (2) ~~Eighteen (18)~~ Nineteen (19) members appointed by and serving at the pleasure of the
13 governor, as follows:
- 14 (i) Two (2) members of the senate, recommended by the president of the senate, not
15 more than one of whom shall be from the same political party;
- 16 (ii) Two (2) members of the house of representatives, recommended by the speaker of
17 the house, not more than one of whom shall be from the same political party;
- 18 (iii) One representative of the electric industry;
- 19 (iv) One representative of the gas industry;
- 20 (v) One representative of the telephone industry;
- 21 (vi) The executive director of the Rhode Island petroleum association or other similarly
22 situated person;
- 23 (vii) Two (2) representatives of the general public, one who shall have expertise in
24 disaster preparedness;
- 25 (viii) One representative of the Rhode Island league of cities and towns;
- 26 (ix) One representative of the media;
- 27 (x) One representative of the water supply industry;
- 28 (xi) One representative of the health care industry;
- 29 (xii) One representative of the Rhode Island firefighters association;
- 30 (xiii) One representative of the Rhode Island association of fire chiefs;
- 31 (xiv) One representative of a private ambulance company; ~~and~~
- 32 (xv) One representative of a level I trauma hospital who shall have direct expertise in
33 disaster preparedness; and
- 34 (xvi) One representative of the Rhode Island Association of Emergency Managers.

1 (b) It shall be the duty of the council to advise the governor and the adjutant general on
2 all matters pertaining to disaster preparedness. The lieutenant governor shall serve as chairperson
3 of the council and the adjutant general shall serve as vice-chairperson. In providing advice to the
4 governor and the adjutant general, the council shall, among other matters reasonably related to
5 their authority, do the following:

6 (1) Establish a regular meeting schedule and form subcommittees as may be appropriate;

7 (2) Review emergency management plans and other matters as may be acted upon or
8 otherwise provided for in this chapter;

9 (3) Establish priorities and goals on emergency management matters on an annual basis;

10 (4) Study emergency management plans in conjunction with the adjutant general, and
11 otherwise conduct such other studies as may be deemed appropriate;

12 (5) Review the coordination of the state's emergency management programs with
13 appropriate authorized agencies and conduct studies on the programs as may be necessary;

14 (6) Review the plans and operations of the various cities and towns in disaster
15 preparedness in conjunction with the director and his or her office as required or necessary; and

16 (7) [Deleted by P.L. 2000, ch. 170, section 2];

17 (8) Provide an annual report on its activities in conjunction with the adjutant general.

18 SECTION 2. This act shall take effect upon passage.
