In addition, 14 she was one of the first organizers of children's games at the Washington County Fair; and 15 WHEREAS, At the state and national levels, Hope is an active member of the Rhode Island State Grange, where she won the Talent Contest and went on to represent Rhode Island at 16 the National Grange Session. She has also served as Chairperson and Co-Chairperson of the 17 Women's Activities committees and has served on several additional committees; and 18

WHEREAS, With Hope's guidance, "thousands of dollars, pounds of food, baby hats,
