It is enacted by the General Assembly as follows:

- 1 SECTION 1. Section 4-1.1-4 of the General Laws in Chapter 4-1.1 entitled "Unlawful
- 2 Confinement of a Covered Animal" is hereby amended to read as follows:
- 3 <u>4-1.1-4. Exceptions. [Effective July 1, 2026.]</u>
- 4 This chapter shall not apply:
- 5 (1) During medical research;
- 6 (2) Temporary confinement prior to and during examination, testing, individual treatment
- 7 or operation for veterinary purposes;
- 8 (3) During transportation;
- 9 (4) During rodeo exhibitions, state or county fair exhibitions, 4-H programs, and similar
- 10 exhibitions or educational programs;
- 11 (5) During temporary confinement for animal husbandry purposes for no more than six (6)
- 12 hours in any twenty-four-hour (24) period, unless ordered by a licensed veterinarian;
- 13 (6) During the humane slaughter of a covered animal in accordance with the provisions of
- 14 chapter 17 of this title, and other applicable laws and regulations;
- 15 (7) To a sow during the five-day (5) period prior to the sow's expected date of giving birth
- 16 and any day that the sow is nursing piglets;
- 17 (8) To calves being trained to exhibit; and
- 18 (9) To calves being trained to accept routine confinement in dairy and beef housing-<u>;</u> and

- 1 (10) Egg laying hens kept for commercial egg production until January 1, 2028, at which
- 2 <u>time this exemption shall expire.</u>
- 3 SECTION 2. This act shall take effect upon passage.
