Iannitti, and the uncle of many 11 nieces, nephews, and one great-great nephew. He grew up and was a life-long resident of 12 Providence's Silver Lake neighborhood and was a graduate of LaSalle Academy; and 13 WHEREAS, Mr. Igliozzi served his country with distinction during the Korean War. 14 Upon discharge, he attended Bryant College to study business. Throughout his distinguished 15 career, Mr. Igliozzi held myriad eminent titles including, being named Director of Administration 16 for the State of Rhode Island State Equal Opportunity Office and Federal Programs Coordinator, 17 Assistant Director of Administration for the State of Rhode Island, and the Deputy Clerk to the 18 Rhode Island House of Representatives; and 19 WHEREAS, In addition, Mr. Igliozzi held numerous professional positions including, 20 serving as President of the International Personnel Management Association, executive board
