It is enacted by the General Assembly as follows:

1	SECTION 1. Chapter 27-18 of the General Laws entitled "Accident and Sickness
2	Insurance Policies" is hereby amended by adding thereto the following section:
3	27-18-71. Mandatory coverage for surgery and services for implantation of Federal
4	Drug Administration (FDA) approved implantable hearing device – (a) Every individual or
5	group hospital or medical services plan or policy delivered, issued for delivery or renewed in this
6	state shall provide coverage for surgery and services for implantation of Federal Drug
7	Administration (FDA) approved implantable hearing device per ear that shall include, but not be
8	limited to:
9	(1) Pre-and post-surgery treatment services;
10	(2) Supplies and accessories necessary for proper operation of the devices; and
11	(3) Upgrades that are required to maintain the device.
12	(b) The following definitions shall apply to the provisions of this section:
13	(1) "Implantable hearing device" includes any implantable instrument or device that is
14	designed to access or restore hearing, including, but not limited to, cochlear implant, Baha device,
15	and any implantable hearing devices.
16	(2) "Pre-and post-surgery treatment services" include diagnosis, evaluation, surgery,
17	mappings, auditory oral rehabilitation treatment and auditory habilitation therapy as medically
18	prescribed.

- 7 <u>implantation of Federal Drug Administration (FDA) approved implantable hearing device per ear</u>
- 8 <u>that shall include, but not be limited to:</u>
- 9 (1) Pre-and post-surgery treatment services;
- 10 (2) Supplies and accessories necessary for proper operation of the devices; and
- 11 (3) Upgrades that are required to maintain device.
- 12 (b) The following definitions shall apply to the provisions of this section:
- 13 (1) "Implantable hearing device" includes any implantable instrument or device that is
