RELATING TO MOTOR AND OTHER VEHICLES -- REGISTRATION OF VEHICLES --  
BOSTON RED SOX/JIMMY FUND LICENSE PLATES

Referred To: Senate Constitutional & Regulatory Issues

It is enacted by the General Assembly as follows:

1 SECTION 1. Chapter 31-3 of the General Laws entitled "Registration of Vehicles" is  
2 hereby amended by adding thereto the following section:

3 **31-3-87. Special plate to conquer cancer.** -- (a) The administrator of the division of  
4 motor vehicles is empowered to make available a special motor vehicle registration plate  
5 honoring the World Champion Boston Red Sox and the Jimmy Fund in their efforts to conquer  
6 cancer. The plate shall bear the official Boston Red Sox logo, as well as the Jimmy Fund logo.  
7 The special plate shall be displayed upon the same registration number assigned to the vehicle for  
8 which it was issued and shall be used in place of and in the same manner as the original  
9 registration plates issued to the vehicle. The original registration plates for the vehicle shall be  
10 removed from the vehicle and the registration certificate for the plates shall be carried in the  
11 vehicle, in accordance with section 31-3-9. The registration certificate shall be in effect for the  
12 special plate.

13 (b) A special automobile or commercial commemorative official Boston Red Sox/Jimmy  
14 Fund plate shall be issued upon application using forms furnished by the administrator upon  
15 payment in addition to the regularly prescribed motor vehicle registration fee, and a service  
16 charge of forty dollars (\$40.00) for each issue. The service charge shall be paid to the  
17 administrator prior to the administrator's acceptance of the application. Twenty dollars (\$20.00)  
18 of the service charge shall be paid to the Jimmy Fund of Dana-Farber Cancer Institute and twenty

1 dollars (\$20.00) shall be allocated to the division of motor vehicles for its costs in manufacturing  
2 and distributing the special plates.

3 (c) Official Boston Red Sox/Jimmy Fund plates shall be subject to a minimum pre-paid  
4 order of at least nine hundred (900) plates. Official Boston Red Sox/Jimmy Fund plates shall not  
5 be issued unless the minimum order requirements are met.

6 SECTION 2. This act shall take effect upon passage.
