RELATING TO TOWNS AND CITIES -- ZONING ORDINANCES -- PROMOTION OF
NEIGHBORHOOD CHARACTER AND SMART GROWTH

It is enacted by the General Assembly as follows:

1 SECTION 1. Sections 45-24-30, 45-24-31, 45-24-33, 45-24-34, 45-24-36, 45-24-37, 45-
2 24-39, 45-24-40, 45-24-42, 45-24-43, 45-24-44, 45-24-46.1, 45-24-46.2, 45-24-46.3, 45-24-46.4,
3 45-24-47, 45-24-48, 45-24-57, 45-24-58 and 45-24-61 of the General Laws in Chapter 45-24
4 entitled "Zoning Ordinances" are hereby amended to read as follows:

5 **45-24-30. General purposes of zoning ordinances.**

6 (a) Zoning regulations shall be developed and maintained in accordance with a
7 comprehensive plan prepared, adopted, and as may be amended, in accordance with chapter 22.2
8 of this title and shall be designed to address the following purposes. The general assembly
9 recognizes these purposes, each with equal priority and numbered for reference purposes only.

10 [\(1\) Respecting the right of housing for every Rhode Islander in any city or town, regardless](#)
11 [of their income.](#)

12 ~~(2)~~ (2) Promoting the public health, safety, and general welfare.

13 ~~(3)~~ (3) Providing for a range of uses and intensities of use appropriate to the character of
14 the city or town and reflecting current and expected future needs.

15 [\(4\) Promoting smart growth: redevelopment of previously developed land and preservation](#)
16 [of undeveloped land.](#)

17 ~~(5)~~ (5) Providing for orderly growth ~~and~~, development, [and redevelopment](#) that recognizes:

18 (i) The goals and patterns of land use contained in the comprehensive plan of the city or

1 town adopted pursuant to chapter 22.2 of this title;

2 (ii) The natural characteristics of the land, including its suitability for use based on soil
3 characteristics, topography, and susceptibility to surface or groundwater pollution;

4 (iii) The values and dynamic nature of coastal and freshwater ponds, the shoreline, and
5 freshwater and coastal wetlands;

6 (iv) The values of unique or valuable natural resources and features;

7 (v) The availability and capacity of existing and planned public and/or private services and
8 facilities, specifically public and civic spaces, transportation, water, storm water management
9 systems, sewage treatment and disposal, solid waste treatment and disposal, schools, recreation,
10 public facilities, open space, and other public requirements;

11 (vi) The need to shape and balance urban and rural development; and

12 (vii) The use of innovative development and redevelopment regulations and techniques.

13 ~~(4)~~(6) Providing for the control, protection, and/or abatement of air, water, groundwater,
14 and noise pollution, and soil erosion and sedimentation.

15 ~~(5)~~(7) Providing for the protection of the natural, historic, cultural, and scenic ~~character~~
16 characteristics of the city or town or areas in the municipality.

17 ~~(6)~~(8) Providing for the preservation and promotion of agricultural production, forest,
18 silviculture, aquaculture, timber resources, public and civic spaces, and open space.

19 ~~(7)~~(9) Providing for the protection of public investment in transportation, public and civic
20 spaces, water, stormwater management systems, sewage treatment and disposal, solid waste
21 treatment and disposal, schools, recreation, public facilities, open space, and other public
22 requirements.

23 ~~(8)~~(10) Promoting a balance of housing choices, for all income levels and groups, to assure
24 the health, safety and welfare of all citizens and their rights to affordable, accessible, safe, and
25 sanitary housing.

26 ~~(9)~~(11) Providing opportunities for the establishment of low- and moderate-income
27 housing.

28 ~~(10)~~(12) Promoting safety from ~~fire~~, flood, and ~~other natural or unnatural disasters~~ wildfire.

29 ~~(11)~~(13) Promoting a high level of quality in design and construction in the development
30 and redevelopment of private and public facilities.

31 ~~(12)~~(14) Promoting implementation of the comprehensive plan of the city or town adopted
32 pursuant to chapter 22.2 of this title.

33 ~~(13)~~(15) Providing for coordination of land uses with contiguous municipalities, other
34 municipalities, the state, and other agencies, as appropriate, especially with regard to resources and

1 facilities that extend beyond municipal boundaries or have a direct impact on that municipality.

2 ~~(14)~~(16) Providing for efficient review of development and redevelopment proposals, to
3 clarify and expedite the zoning approval process.

4 ~~(15)~~(17) Providing for procedures for the administration of the zoning ordinance,
5 including, but not limited to, variances, ~~special-use~~ special permits, and, where adopted, procedures
6 for modifications.

7 ~~(16)~~(18) Providing opportunities for reasonable accommodations in order to comply with
8 the Rhode Island Fair Housing Practices Act, chapter 37 of title 34; the United States Fair Housing
9 Amendments Act of 1988 (FHAA); the Rhode Island Civil Rights of Persons with Disabilities Act,
10 chapter 87 of title 42; and the Americans with Disabilities Act of 1990 (ADA), 42 U.S.C. § 12101
11 et seq.

12 Provided, however, that any zoning ordinance in which a community sets forth standards
13 or requirements for the location, design, construction, or maintenance of on-site wastewater
14 treatment systems shall first be submitted to the director of the department of environmental
15 management for approval as to the technical merits of the ordinance. In addition, any zoning
16 ordinance in which a municipality sets forth standards regarding wetland requirements, shall first
17 be submitted to the director of the department of environmental management for approval as to the
18 technical merits of the ordinance.

19 (b) Upon the effective date of this section, a city or town shall no longer be authorized to
20 adopt as a provision of its zoning ordinance new requirements that specify buffers or setbacks in
21 relation to freshwater wetland, freshwater wetland in the vicinity of the coast, or coastal wetland or
22 that specify setback distances between an onsite wastewater treatment system and a freshwater
23 wetlands, freshwater wetland in the vicinity of the coast, or coastal wetland.

24 (c) Upon promulgation of state regulations to designate wetland buffers and setbacks
25 pursuant to §§ 2-1-18 through 2-1-28, cities and towns shall be prohibited from applying the
26 requirements in existing zoning ordinances pertaining to both wetland buffers and onsite
27 wastewater treatment system setbacks to development applications submitted to a municipality
28 after the effective date of said state regulations. All applications for development that were
29 submitted to a municipality prior to the effective date of state regulations designating wetland
30 buffers and setbacks, will remain subject to, as applicable, the zoning provisions pertaining to
31 wetland buffers or setbacks for onsite wastewater treatment systems that were in effect at the time
32 the application was originally filed or granted approval, subject to the discretion of the municipality
33 to waive such requirements. Nothing herein shall rescind the authority of a city or town to enforce
34 local zoning requirements.

1 (d) Cities and towns shall act to amend their ordinances and regulations to conform to this
2 section within twelve (12) months of the effective date of state regulations referenced herein.

3 **45-24-31. Definitions.**

4 Where words or terms used in this chapter are defined in § 45-22.2-4 or 45-23-32, they
5 have the meanings stated in that section. In addition, the following words have the following
6 meanings. Additional words and phrases may be used in developing local ordinances under this
7 chapter; however, the words and phrases defined in this section are controlling in all local
8 ordinances created under this chapter:

9 (1) Abutter. One whose property abuts, that is, adjoins at a border, boundary, or point with
10 no intervening land.

11 (2) Accessory dwelling unit. A dwelling unit: (i) Rented to and occupied either by one or
12 more members of the family of the occupant or occupants of the principal residence; or (ii)
13 Reserved for rental occupancy by a person or a family where the principal residence is owner
14 occupied and that meets the following provisions:

15 (A) In zoning districts that allow residential uses, no more than one accessory dwelling unit
16 may be an accessory to a single-family dwelling.

17 (B) An accessory dwelling unit shall include separate cooking and sanitary facilities, with
18 its own legal means of ingress and egress, and is a complete, separate dwelling unit. The accessory
19 dwelling unit shall be within, or attached to, the principal dwelling-unit structure or within an
20 existing structure, such as a garage or barn, and designed so that the appearance of the principal
21 structure remains that of a one-family residence.

22 (3) Accessory use. A use of land or of a building, or portion thereof, customarily incidental
23 and subordinate to the principal use of the land or building. An accessory use may be restricted to
24 the same lot as the principal use. An accessory use shall not be permitted without the principal use
25 to which it is related.

26 (4) Aggrieved party. An aggrieved party, for purposes of this chapter, shall be:

27 (i) Any person, or persons, or entity, or entities, who or that can demonstrate that his, her,
28 or its property will be injured by a decision of any officer or agency responsible for administering
29 the zoning ordinance of a city or town; or

30 (ii) Anyone requiring notice pursuant to this chapter.

31 (5) Agricultural land. "Agricultural land," as defined in § 45-22.2-4.

32 (6) Airport hazard area. "Airport hazard area," as defined in § 1-3-2.

33 (7) Applicant. An owner, or authorized agent of the owner, submitting an application or
34 appealing an action of any official, board, or agency.

1 (8) Application. The completed form, or forms, and all accompanying documents, exhibits,
2 and fees required of an applicant by an approving authority for development review, approval, or
3 permitting purposes.

4 (9) Architectural form. The shape or configuration of a building. Form and its opposite,
5 space, constitute primary elements of architecture. The form of a group of buildings, such as part
6 of a street wall, may include several buildings on separate lots owned by separate owners.

7 (10) Architectural wall. The vertical plane created by a series of architectural forms. See
8 also "street wall."

9 ~~(9)~~(11) Buffer. Land that is maintained in either a natural or landscaped state, and is used
10 to screen or mitigate the impacts of development on surrounding areas, properties, or rights-of-
11 way.

12 ~~(10)~~(12) Building. Any structure used or intended for supporting or sheltering any use or
13 occupancy.

14 ~~(11)~~(13) Building envelope. The three-dimensional space within which a structure is
15 permitted to be built on a lot and that is defined by regulations governing building setbacks,
16 maximum height, and bulk; by other regulations; or by any combination thereof.

17 ~~(12)~~(14) Building height. For a vacant parcel of land, building height shall be measured
18 from the average, existing-grade elevation where the foundation of the structure is proposed. For
19 an existing structure, building height shall be measured from average grade taken from the
20 outermost four (4) corners of the existing foundation. In all cases, building height shall be measured
21 to the top of the highest point of the existing or proposed roof or structure. This distance shall
22 exclude spires, chimneys, flag poles, and the like. For any property or structure located in a special
23 flood hazard area, as shown on the official FEMA Flood Insurance Rate Maps (FIRMs), or depicted
24 on the Rhode Island coastal resources management council (CRMC) suggested design elevation
25 three foot (3') sea level rise (CRMC SDE 3 SLR) map as being inundated during a one-hundred-
26 year (100) storm, the greater of the following amounts, expressed in feet, shall be excluded from
27 the building height calculation:

28 (i) The base flood elevation on the FEMA FIRM plus up to five feet (5') of any utilized or
29 proposed freeboard, less the average existing grade elevation; or

30 (ii) The suggested design elevation as depicted on the CRMC SDE 3 SLR map during a
31 one-hundred-year (100) storm, less the average existing grade elevation. CRMC shall reevaluate
32 the appropriate suggested design elevation map for the exclusion every ten (10) years, or as
33 otherwise necessary.

34 (15) Civic space. See "public and civic space".

1 ~~(13)~~(16) Cluster. A site-planning technique that concentrates buildings in specific areas
2 on the site to allow the remaining land to be used for public and civic space, recreation, common
3 open space, and/or preservation of environmentally, historically, culturally, or other sensitive
4 features and/or structures. The techniques used to concentrate buildings shall be specified in the
5 ordinance and may include, but are not limited to, reduction in lot areas, setback requirements,
6 and/or bulk requirements, with the resultant open land being devoted by deed restrictions for one
7 or more uses. Under cluster development, there is no increase in the number of lots that would be
8 permitted under conventional development except where ordinance provisions include incentive
9 bonuses for certain types or conditions of development.

10 ~~(14)~~(17) Common ownership. Either:

11 (i) Ownership by one or more individuals or entities in any form of ownership of two (2)
12 or more contiguous lots; or

13 (ii) Ownership by any association (ownership may also include a municipality) of one or
14 more lots under specific development techniques.

15 ~~(15)~~(18) Community residence. A home or residential facility where children and/or adults
16 reside in a family setting and may or may not receive supervised care. This does not include halfway
17 houses or substance-use-disorder-treatment facilities. This does include, but is not limited to, the
18 following:

19 (i) Whenever six (6) or fewer children or adults with intellectual and/or developmental
20 disability reside in any type of residence in the community, as licensed by the state pursuant to
21 chapter 24 of title 40.1. All requirements pertaining to local zoning are waived for these community
22 residences;

23 (ii) A group home providing care or supervision, or both, to not more than eight (8) persons
24 with disabilities, and licensed by the state pursuant to chapter 24 of title 40.1;

25 (iii) A residence for children providing care or supervision, or both, to not more than eight
26 (8) children, including those of the caregiver, and licensed by the state pursuant to chapter 72.1 of
27 title 42;

28 (iv) A community transitional residence providing care or assistance, or both, to no more
29 than six (6) unrelated persons or no more than three (3) families, not to exceed a total of eight (8)
30 persons, requiring temporary financial assistance, and/or to persons who are victims of crimes,
31 abuse, or neglect, and who are expected to reside in that residence not less than sixty (60) days nor
32 more than two (2) years. Residents will have access to, and use of, all common areas, including
33 eating areas and living rooms, and will receive appropriate social services for the purpose of
34 fostering independence, self-sufficiency, and eventual transition to a permanent living situation.

1 ~~(16)~~[\(19\)](#) Comprehensive plan. The comprehensive plan adopted and approved pursuant to
2 chapter 22.2 of this title and to which any zoning adopted pursuant to this chapter shall be in
3 compliance.

4 ~~(17)~~[\(20\)](#) Day care -- Day-care center. Any other day-care center that is not a family day-
5 care home.

6 ~~(18)~~[\(21\)](#) Day care -- Family day-care home. Any home, other than the individual's home,
7 in which day care in lieu of parental care or supervision is offered at the same time to six (6) or less
8 individuals who are not relatives of the caregiver, but may not contain more than a total of eight
9 (8) individuals receiving day care.

10 ~~(19)~~[\(22\)](#) Density, residential. The number of dwelling units per unit of land.

11 ~~(20)~~[\(23\)](#) Development. The construction, reconstruction, conversion, [facade redesign](#),
12 structural alteration, relocation, or enlargement of any structure; any mining, excavation, landfill,
13 or land disturbance; or any change in use, or alteration or extension of the use, of land.

14 ~~(21)~~[\(24\)](#) Development plan review. The process whereby authorized, local officials review
15 the site plans, maps, and other documentation of a development to determine the compliance with
16 the stated purposes and standards of the ordinance.

17 ~~(22)~~[\(25\)](#) District. See "zoning-use [and form](#) district."

18 ~~(23)~~[\(26\)](#) Drainage system. A system for the removal of water from land by drains, grading,
19 or other appropriate means. These techniques may include runoff controls to minimize erosion and
20 sedimentation during and after construction or development; the means for preserving surface and
21 groundwaters; and the prevention and/or alleviation of flooding.

22 ~~(24)~~[\(27\)](#) Dwelling unit. A structure, or portion of a structure, providing complete,
23 independent living facilities for one or more persons, including permanent provisions for living,
24 sleeping, eating, cooking, and sanitation, and containing a separate means of ingress and egress.

25 ~~(25)~~[\(28\)](#) Extractive industry. The extraction of minerals, including: solids, such as coal and
26 ores; liquids, such as crude petroleum; and gases, such as natural gases. The term also includes
27 quarrying; well operation; milling, such as crushing, screening, washing, and flotation; and other
28 preparation customarily done at the extraction site or as a part of the extractive activity.

29 ~~(26)~~[\(29\)](#) Family member. A person, or persons, related by blood, marriage, or other legal
30 means, including, but not limited to, a child, parent, spouse, mother-in-law, father-in-law,
31 grandparents, grandchildren, domestic partner, sibling, care recipient, or member of the household.

32 ~~(27)~~[\(30\)](#) Floating zone. An unmapped zoning district adopted within the ordinance that is
33 established on the zoning map only when an application for development, meeting the zone
34 requirements, is approved.

1 ~~(28)~~(31) Floodplains, or Flood hazard area. As defined in § 45-22.2-4.

2 [\(32\) Form. See "architectural form."](#)

3 ~~(29)~~(33) Freeboard. A factor of safety expressed in feet above the base flood elevation of

4 a flood hazard area for purposes of floodplain management. Freeboard compensates for the many

5 unknown factors that could contribute to flood heights, such as wave action, bridge openings, and

6 the hydrological effect of urbanization of the watershed.

7 ~~(30)~~(34) Groundwater. "Groundwater" and associated terms, as defined in § 46-13.1-3.

8 ~~(31)~~(35) Halfway house. A residential facility for adults or children who have been

9 institutionalized for criminal conduct and who require a group setting to facilitate the transition to

10 a functional member of society.

11 ~~(32)~~(36) Hardship. See § 45-24-41.

12 ~~(33)~~(37) Historic district or historic site. As defined in § 45-22.2-4.

13 ~~(34)~~(38) Home occupation. Any activity customarily carried out for gain by a resident,

14 conducted as an accessory use in the resident's dwelling unit.

15 ~~(35)~~(39) Household. One or more persons living together in a single-dwelling unit, with

16 common access to, and common use of, all living and eating areas and all areas and facilities for

17 the preparation and storage of food within the dwelling unit. The term "household unit" is

18 synonymous with the term "dwelling unit" for determining the number of units allowed within any

19 structure on any lot in a zoning district. An individual household shall consist of any one of the

20 following:

21 (i) A family, which may also include servants and employees living with the family; or

22 (ii) A person or group of unrelated persons living together. The maximum number may be

23 set by local ordinance, but this maximum shall not be less than three (3).

24 ~~(36)~~(40) Incentive zoning. The process whereby the local authority may grant additional

25 development capacity in exchange for the developer's provision of a public benefit or amenity as

26 specified in local ordinances.

27 ~~(37)~~(41) Infrastructure. Facilities and services needed to sustain residential, commercial,

28 industrial, institutional, and other activities.

29 ~~(38)~~(42) Land-development project. A project in which one or more lots, tracts, or parcels

30 of land are developed or redeveloped as a coordinated site for one or more uses, units, or structures,

31 including, but not limited to, planned development or cluster development for residential,

32 commercial, institutional, recreational, open space, or mixed uses as provided in the zoning

33 ordinance.

34 ~~(39)~~(43) Lot. Either:

1 (i) The basic development unit for determination of lot area, depth, and other dimensional
2 regulations; or

3 (ii) A parcel of land whose boundaries have been established by some legal instrument,
4 such as a recorded deed or recorded map, and that is recognized as a separate legal entity for
5 purposes of transfer of title.

6 ~~(40)~~(44) Lot area. The total area within the boundaries of a lot, excluding any street right-
7 of-way, usually reported in acres or square feet.

8 ~~(41)~~(45) Lot area, minimum. The smallest land area established by the local zoning
9 ordinance upon which a use, building, or structure may be located in a particular zoning district.

10 ~~(42)~~(46) Lot building coverage. That portion of the lot that is, or may be, covered by
11 buildings and accessory buildings.

12 ~~(43)~~(47) Lot depth. The distance measured from the front lot line to the rear lot line. For
13 lots where the front and rear lot lines are not parallel, the lot depth is an average of the depth.

14 ~~(44)~~(48) Lot frontage. That portion of a lot abutting a street. A zoning ordinance shall
15 specify how noncontiguous frontage will be considered with regard to minimum frontage
16 requirements.

17 ~~(45)~~(49) Lot line. A line of record, bounding a lot, that divides one lot from another lot or
18 from a public or private street or any other public or private space and shall include:

19 (i) Front: the lot line separating a lot from a street right-of-way. A zoning ordinance shall
20 specify the method to be used to determine the front lot line on lots fronting on more than one
21 street, for example, corner and through lots;

22 (ii) Rear: the lot line opposite and most distant from the front lot line, or in the case of
23 triangular or otherwise irregularly shaped lots, an assumed line at least ten feet (10') in length
24 entirely within the lot, parallel to and at a maximum distance from, the front lot line; and

25 (iii) Side: any lot line other than a front or rear lot line. On a corner lot, a side lot line may
26 be a street lot line, depending on requirements of the local zoning ordinance.

27 ~~(46)~~(50) Lot size, minimum. Shall have the same meaning as "minimum lot area" defined
28 herein.

29 ~~(47)~~(51) Lot, through. A lot that fronts upon two (2) parallel streets, or that fronts upon two
30 (2) streets that do not intersect at the boundaries of the lot.

31 ~~(48)~~(52) Lot width. The horizontal distance between the side lines of a lot measured at right
32 angles to its depth along a straight line parallel to the front lot line at the minimum front setback
33 line.

34 ~~(49)~~(53) Mere inconvenience. See § 45-24-41.

1 ~~(50)~~(54) Mixed use. A mixture of land uses within a single development, building, or tract.
2 Also referred to as traditional development. Typically ground floor commercial with residential
3 above.

4 ~~(51)~~(55) Modification. Permission granted and administered by the zoning enforcement
5 officer of the city or town, and pursuant to the provisions of this chapter to grant a dimensional
6 variance other than lot area requirements from the zoning ordinance to a limited degree as
7 determined by the zoning ordinance of the city or town, but not to exceed twenty-five percent (25%)
8 of each of the applicable dimensional requirements.

9 ~~(52)~~(56) Nonconformance. A building, structure, or parcel of land, or use thereof, lawfully
10 existing at the time of the adoption or amendment of a zoning ordinance or in existence for at least
11 six (6) years and not in conformity with the provisions of that ordinance or amendment.
12 Nonconformance is of only two (2) types:

13 (i) Nonconforming by use: a lawfully established use of land, building, or structure that is
14 not a permitted use in that zoning district. A building or structure containing more dwelling units
15 than are permitted by the use regulations of a zoning ordinance is ~~nonconformity~~ nonconforming
16 by use. ~~Nonconformance by use shall be established if a use was lawfully existing prior to the~~
17 enactment of the zoning ordinance or amendment that rendered the use out of conformity, if a use
18 has been in existence for fifty (50) years, or if a non-accessory use has been in existence for twenty-
19 five (25) years without the initiation of any enforcement actions to ensure conformity with the
20 zoning ordinance. In the case where the nonconformance by use exists because the number of
21 dwelling units exceeds the limits established by the use regulations of a zoning ordinance, the
22 nonconformance shall be established if the dwelling units were lawfully existing prior to the
23 enactment of a zoning ordinance or a zoning amendment that rendered the use out of conformity;
24 if the dwelling units were in existence prior to January 1, 2016; if the dwelling units have been in
25 existence for twenty-five (25) years; or if the dwelling units have been in existence for six (6) years
26 without the initiation of any enforcement actions to ensure conformity with the zoning ordinance.
27 In the case where the use is a zoning use that raises pollution risk, nonconformance by use shall
28 only be established if the zoning use that raises pollution risk was lawfully existing for at least six
29 (6) years prior to the enactment of the zoning ordinance or amendment that rendered the zoning use
30 that raises pollution risk out of conformity.

31 (ii) Nonconforming by dimension: a building, structure, or parcel of land not in compliance
32 with the dimensional regulations of the zoning ordinance. Dimensional regulations include all
33 regulations of the zoning ordinance, other than those pertaining to the permitted uses. A building
34 or structure containing more dwelling units than are permitted by the use regulations of a zoning

1 ordinance is nonconforming by use; a building or structure containing a permitted number of
2 dwelling units by the use regulations of the zoning ordinance, but not meeting the lot area per
3 dwelling unit regulations, is nonconforming by dimension. Nonconformance by dimension shall be
4 established if the dimensional conditions were lawfully existing prior to the enactment of the zoning
5 ordinance or amendment that rendered the building, structure, or parcel of land out of conformity;
6 if the dimensional conditions were in existence prior to January 1, 2015; if the dimensional
7 conditions have been in existence for twenty-five (25) years; or if the dimensional conditions have
8 been in existence for six (6) years without the initiation of any enforcement actions to ensure
9 conformity with the zoning ordinance.

10 ~~(53)~~(57) Overlay district. A district established in a zoning ordinance that is superimposed
11 on one or more districts or parts of districts. The standards and requirements associated with an
12 overlay district may be more or less restrictive than those in the underlying districts consistent with
13 other applicable state and federal laws.

14 ~~(54)~~(58) Performance standards. A set of criteria or limits relating to elements that a
15 particular use or process must either meet or may not exceed.

21 ~~(57)~~(61) Plant agriculture. The growing of plants for food or fiber, to sell or consume.

22 ~~(58)~~(62) Preapplication conference. A review meeting of a proposed development held
23 between applicants and reviewing agencies as permitted by law and municipal ordinance, before
24 formal submission of an application for a permit or for development approval.

25 (63) Public and civic space. An extension of the community, serving as a stage for our
26 public lives. The space enriches the lives of its users and enhances its surrounding buildings and
27 neighborhood. Public and civic space includes atria, boardwalks, courtyards, forecourts, overlooks,
28 plazas, paths, and squares.

29 (64) Reconstruction. The act or process of depicting, by means of new construction, the
30 form features, and detailing of a non-surviving site, landscape, building, structure, or object for the
31 purpose of replicating its appearance at a specific period of time and in its historic location.

32 (65) Redevelopment. Alteration to previously developed land, structures, or buildings
33 which may include adaptive reuse, reconstruction, conversion, facade redesign, structural
34 alteration, relocation, or enlargement of any structure or building.

1 (66) Rural. Sparsely populated and lacking in public services. Primarily open space and
2 agriculture with interstitial development.

3 ~~(59)~~(67) Setback line or lines. A line, or lines, parallel to a lot line at the minimum distance
4 of the required setback for the zoning district in which the lot is located that establishes the area
5 within which the principal structure must be erected or placed.

6 ~~(60)~~(68) Site plan. The development plan for one or more lots on which is shown the
7 existing and/or the proposed conditions of the lot.

8 ~~(61)~~(69) Slope of land. The grade, pitch, rise, or incline of the topographic landform or
9 surface of the ground.

10 ~~(62)~~(70) Special ~~use~~ permit. A regulated use or dimension that is permitted pursuant to the
11 ~~special-use~~ special permit issued by the authorized governmental entity, pursuant to § 45-24-42.
12 Formerly referred to as a special use permit or modification, or special exception. There are only
13 two (2) categories of special permit, a special use permit or a special dimensional permit.

14 (i) Special use permit. A regulated use that is permitted pursuant to the special use permit
15 issued by the authorized governmental entity, pursuant to § 45-24-42. Special use permits are
16 typically utilized for uses that may have an outsize impact on the surrounding area, such as schools
17 or drive-through windows.

18 (ii) Special dimensional permit. A regulated dimension that is permitted pursuant to the
19 special dimensional permit issued by the authorized governmental entity, pursuant to § 45-24-42.
20 Special dimensional permits allow the involvement of the public and the discretion of the
21 authorized governmental entity in allowing small deviations from a zoning ordinance.

22 (71) Street wall. The architectural wall on either side of a street. A street wall requires
23 relatively consistent setbacks, building heights, building envelopes, and landscaping to function.

24 ~~(63)~~(72) Structure. A combination of materials to form a construction for use, occupancy,
25 or ornamentation, whether installed on, above, or below the surface of land or water.

26 ~~(64)~~(73) Substandard lot of record. Any lot lawfully existing at the time of adoption or
27 amendment of a zoning ordinance and not in conformance with the dimensional or area provisions
28 of that ordinance.

29 (74) Urban. Densely populated with defined and balanced public and private realms,
30 primarily with public and civic spaces, people-centric design, continuous, coherent, and
31 harmonious architectural wall, extensive public services, including transportation, water,
32 stormwater management systems, sewage treatment and disposal, solid waste treatment and
33 disposal, schools, recreation, public facilities, interstitial open space and agriculture, and other
34 public requirements, Generally defined by the division of planning as village centers and areas

1 [within the urban services boundary, on a map maintained by the division of planning.](#)

2 ~~(65)~~[\(75\)](#) Use. The purpose or activity for which land or buildings are designed, arranged,
3 or intended, or for which land or buildings are occupied or maintained.

4 ~~(66)~~[\(76\)](#) Variance. Permission to depart from the literal requirements of a zoning
5 ordinance. An authorization for the construction or maintenance of a building or structure, or for
6 the establishment or maintenance of a use of land, that is prohibited by a zoning ordinance. There
7 are only two (2) categories of variance, a use variance or a dimensional variance.

8 (i) Use variance. Permission to depart from the use requirements of a zoning ordinance
9 where the applicant for the requested variance has shown by evidence upon the record that the
10 subject land or structure cannot yield any beneficial use if it is to conform to the provisions of the
11 zoning ordinance.

12 (ii) Dimensional variance. Permission to depart from the dimensional requirements of a
13 zoning ordinance, where the applicant for the requested relief has shown, by evidence upon the
14 record, that there is no other reasonable alternative way to enjoy a legally permitted beneficial use
15 of the subject property unless granted the requested relief from the dimensional regulations.
16 However, the fact that a use may be more profitable or that a structure may be more valuable after
17 the relief is granted are not grounds for relief.

21 ~~(70)~~[\(80\)](#) Zoning certificate. A document signed by the zoning-enforcement officer, as
22 required in the zoning ordinance, that acknowledges that a use, structure, building, or lot either
23 complies with, or is legally nonconforming to, the provisions of the municipal zoning ordinance or
24 is an authorized variance or modification therefrom.

25 ~~(71)~~[\(81\)](#) Zoning map. The map, or maps, that are a part of the zoning ordinance and that
26 delineate the boundaries of all mapped zoning districts within the physical boundary of the city or
27 town.

28 ~~(72)~~[\(82\)](#) Zoning ordinance. An ordinance enacted by the legislative body of the city or
29 town pursuant to this chapter and in the manner providing for the adoption of ordinances in the city
30 or town's legislative or home rule charter, if any, that establish regulations and standards relating
31 to the nature and extent of uses of land and structures; that is consistent with the comprehensive
32 plan of the city or town as defined in chapter 22.2 of this title; that includes a zoning map; and that

7 circulator systems;
- 8 (vii) Landscaping, fencing, and lighting;
- 9 (viii) Appropriate drainage requirements and methods to manage stormwater runoff;
- 10 (ix) Public access to waterbodies, rivers, and streams; and
- 11 (x) Other requirements in connection with any use of land or structure;
- 12 (5) Permitting, prohibiting, limiting, and restricting development [and redevelopment](#) in
13 flood plains or flood hazard areas and designated significant natural areas;
- 14 (6) Promoting the conservation of energy and promoting energy-efficient patterns of
15 development [and redevelopment](#);
- 16 (7) Providing for the protection of existing and planned public drinking water supplies,
17 their tributaries and watersheds, and the protection of Narragansett Bay, its tributaries and

- 19 (8) Providing for adequate, safe, and efficient transportation systems; and avoiding
20 congestion by relating types and levels of development [and redevelopment](#) to the capacity of the

- 18 (22) Reducing unnecessary delay in approving or disapproving development applications
19 through provisions for preapplication conferences and other means.;
- 20 (23) Providing for the application of the Rhode Island Fair Housing Practices Act, chapter
21 37 of title 34, the United States Fair Housing Amendments Act of 1988 (FHAA); the Rhode Island
22 Civil Rights People with Disabilities Act, chapter 37 of title 42; and the Americans with Disabilities
23 Act of 1990 (ADA), 42 U.S.C. § 12101 et seq.; [and](#)
- 24 (24) Regulating drive-through windows of varied intensity of use when associated with
25 land-use activities and providing standards and requirements for the regulation, review, and
26 approval of the drive-through windows, including, but not limited to:

28 prohibited, or permitted by ~~special-use~~ [special](#) permit;

30 in an owner-occupied, single-family residence shall be permitted as a reasonable accommodation
31 for family members with disabilities or who are sixty-two (62) years of age or older, or to
32 accommodate other family members. The appearance of the structure shall remain that of a single-
33 family residence and there shall be an internal means of egress between the principal unit and the
34 accessory family dwelling unit. If possible, no additional exterior entrances should be added. Where

1 additional entrance is required, placement should generally be in the rear or side of the structure.
2 When the structure is serviced by an individual sewage disposal system, the applicant shall have
3 the existing or any new system approved by the department of environmental management. The
4 zoning enforcement officer shall require that a declaration of the accessory family dwelling unit for
5 the family member, or members, and its restrictions be recorded in the land evidence records and
6 filed with the zoning enforcement officer and the building official. Once the family members with
7 disabilities or who are sixty-two (62) years of age or older, or any other family member, no longer
8 reside(s) in the premises on a permanent basis, or the title is transferred, the property owner shall
9 notify the zoning official in writing, and the accessory family dwelling unit shall no longer be
10 permitted, unless there is a subsequent, valid application.

11 (f) When used in this section the terms "people with disabilities" or "member, or members,
12 with disabilities" means a person(s) who has a physical or mental impairment that substantially
13 limits one or more major life activities, as defined in § 42-87-1(7).

14 (g) Notwithstanding any other provisions of this chapter, plant agriculture is a permitted
15 use within all zoning districts of a municipality, including all industrial and commercial zoning
16 districts, except where prohibited for public health or safety reasons or the protection of wildlife
17 habitat.

18 **45-24-39. General provisions -- Nonconforming development.**

19 (a) Any city or town adopting or amending a zoning ordinance under this chapter shall
20 make provision for any use, activity, structure, building, or sign or other improvement, ~~lawfully~~
21 ~~existing at the time of the adoption or amendment of the zoning ordinance, but~~ which is lawfully
22 established as nonconforming by use or nonconforming by dimension. The zoning ordinance may
23 regulate development which is nonconforming by dimension differently than that which is

10 nonconforming use is presumed to have abandoned the nonconforming use, unless that presumption
11 is rebutted by the presentation of sufficient evidence of intent not to abandon the use. An
12 involuntary interruption of nonconforming use, as by fire and natural catastrophe, does not establish
13 the intent to abandon the nonconforming use. A use that is nonconforming by use because the
14 building or structure contains more dwelling units than are permitted by the use regulations of a
15 zoning ordinance shall never be considered abandoned, unless the zoning use and form district does
16 not permit any residential use.

20 abandonment of nonconformance by dimension shall not be construed to imply non-abandonment

29 sent by first-class mail to the applicant, and to all those who would require notice under § 45-24-
30 53. The notice shall also include the street address of the subject property. A zoning ordinance may
31 require that a supplemental notice, that an application for a ~~special-use~~ special permit is under
32 consideration, be posted at the location in question. The posting is for information purposes only
33 and does not constitute required notice of a public hearing. The cost of notification shall be borne
34 by the applicant;

1 (5) Provide for the recording of findings of fact and written decisions; and

2 (6) Provide that appeals may be taken pursuant to §§ 45-24-70 or 45-23-66, dependent on
3 the board to which application was made.

4 (c) The ordinance additionally ~~may~~ shall provide that an applicant may apply for, and be
5 issued, a ~~dimensional~~ variance in conjunction with a ~~special-use~~ special permit. If the ~~special-use~~
6 special permit could not exist without the ~~dimensional~~ variance, the zoning board of review, or,
7 where unified development review is enabled pursuant to § 45-24-46.4(b), the planning board or
8 commission shall consider the ~~special-use~~ special permit and the ~~dimensional~~ variance together to
9 determine if granting the special ~~use~~ permit is appropriate based on both the special ~~use~~ permit
10 criteria and the ~~dimensional~~ variance evidentiary standards.

11 **45-24-43. General provisions -- Special conditions.**

12 In granting a variance or in making any determination upon which it is required to pass
13 after a public hearing under a zoning ordinance, the zoning board of review or other zoning
14 enforcement agency may apply the special conditions that may, in the opinion of the board or
15 agency, be required to promote the intent and purposes of the comprehensive plan and the zoning
16 ordinance of the city or town. Failure to abide by any special conditions attached to a grant
17 constitutes a zoning violation. Those special conditions shall be based on competent credible
18 evidence on the record, be incorporated into the decision, and may include, but are not limited to,
19 provisions for:

20 (1) Minimizing the adverse impact of the development or redevelopment upon other land,
21 including the type, intensity, design, and performance of activities;

22 (2) Controlling the sequence of development or redevelopment, including when it must be
23 commenced and completed;

24 (3) Controlling the duration of use or development and the time within which any
25 temporary structure must be removed;

26 (4) Assuring satisfactory installation and maintenance of required public improvements;

27 (5) Designating the exact location and nature of development or redevelopment; and

28 (6) Establishing detailed records by submission of drawings, maps, plats, or specifications.

29 **45-24-44. General provisions -- Creation of vested rights.**

30 (a) A zoning ordinance provides protection for the consideration of applications for
31 development or redevelopment that are substantially complete and have been submitted for
32 approval to the appropriate review agency in the city or town prior to enactment of the new zoning
33 ordinance or amendment.

34 (b) Zoning ordinances or other land development ordinances or regulations specify the

1 minimum requirements for a development application to be substantially complete for the purposes
2 of this section.

3 (c) Any application considered by a city or town under the protection of this section shall
4 be reviewed according to the regulations applicable in the zoning ordinance in force at the time the
5 application was submitted.

6 (d) If an application for development [or redevelopment](#) under the provisions of this section
7 is approved, reasonable time limits shall be set within which development [or redevelopment](#) of the
8 property must begin and within which development [or redevelopment](#) must be substantially
9 completed.

10 **45-24-46.1. Inclusionary zoning.**

11 (a) A zoning ordinance requiring the inclusion of affordable housing as part of a
12 development [or redevelopment](#) shall provide that the housing will be affordable housing, as defined
13 in § 42-128-8.1(d)(1); that the affordable housing will constitute not less than ten percent (10%) of
14 the total units in the development [or redevelopment](#); and that the units will remain affordable for a
15 period of not less than thirty-years (30) from initial occupancy enforced through a land lease and/or
16 deed restriction enforceable by the municipality and the state of Rhode Island.

17 (b) A zoning ordinance that includes inclusionary zoning may provide that the affordable
18 housing must be built on-site or utilize one or more alternative methods of production, including,
19 but not limited to, off-site construction or rehabilitation, donation of land suitable for development
20 of the required affordable units, and/or the payment of a fee in lieu of the construction or provision
21 of affordable housing units. For all projects subject to inclusionary zoning, density bonuses and
22 other incentives shall be established by the community and shall apply to offset differential costs
23 of below-market units.

24 (c) This fee in lieu of the construction or provision of affordable housing shall be the choice
25 of the developer or builder applied on a per-unit basis and may be used for new developments,
26 purchasing property and/or homes, rehabilitating properties, or any other manner that creates
27 additional low-or-moderate income housing as defined in § 45-53-3(9).

28 (1) For affordable single-family homes and condominium units, the per-unit fee shall be
29 the difference between the maximum affordable sales price for a family of four (4) earning eighty
30 percent (80%) of the area median income as determined annually by the U.S. Department of
31 Housing and Urban Development and the average cost of developing a single unit of affordable
32 housing. The average cost of developing a single unit of affordable housing shall be determined
33 annually based on the average, per-unit development cost of affordable homes financed by Rhode
34 Island housing over the previous three (3) years, excluding existing units that received preservation

1 financing.

2 (2) Notwithstanding subsection (c)(1) of this section, in no case shall the per-unit fee for
3 affordable single family homes and condominium units be less than forty thousand dollars
4 (\$40,000).

5 (d) The municipality shall deposit all in-lieu payments into restricted accounts that shall be
6 allocated and spent only for the creation and development of affordable housing within the
7 municipality serving individuals or families at or below eighty percent (80%) of the area median
8 income. The municipality shall maintain a local affordable housing board to oversee the funds in
9 the restricted accounts and shall allocate the funds within two (2) years. The municipality shall
10 include in the housing element of their local comprehensive plan, if applicable, the process it will
11 use to allocate the funds.

12 (e) As an alternative to the provisions of subsection (d), the municipality may elect to
13 transfer in-lieu payments promptly upon receipt or within the two-year (2) period after receipt to
14 the housing resources commission or Rhode Island housing for the purpose of developing
15 affordable housing within that community.

16 (f) Rhode Island housing shall report to the general assembly and the housing resources
17 commission the amount of fees in lieu collected by community; the projects that were provided
18 funding with the fees, the dollar amounts allocated to the projects and the number of units created.

19 **45-24-46.2. Special provisions -- Transfer of development rights -- North Kingstown.**

20 (a) In addition to other powers granted to towns and cities by this chapter to establish and
21 administer transfer of development rights programs, the town council of the town of North
22 Kingstown may provide by ordinance for the transfer of development rights, as a voluntary program
23 available to developers and property owners, in the manner set forth in this section.

24 (b) The establishment, as provided for by this section, of a system for transfer of
25 development rights within or between zoning districts, or a portion thereof, designated in the zoning
26 ordinance shall be:

27 (1) For the purpose of providing developers and property owners the ability to establish,
28 certify, purchase, sell, convey, and/or hold land development rights; and

29 (2) For one or more of the following purposes:

30 (i) Preserving sensitive resource areas in the community such as groundwater reserves,
31 wildlife habitat, agricultural lands, and public access to surface waters;

32 (ii) Directing development away from sensitive resource areas to places better suited to
33 increased levels of development [and redevelopment](#) such as established or proposed mixed use,
34 commercial, village, or residential centers;

1 (iii) Directing development to areas served by existing infrastructure such as established
2 roadways, public water supply systems, centralized sewer collection systems, public transit and
3 other utilities; or

4 (iv) Shaping and balancing urban and rural development; and/or promoting a high level of
5 quality in design in the development [and redevelopment](#) of private and public facilities and spaces.

6 (c) For purposes of this section the following terms shall have the following meaning:

7 (1) "Receiving area district" means a zoning district, which is established and mapped
8 pursuant to a transfer of development rights ordinance and superimposed on one or more zoning
9 use [and form](#) districts or portions thereof that is eligible to receive development rights through a
10 major land development project review. As may be necessary or desirable to achieve the intended
11 uses, density and intensity of use, a receiving area district may allow for additional development
12 [and redevelopment](#) capacity and for increased lot building coverage and building envelope that are
13 greater than those of the underlying zoning.

14 (2) "Sending area district" means a zoning district, which is established and mapped
15 pursuant to a transfer of development rights ordinance and superimposed on one or more zoning
16 use [and form](#) districts or a portion thereof, that is eligible to establish development rights that may
17 eventually be transferred to a receiving area.

18 **45-24-46.3. Special provisions -- Transfer of development rights -- Exeter.**

19 (a) In addition to other powers granted to towns and cities by this chapter to establish and
20 administer transfer of development rights programs, the town council of the town of Exeter may
21 provide by ordinance for the transfer of development rights, as a voluntary program available to
22 developers and property owners, in the manner set forth in this section.

23 (b) For purposes of this section the following terms shall have the following meaning:

24 (1) "Receiving area district" means a zoning district, which is established and mapped
25 pursuant to a transfer of development rights ordinance and superimposed on one or more zoning
26 use [and form](#) districts or portions thereof, that is eligible to receive development rights through a
27 major land development project review. As may be necessary or desirable to achieve the intended
28 uses, density and intensity of use, a receiving area district may allow for additional development
29 capacity and for increased lot building coverage and building envelope that are greater than those
30 of the underlying zoning.

31 (2) "Sending area district" means a zoning district, which is established and mapped
32 pursuant to a transfer of development rights ordinance and superimposed on one or more zoning
33 use [and form](#) districts or a portion thereof, that is eligible to establish development rights that may
34 eventually be transferred to a receiving area.

1 (c) The establishment, as provided for by this section, of a system for transfer of
2 development rights within or between zoning districts, or a portion thereof, designated in the zoning
3 ordinance shall be:

4 (1) For the purpose of providing developers and property owners the ability to establish,
5 certify, purchase, sell, convey, and/or hold land development rights; and

6 (2) For one or more of the following purposes:

7 (i) Preserving sensitive resource areas in the community such as groundwater reserves,
8 wildlife habitat, agricultural lands, and public access to surface waters;

9 (ii) Directing development away from sensitive resource areas to places better suited to
10 increased levels of development [and redevelopment](#) such as established or proposed mixed use,
11 commercial, village, or residential centers;

12 (iii) Directing development to areas served by existing infrastructure such as established
13 roadways, public water supply systems, centralized sewer collection systems, public transit and
14 other utilities; or

15 (iv) Shaping and balancing urban and rural development, and/or promoting a high level of
16 quality in design in the development [and redevelopment](#) of private and public facilities and spaces.

17 **45-24-46.4. Special provisions -- Unified development review.**

18 (a) A zoning ordinance may provide that review and approval of dimensional variances,
19 use variances, [special dimensional permits](#), and/or ~~special-use~~ [special](#) permits for properties
20 undergoing review by the planning board or commission as land-development or subdivision
21 projects pursuant to § 45-23-36, be conducted and decided by the planning board or commission.
22 This process is to be known as unified development review.

23 (b) If unified development review is desired, such review must be enabled within the
24 zoning ordinance, in accordance with this section, and the local subdivision and land-development
25 regulations must be brought into conformance, pursuant to § 45-23-50.1.

26 (c) A zoning ordinance that provides for unified development review shall:

27 (1) Specify which types of zoning approval the planning board or commission shall be
28 empowered to grant for which types of projects; and

29 (2) Provide that any person, group, agency, or corporation that files an application for an
30 included land development or subdivision project may also file requests for relief from the literal
31 requirements of a zoning ordinance on the subject property, pursuant to § 45-24-41, and/or for the
32 issuance of ~~special-use~~ [special](#) permits for the subject property, pursuant to § 45-24-42, by
33 including such within the application to the administrative officer of the planning board or
34 commission with the other required application materials, pursuant to § 45-23-50.1(b).

1 (d) A zoning ordinance that provides for unified development review may specify design,
2 use, public benefit, or other relevant criteria that must be met in order for an application to qualify
3 for review under the unified development review provisions of the zoning ordinance. Certification
4 as to whether an application meets the established criteria shall be conducted in conjunction with,
5 and following the time lines outlined for, certification of completeness of the application, pursuant
6 to §§ 45-23-38(c), 45-23-40(b), or 45-23-41(b).

7 (e) All land development and subdivision applications that include requests for variances
8 and/or special-use permits submitted pursuant to this section shall require a public hearing that
9 meets the requirements of §§ 45-23-50.1(b) and 45-23-50.1(c).

10 (f) In granting requests for dimensional and use variances, the planning board or
11 commission shall be bound to the requirements of §§ 45-24-41(d) and 45-24-41(e) relative to
12 entering evidence into the record in satisfaction of the applicable standards.

13 (g) In reviewing requests for ~~special-use~~ [special](#) permits, the planning board or commission
14 shall be bound to the conditions and procedures under which a ~~special-use~~ [special](#) permit may be
15 issued and the criteria for the issuance of such permits, as found within the zoning ordinance
16 pursuant to §§ 45-24-42(b)(1), 45-24-42(b)(2) and 45-24-42(b)(3), and shall be required to provide
17 for the recording of findings of fact and written decisions as described in the zoning ordinance
18 pursuant to § 45-24-42(b)(5).

19 (h) An appeal from any decision made pursuant to this section may be taken pursuant to §
20 45-23-66.

21 **45-24-47. Special provisions -- Land development projects.**

22 (a) A zoning ordinance may provide for land development projects which are projects in
23 which one or more lots, tracts, or parcels of land are to be developed or redeveloped as a coordinated
24 site for a complex of uses, units, or structures, including, but not limited to, planned development
25 and/or cluster development for residential, commercial, institutional, industrial, recreational, open
26 space, and/or mixed uses as may be provided for in the zoning ordinance.

27 (b) A zoning ordinance adopted pursuant to this chapter which permits or requires the
28 creation of land development projects in one or more zoning districts shall require that any land
29 development project is referred to the city or town planning board or commission for approval, in
30 accordance with the procedures established by chapter 23 of this title, including those for appeal
31 and judicial review, and with any ordinances or regulations adopted pursuant to the procedures,
32 whether or not the land development project constitutes a "subdivision", as defined in chapter 23
33 of this title. No land development project shall be initiated until a plan of the project has been
34 submitted to the planning board or commission and approval has been granted by the planning

1 board or commission. In reviewing, hearing, and deciding upon a land development project, the
2 city or town planning board or commission may be empowered to allow zoning incentives within
3 the project; provided, that standards for the adjustments are described in the zoning ordinance, and
4 may be empowered to apply any special conditions and stipulations to the approval that may, in the
5 opinion of the planning board or commission, be required to maintain harmony with neighboring
6 uses and promote the objectives and purposes of the comprehensive plan and zoning ordinance.

7 (c) In regulating land development projects, an ordinance adopted pursuant to this chapter
8 may include, but is not limited to, regulations governing the following:

9 (1) A minimum area or site size for a land development project;

10 (2) Uses to be permitted within the development;

11 (3) Ratios of residential to nonresidential uses where applicable;

12 (4) Maximum density per lot and maximum density for the entire development, with

13 provisions for adjustment of applicable lot density and dimensional standards where open space is

14 to be permanently set aside for public or common use, and/or where the physical characteristics,

15 location, or size of the site require an adjustment, and/or where the location, size, and type of

16 housing, commercial, industrial, or other use require an adjustment, and/or where housing for low

17 and moderate income families is to be provided, or where other amenities not ordinarily required

18 are provided, as stipulated in the zoning ordinance. Provision may be made for adjustment of

19 applicable lot density and dimensional standards for payment or donation of other land or facilities

20 in lieu of an on-site provision of an amenity that would, if provided on-site, enable an adjustment;

21 (5) Roads, driveways, utilities, parking, and other facilities; regulations may distinguish

22 between those facilities intended to remain in private ownership or to be dedicated to the public;

23 and

24 (6) Buffer areas, landscaping, screening, and shading.

25 (d)(1) A zoning ordinance requiring open land in a cluster development or other land

26 development project for public or common use, shall provide that such open land either: (i) be

27 conveyed to the city or town and accepted by it for park, open space, agricultural, or other specified

28 use or uses, or (ii) be conveyed to a nonprofit organization, the principal purpose of which is the

29 conservation of open space or resource protection, or (iii) be conveyed to a corporation or trust

30 owned or to be owned by the owners of lots or units within the development [or redevelopment](#), or

31 owners of shares within a cooperative development [or redevelopment](#). If such a corporation or trust

32 is used, ownership shall pass with conveyances of the lots or units, or (iv) remain in private

33 ownership if the use is limited to agriculture, habitat or forestry, and the city or town has set forth

34 in its community comprehensive plan and zoning ordinance that private ownership is necessary for

1 the preservation and management of the agricultural, habitat or forest resources.

2 (2) In any case where the land is not conveyed to the city or town:

3 (i) A restriction, in perpetuity, enforceable by the city or town or by any owner of property
4 in the cluster or other land development project in which the land is located shall be recorded
5 providing that the land is kept in the authorized condition(s) and not built upon or developed for
6 accessory uses such as parking or roadway; and

7 (ii) The developmental rights and other conservation easements on the land may be held,
8 in perpetuity, by a nonprofit organization, the principal purpose of which is the conservation of
9 open space or resource protection.

10 (3) All open space land provided by a cluster development or other land development
11 project shall be subject to a community approved management plan that will specify the permitted
12 uses for the open space.

13 **45-24-48. Special provisions -- Preapplication conference.**

14 A zoning ordinance may provide for a preapplication conference for specific types of
15 development [and redevelopment](#) proposals. A preapplication conference is intended to allow the
16 designated agency to:

17 (1) Acquaint the applicant with the comprehensive plan and any specific plans that apply
18 to the parcel, as well as the zoning and other ordinances that affect the proposed development [or](#)
19 [redevelopment](#);

20 (2) Suggest improvements to the proposed design on the basis of a review of the sketch
21 plan;

22 (3) Advise the applicant to consult appropriate authorities on the character and placement
23 of public utility services; and

24 (4) Help the applicant to understand the steps to be taken to receive approval.

25 **45-24-57. Administration -- Powers and duties of zoning board of review.**

26 A zoning ordinance adopted pursuant to this chapter shall provide that the zoning board of
27 review shall:

28 (1) Have the following powers and duties:

29 (i) To hear and decide appeals within sixty-five (65) days of the date of the filing of the
30 appeal where it is alleged there is an error in any order, requirement, decision, or determination
31 made by an administrative officer or agency in the enforcement or interpretation of this chapter, or
32 of any ordinance adopted pursuant hereto;

33 (ii) To hear and decide appeals from a party aggrieved by a decision of an historic district
34 commission, pursuant to §§ 45-24.1-7.1 and 45-24.1-7.2;

1 (iii) To hear and decide appeals where the zoning board of review is appointed as the board
2 of appeals for airport zoning regulations, pursuant to § 1-3-19;

3 (iv) To authorize, upon application, in specific cases of hardship, variances in the
4 application of the terms of the zoning ordinance, pursuant to § 45-24-41;

5 (v) To authorize, upon application, in specific cases, ~~special-use~~ special permits, pursuant
6 to § 45-24-42, where the zoning board of review is designated as a permit authority for ~~special-use~~
7 special permits;

8 (vi) To refer matters to the planning board or commission, or to other boards or agencies
9 of the city or town as the zoning board of review may deem appropriate, for findings and
10 recommendations;

11 (vii) To provide for the issuance of conditional zoning approvals where a proposed
12 application would otherwise be approved except that one or more state or federal agency approvals
13 that are necessary are pending. A conditional zoning approval shall be revoked in the instance
14 where any necessary state or federal agency approvals are not received within a specified time
15 period; and

16 (viii) To hear and decide other matters, according to the terms of the ordinance or other
17 statutes, and upon which the board may be authorized to pass under the ordinance or other statutes;
18 and

19 (2) Be required to vote as follows:

20 (i) Five (5) active members are necessary to conduct a hearing. As soon as a conflict occurs
21 for a member, that member shall recuse himself or herself, shall not sit as an active member, and
22 shall take no part in the conduct of the hearing. Only five (5) active members are entitled to vote
23 on any issue;

24 (ii) The concurring vote of three (3) of the five (5) members of the zoning board of review
25 sitting at a hearing are necessary to reverse any order, requirement, decision, or determination of
26 any zoning administrative officer from whom an appeal was taken; and

27 (iii) The concurring vote of four (4) of the five (5) members of the zoning board of review
28 sitting at a hearing is required to decide in favor of an applicant on any matter within the discretion
29 of the board upon which it is required to pass under the ordinance, including variances and ~~special-~~
30 use special permits.

31 **45-24-58. Administration -- Application procedure.**

32 The zoning ordinance establishes the various application procedures necessary for the
33 filing of appeals, requests for variances, ~~special-use~~ special permits, development plan reviews, site
34 plan reviews, and other applications that may be specified in the zoning ordinance, with the zoning

1 board of review, consistent with the provisions of this chapter. The zoning ordinance provides for
2 the creation of appropriate forms, and for the submission and resubmission requirements, for each
3 type of application required. A zoning ordinance may establish that a time period of a certain
4 number of months is required to pass before a successive similar application may be filed.

5 **45-24-61. Administration -- Decisions and records of zoning board of review.**

6 (a) Following a public hearing, the zoning board of review shall render a decision within
7 fifteen (15) days. The zoning board of review shall include in its decision all findings of fact and
8 conditions, showing the vote of each participating member, and the absence of a member or his or
9 her failure to vote. Decisions shall be recorded and filed in the office of the city or town clerk within
10 thirty (30) days from the date when the decision was rendered, and is a public record. The zoning
11 board of review shall keep written minutes of its proceedings, showing the vote of each member
12 upon each question, or, if absent or failing to vote, indicating that fact, and shall keep records of its
13 examinations, findings of fact, and other official actions, all of which shall be recorded and filed in
14 the office of the zoning board of review in an expeditious manner upon completion of the
15 proceeding. For any proceeding in which the right of appeal lies to the superior or supreme court,
16 the zoning board of review shall have the minutes taken either by a competent stenographer or
17 recorded by a sound-recording device.

18 (b) Any decision by the zoning board of review, including any special conditions attached
19 to the decision, shall be mailed within one business day of recording, by any method that provides
20 confirmation of receipt to the applicant, to any objector who has filed a written request for notice
21 with the zoning enforcement officer, and to the zoning enforcement officer of the city or town. Any
22 decision evidencing the granting of a variance, modification, or ~~special-use~~ [special permit](#) shall also
23 be recorded in the land evidence records of the city or town and mailed within one business day of
24 recording, by any method that provides confirmation of receipt, to the applicant, to any objector
25 who has filed a written request for notice with the zoning enforcement officer, and to the zoning
26 officer. A copy of the recorded decision shall be mailed within one business day of recording, by
27 any method that provides confirmation of receipt, to the applicant, and to any objector who has
28 filed a written request for notice with the zoning enforcement officer, as well as a copy to the zoning
29 enforcement officer.

30 SECTION 2. This act shall take effect upon passage.
