It is enacted by the General Assembly as follows:

1 SECTION 1. Sections 5-63.2-2, 5-63.2-4, 5-63.2-9 and 5-63.2-10 of the General Laws in 2 Chapter 5-63.2 entitled "Mental Health Counselors and Marriage and Family Therapists" are 3 hereby amended to read as follows: 4 **5-63.2-2.** Definitions. 5 As used in this chapter: 6 (1) "Advertise" means, but is not limited to, the issuing or causing to be distributed any 7 card, sign, or device to any person; or the causing, permitting, or allowing any sign or marking on 8 or in any building, radio, or television; or by advertising by any other means designed to secure 9 public attention. 10 (2) "Board" means the board of mental health counselors and marriage and family 11 therapists. 12 (3) "Clinical counselor in mental health" means a person who is licensed pursuant to § 5-63.2-9, which license is in force and not suspended or revoked as of the particular time in question. 13 14 (4) "Internship" means a part of an organized graduate program in counseling therapy and 15 constitutes a supervised experience within a mental health and/or marriage and family setting. (5) "Marriage and family therapist" means a person who is licensed pursuant to § 5-63.2-16

(6) "Person" means any individual, firm, corporation, partnership, organization, or body

2	(7) "Practice of clinical mental health counseling" means the rendering of professional
3	services to individuals, families, or groups for monetary compensation. These professional services
4	include:
5	(i) Applying the principles, methods, and theories of counseling and/or psychotherapeutic
6	techniques to define goals and develop a treatment plan of action aimed toward the prevention,
7	treatment, and resolution of social, mental, and emotional dysfunction and intra or interpersonal
8	disorders in persons diagnosed at intake as non-psychotic and not presenting medical problems;
9	and
10	(ii) Engaging in psychotherapy of a nonmedical nature, utilizing supervision when
11	appropriate, and making referrals to other psychiatric, psychological, or medical resources when
12	the person is diagnosed as psychotic or presenting a medical problem.
13	(8) "Practice of marriage and family therapy" means the rendering of professional services
14	to individuals, family groups, couples, or organizations for monetary compensation. These
15	professional services include applying principles, methods, and therapeutic techniques for the
16	purpose of resolving emotional conflicts; modifying perceptions and behavior; enhancing
17	communications and understanding among all family members; and the prevention of family and
18	individual crisis. Individual marriage and family therapists shall also engage in psychotherapy of a
19	nonmedical and non-psychotic nature with appropriate referrals to psychiatric resources.
20	(9) "Practicum" means a part of an organized graduate program in counseling therapy and
21	constitutes a supervised experience within the graduate counseling program.
22	(10) "Qualified supervision" means the supervision of clinical services in accordance with
23	standards established by the board under the supervision of an individual who has been recognized
24	by the board as an approved supervisor.
25	(11) "Recognized educational institution" means any educational institution that grants a
26	bachelor's, master's, or doctoral degree and is recognized by the board of mental health counselors
27	and marriage and family therapists or a recognized postgraduate clinical training program as
28	specified in §§ $\frac{5-63.2-9(2)}{5-63.2-9}$ and $\frac{5-63.2-10(2)}{5-63.2-10}$.
29	(12) "Use a title or description of" means to hold oneself out to the public as having a
30	particular status by means of stating on signs, mailboxes, address plates, stationery,
31	announcements, calling cards, or other instruments of professional identification.
32	5-63.2-4. Composition of board Appointment, terms, and removal of members.
33	The director of the department of health, with the approval of the governor, shall appoint
34	nine (9) electors as members of the board. Three (3) shall be clinical mental health counselors, at

1	least two (2) of whom shall meet the qualifications of § 5-63.2-9 5-63.2-9(b) and have at least five
2	(5) years of private practice experience in mental health counseling; three (3) shall be marriage and
3	family therapists, who shall be clinical marriage and family therapists who meet the qualifications
4	of § 5-63.2-10 5-63.2-10(b) and have at least five (5) years of private practice experience in
5	marriage and family therapy; three (3) shall be members of the public. Commencing September
6	1996, the director of the department of health shall appoint one clinical mental health counselor for
7	one year; one clinical mental health counselor for two (2) years; one clinical mental health
8	counselor for three (3) years; one marriage and family therapist for one year; one marriage and
9	family therapist for two (2) years; one marriage and family therapist for three (3) years; one public
10	member for two (2) years; and two (2) public members for three (3) years. After this, all terms of
11	appointments shall be for three (3) years. In no instance shall a person serve more than six (6)
12	consecutive years on the board.

27	(3)(iii) Has completed sixty (60) semester hours or ninety (90) quarter hours within his or
28	her graduate counseling/therapy program; and
29	(4)(iv) Has completed a minimum of twelve (12) semester hours or eighteen (18) quarter
30	hours of supervised practicum and a minimum of one calendar year of supervised internship
31	consisting of twenty (20) hours per week, or its equivalent, with emphasis in mental health
32	counseling supervised by the department within the college or university granting the requisite
33	degree or by an accredited postgraduate clinical training program recognized by the United States
34	Department of Education, or education and/or experience that is deemed equivalent by the board;

9	services with emphasis in marriage and family therapy subsequent to being awarded a master's
10	degree or doctorate; and
11	(6)(ii) Has had a minimum of one hundred (100) hours of post-degree supervised case work
12	spread over two years (2); provided, that the supervision was provided by a person who, at the time
13	of rendering the supervision, was recognized by the board as an approved supervisor; and
14	(7)(iii) Has passed to the satisfaction of the board an examination conducted by it to
15	determine the applicant's qualifications for licensure as a marriage and family therapist or is
16	applying for licensure under the provisions of § 5-63.2-15.
17	(b) A candidate shall be qualified for licensure as a marriage and family therapist associate,
18	or a marriage and family therapist upon the affirmative vote of at least four (4) members of the
19	board, two (2) of whom must be marriage and family therapists on the board.
20	SECTION 2. This act shall take effect upon passage.

EXPLANATION

BY THE LEGISLATIVE COUNCIL

OF

AN ACT
