# House Bill 1012

HOUSE JUDICIARY ENGROSSED

1 **An Act to correct technical errors in statutory cross-references.**

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 **Section 1.** That § 1-14-1 be AMENDED:

4 **1-14-1. Continuation of bureau--Department of Executive Management--**  
 5 **Central office location.**

6 The Bureau of Administration shall continue within the Department of Executive  
 7 Management, and all its functions shall be performed by the Department of Executive  
 8 Management ~~as provided by § 1-33-6.~~

9 The bureau shall maintain a central office in Pierre which shall be the official address  
 10 of the bureau and the place for serving process or papers of any kind upon it.

11 **Section 2.** That § 1-33B-2 be AMENDED:

12 **1-33B-2. Energy conservation measure defined--Inclusions--Limitation.**

13 For the purposes of this chapter, the term, energy conservation measure, means  
 14 a training program or facility alteration intended to reduce either energy consumption or  
 15 operating costs, or both, or increase operating revenues through the generation of energy,  
 16 renewable energy, or improved metering technology, including the following:

- 17 (1) Insulation of the building or any structure associated with the building;
- 18 (2) Window or door replacement, weather stripping, or modifications that reduce  
 19 energy consumption;
- 20 (3) Automated or computerized energy control systems;
- 21 (4) Replacement or modification to increase the energy efficiency of the lighting,  
 22 heating, air conditioning, or ventilating systems;
- 23 (5) Energy recovery or cogeneration systems;
- 24 (6) Repair or maintenance items, when included in energy efficiency improvements of  
 25 the building, if overall measures meet the fifteen-year payback as provided in ~~§ 1-~~

1 ~~33B-7~~ § 1-33B-8;

2 (7) Energy source conversions which provide either operational or energy cost savings,  
3 or both; and

4 (8) Other energy or utility-related improvements in facilities, systems, or technology  
5 that improve energy or metering efficiency or increase operating revenues through  
6 the generation of energy, renewable energy, or improved metering technology.

7 Nothing in this section addresses the relationship between an electric utility and its  
8 customer under a proposed energy exchange contract, where the customer seeks status  
9 as a qualifying facility under the Public Utility Regulatory Policies Act of 1978, as defined  
10 by 18 CFR Part 292, Subpart B, as it existed on January 1, 2005.

11 **Section 3.** That § 1-40-20.1 be AMENDED:

12 **1-40-20.1. Water Management Board--Functions transferred.**

13 The functions of the Water Management Board ~~pursuant to §§ 34A-2-86 and 34A-~~  
14 ~~2-87~~, relating to water pollution control grants, community water systems grants, and  
15 lake protection grants, respectively, are transferred to the Board of Water and Natural  
16 Resources.

17 **Section 4.** That § 1-45-27.1 be AMENDED:

18 **1-45-27.1. Education and Cultural Affairs Planning Commission--Functions**  
19 **transferred.**

20 The functions of the Education and Cultural Affairs Planning Commission ~~created~~  
21 ~~by § 1-45-27~~ are transferred to the secretary of education.

22 **Section 5.** That § 3-22-5 be AMENDED:

23 **3-22-5. Bureau of Administration--Powers.**

24 The bureau may:

- 25 (1) Select a director who shall serve at the pleasure of the bureau;
- 26 (2) Enter contracts for actuarial determinations, claims adjustment and investigation,  
27 loss control and risk management, legal services, or other services the director  
28 determines to be necessary to carry out the purposes of this chapter;
- 29 (3) Enter contracts for insurance and reinsurance the director determines to be  
30 necessary to carry out the purposes of this chapter. Any such contract is not subject  
31 to the provisions of chapters 5-18A and ~~5-18-D~~ 5-18D;

- 1 (4) Develop a coverage document, agreed to by the director and the Governor, to  
2 establish the type and scope of covered claims, limits of coverage, terms and  
3 conditions of coverage, and costs of coverage; and
- 4 (5) Based on annual actuarial calculations, impose and collect contributions from  
5 covered state entities for the estimated amount necessary to extend coverage and  
6 maintain appropriate reserves for covered claims.

7 **Section 6.** That § 4-7-2 be AMENDED:

8 **4-7-2. Bureau of Finance and Management continued--Functions performed--**  
9 **-Purpose.**

10 The Bureau of Finance and Management is hereby continued within the Department  
11 of Executive Management, for the purpose of promoting economy and efficiency in the  
12 fiscal management of the state government. All its functions shall be performed by the  
13 Department of Executive Management ~~as provided by § 1-33-6.~~

14 **Section 7.** That § 4-8A-17 be AMENDED:

15 **4-8A-17. Legislative priority pilot program contingency fund created.**

16 On June 29, 2015, the state treasurer shall transfer to the legislative priority pilot  
17 program contingency fund, which is hereby created, the sum of one million dollars  
18 (\$1,000,000) from the South Dakota risk pool fund ~~created by § 58-17-120.~~ The  
19 contingency funds are to be made available in accordance with the provisions of §§ 4-8A-  
20 9, 4-8A-10, 4-8A-11, and 4-8A-12. The contingency funds shall be used to fund legislative  
21 priority pilot programs. Interest earned on money in the fund shall be deposited into the  
22 general fund.

23 **Section 8.** That § 5-6-13 be AMENDED:

24 **5-6-13. Amount of forest products determined--State forester.**

25 The commissioner of school and public lands may authorize the state forester to  
26 determine the amount of forest products to be harvested from school and endowment  
27 lands ~~in accordance with § 41-20-8.~~

28 **Section 9.** That § 5-18A-24 be AMENDED:

1 **5-18A-24. Grade A milk processors--Competitive bid contracts.**

2 Any milk processor licensed pursuant to ~~§ 39-6-7~~, for Grade A milk that is bidding  
 3 any milk or milk product under a competitive bid contract, shall receive the bid contract if  
 4 the processor's bid is equal to, or within five percent or less, of any other bidder who is  
 5 not a licensed processor.

6 **Section 10.** That § 7-12-17 be AMENDED:

7 **7-12-17. Mileage and food costs--Reimbursement--Deductions.**

8 Nothing in § 7-12-15 ~~or 7-12-16, however,~~ shall be construed to change the  
 9 reimbursement of the sheriff for costs of mileage incurred while on official business nor to  
 10 change the fee received by the sheriff for the costs of food for boarding of prisoners. In  
 11 the event that housing and utilities are furnished by a county to the sheriff, the county  
 12 board of commissioners is authorized to establish a reasonable value for such quarters,  
 13 based upon the general level of housing accommodation rentals prevailing at the county  
 14 seat, and to deduct from the regular salary of the sheriff an equivalent amount therefor.

15 **Section 11.** That § 7-20-12 be AMENDED:

16 **7-20-12. Removal from office--Cause.**

17 Any county officer neglecting or refusing to comply with the provisions of §§ 7-20-  
 18 ~~1 to 7-20-11, inclusive, through 7-20-10~~ is subject to removal from office. No county  
 19 treasurer is liable on the county treasurer's official bond for any loss of money deposited  
 20 in compliance with the provisions of these sections.

21 **Section 12.** That § 9-3-26 be AMENDED:

22 **9-3-26. State or local tax funds--Prohibition--Exception.**

23 Such municipality shall not be authorized to receive any state or local tax funds or  
 24 any distribution from either state or local sources except such as are specifically provided  
 25 under ~~§§ 7-18-11 and 7-18-12, or any amendments thereto~~ § 7-18-12 or similar laws  
 26 hereafter enacted, for tourist, educational, and recreational activities.

27 **Section 13.** That § 9-38-90 be AMENDED:

28 **9-38-90. City attorney--Duties--Recreation board--Special counsel.**

29 The city attorney as a part of his duties shall conduct all court proceedings under  
 30 ~~§§ 9-38-79 to 9-38-106, inclusive~~ §§ 9-38-80 through 9-38-106, and shall be the legal

1        adviser of the recreation board. When in its judgment the interests of the first or second  
2        class municipality demand, the recreation board may employ special counsel to assist the  
3        city attorney.

4        **Section 14.** That § 9-41A-48 be AMENDED:

5                    **9-41A-48. Encumbrance of property to secure bonds and notes--Filings.**

6                    For the security of bonds or notes issued, or to be issued, by a municipal power  
7                    agency, the municipal power agency may mortgage or execute deeds of trust of the whole  
8                    or any part of its property and franchises in the same manner and with the same effect  
9                    as provided for public utilities in § 49-34-9. Any mortgage or deed of trust and any  
10                   assignment or discharge thereof shall be filed and recorded in the Office of the Secretary  
11                   of State with the same force and effect as provided in §§ 49-34-11 and 49-34-12. All  
12                   filings required under the Uniform Commercial Code to perfect a security interest against  
13                   the personal property or fixtures of a municipal power agency shall be made and  
14                   maintained in the Office of the Secretary of State, with the same force and effect as  
15                   provided ~~in the case of for a debtor public utility under the provisions of §§ 57A-9-403.1~~  
16                   ~~to 57A-9-403.5, inclusive.~~

17        **Section 15.** That § 9-51-23 be AMENDED:

18                    **9-51-23. Net revenues pledged to payment of special obligation bonds--**

19                    **Additional covenants authorized.**

20                    Bonds authorized and issued under §§ 9-51-22 ~~to 9-51-29, inclusive, through 9-~~  
21                    ~~51-28~~ may be made payable as to both principal and interest out of the net revenues or  
22                    moneys levied and appropriated as set forth in § 9-51-14, provided that in the ordinance  
23                    authorizing such bonds the governing body may on behalf of the municipality make any  
24                    or all of the irrevocable covenants in §§ 9-51-24 ~~to through 9-51-28, inclusive,~~ with and  
25                    for the benefit of the holders from time to time of said bonds.

26        **Section 16.** That § 10-4-33 be REPEALED.

27                    **10-4-33. Property used as employee day-care cooperative exempt--**

28                    **Determining value.**

29        **Section 17.** That § 10-6-33.35 be AMENDED:

1           **10-6-33.35. Agricultural Land Assessment Implementation and Oversight**  
2           **Advisory Task Force.**

3           There is hereby established the Agricultural Land Assessment Implementation and  
4           Oversight Advisory Task Force. The task force shall consist of the following fourteen  
5           members:

- 6           (1)    The speaker of the House of Representatives shall appoint four members of the  
7                House of Representatives, no more than two of whom may be from one political  
8                party;
- 9           (2)    The speaker of the House of Representatives shall appoint three members of the  
10            general public, at least one of the members shall have an agricultural background  
11            and at least one of the members shall have a business background;
- 12           (3)    The president pro tempore of the Senate shall appoint four members of the Senate,  
13                no more than two of whom may be from one political party; and
- 14           (4)    The president pro tempore of the Senate shall appoint three members of the  
15                general public, at least one of the members shall have an agricultural background  
16                and at least one of the members shall have a business background.

17           The initial appointments shall be made no later than July 1, 2008, and shall serve  
18           until January 12, 2009. The speaker of the House of Representatives and president pro  
19           tempore of the Senate before the close of each regular session of the Legislature held in  
20           odd-numbered years shall appoint members to the task force for a term of two years. If  
21           there is a vacancy on the task force, the vacancy shall be filled in the same manner as  
22           the original appointment.

23           The task force shall advise the department regarding the rules promulgated by the  
24           department to administer the provisions concerning the assessment and taxation of  
25           agricultural lands and shall review the implementation of the provisions of law concerning  
26           the assessment and taxation of agricultural land. The task force shall report to the Senate  
27           and House of Representatives and may submit a copy of its report to the Governor. The  
28           task force may present draft legislation and policy recommendations to the Legislative  
29           Research Council Executive Board.

30           The task force shall make recommendations in the following areas:

- 31           (1)    The proper percentage of annual earning capacity to be used to determine the  
32                agricultural income value pursuant to § 10-6-33.28;
- 33           (2)    The proper capitalization rate in order to have total taxable valuation for the taxes  
34                payable in 2011 from agricultural property be not more than total taxable valuation

- 1 for the taxes payable in 2010 from agricultural property plus the estimated growth  
 2 in agricultural property value in 2010;
- 3 (3) The changes, if any, that must be made to §§ ~~13-10-6,~~ 13-16-7, 13-37-16, and  
 4 13-37-35.1 to ensure that the total amount of additional taxes that may be  
 5 generated on agricultural land by a school district pursuant to the provisions of  
 6 §§ ~~13-10-6,~~ 13-16-7, 13-37-16, and 13-37-35.1 will not provide a substantial  
 7 property tax revenue increase for the school district pursuant to the  
 8 implementation of the productivity system pursuant to §§ 10-6-33.28 to 10-6-  
 9 33.33, inclusive;
- 10 (4) The changes, if any, that must be made to §§ ~~13-10-6,~~ 13-16-7, 13-37-16, and  
 11 13-37-35.1 to ensure that the total amount of property taxes that may be lost on  
 12 agricultural land by a school district pursuant to the provisions of §§ ~~13-10-6,~~ 13-  
 13 16-7, 13-37-16, and 13-37-35.1 will not provide a substantial property tax revenue  
 14 decrease for the school district pursuant to the implementation of the productivity  
 15 system pursuant to §§ 10-6-33.28 to 10-6-33.33, inclusive; and
- 16 (5) The distribution of the local effort for the general fund of school districts between  
 17 the classifications of real property as provided by § 13-13-72.1 which establishes  
 18 the real property tax contribution from agricultural property for the general fund  
 19 of school districts as a fixed ratio of the total local effort for such levies. The task  
 20 force shall also consider the other taxes paid by agricultural property, the  
 21 relationship of the total assessed value of agricultural property to the total assessed  
 22 value of all real property, and other factors the task force deems appropriate.

23 **Section 18.** That § 10-10-13 be AMENDED:

24 **10-10-13. Appeal from state or county board.**

25 Any appeal under §§ ~~10-10-11 and 10-10-12~~ § 10-10-11 must be taken within  
 26 thirty days after the filing of the decision in the office of the board making the same.

27 **Section 19.** That § 10-11-26 be AMENDED:

28 **10-11-26. County board of equalization--Powers--De novo appeals.**

29 A county board of equalization has all the power and authority of a local board of  
 30 equalization in all unorganized territories. A county board of equalization may:

- 31 (1) ~~Make adjustments and corrections pursuant to § 10-11-61;~~  
 32 (2) Correct clerical errors of the assessment roll;  
 33 (3)(2) Hear appeals from individuals regarding aggregate assessments, classification, and

1 equalization; and  
 2 ~~(4)~~(3) Equalize between taxing districts and between classes of property. The board shall  
 3 raise or lower, if necessary, each class of property on a percentage basis covering  
 4 the class as a whole within the assessment district.  
 5 Appeals to the county board of equalization shall be heard de novo.

6 **Section 20.** That § 10-11-72 be AMENDED:

7 **10-11-72. Consolidated board of equalization--Powers.**

8 A consolidated board of equalization may:

- 9 ~~(1)~~—~~Make adjustments and corrections pursuant to § 10-11-61;~~  
 10 ~~(2)~~ Correct clerical errors of the assessment roll;  
 11 ~~(3)~~(2) Hear appeals from individuals regarding aggregate assessments, classification, and  
 12 equalization; and  
 13 ~~(4)~~(3) Equalize between taxing districts and between classes of property. The board shall  
 14 raise or lower, if necessary, each class of property on a percentage basis covering  
 15 the class as a whole within the assessment district.

16 **Section 21.** That § 10-39A-3 be REPEALED.

17 **10-39A-3. Collection and administration according to mineral severance tax**  
 18 **procedures.**

19 **Section 22.** That § 10-39A-7 be AMENDED:

20 **10-39A-7. Tax in lieu of other taxes.**

21 This tax is in lieu of ~~the tax provided in § 10-39-24 and in lieu of all other~~  
 22 occupational, excise, income, privilege, franchise taxes, and any other mineral taxes  
 23 levied by ~~the State of South Dakota~~ this state, but is not in lieu of sales, use, and property  
 24 taxes.

25 **Section 23.** That § 10-45-61 be AMENDED:

26 **10-45-61. Exemption certificate--Responsibilities of purchaser--Violation as**  
 27 **misdemeanor--Retention of certificate--Rules and forms.**

28 ~~Notwithstanding § 10-54-1, a~~ A seller, who possesses an exemption certificate  
 29 from a purchaser of tangible personal property, any product transferred electronically, or  
 30 services which indicates the items or services being purchased are exempt, may rely on



1 the exemption certificate and not charge sales tax to the provider of the exemption  
2 certificate until the provider of the exemption certificate gives notice that the items or  
3 services being purchased are no longer exempt by filing a new exemption certificate with  
4 the seller.

5 The exemption certificate shall be signed by the purchaser. The exemption certificate  
6 shall provide the purchaser's name, address, and valid state tax license number, if  
7 applicable. However, any person filing an electronic exemption certificate is not required  
8 to sign the exemption certificate.

9 The purchaser claiming the protection of an exemption certificate is responsible for  
10 assuring that the goods and services delivered thereafter are of a type covered by the  
11 exemption certificate. A seller of property, any product transferred electronically, or  
12 services which are generally described under the exemption certificate is not responsible  
13 for the collection of the tax unless otherwise directed by the purchaser.

14 If the purchaser later determines there is any tax due and owing, the purchaser shall  
15 remit the tax owed by the purchaser to the state. If the purchaser makes an exempt  
16 purchase and later determines that the goods or services purchased are not exempt, the  
17 purchaser shall report the transaction and pay the use tax on the next filing of the  
18 purchaser's return.

19 Any purchaser who knowingly files an exemption certificate with a retailer in order to  
20 purchase tangible personal property, any product transferred electronically, or services  
21 with the intent to evade payment of the tax, and fails to timely report the same with the  
22 department is guilty of a Class 1 misdemeanor. The secretary of revenue may assess a  
23 penalty of up to fifty percent of the tax owed, in addition to the tax owed. No interest may  
24 be charged on the penalty.

25 The seller shall retain the exemption certificate for a period of three years from the  
26 date it is filed by the purchaser and provide the exemption certificate to the department  
27 upon request.

28 The secretary may promulgate rules pursuant to chapter 1-26 to adopt forms for  
29 exemption certificates.

30 **Section 24.** That § 10-52-3 be AMENDED:

31 **10-52-3. Referendum procedure--Certain municipalities to review tax**  
32 **ordinances.**

33 Any tax imposed by the governing board of any municipality pursuant to the  
34 provisions of this chapter, may be referred to a vote of the people for its approval or

1 disapproval in the same manner as provided in §§ 9-20-7, 9-20-8, and 9-20-10. A tax  
 2 imposed by municipal ordinance which was in effect on December 31, 2003, is continued  
 3 under the provisions of this chapter if:

- 4 (1) The governing board of the municipality has reviewed the existing tax ordinance to  
 5 determine compliance with the provisions of this chapter; and
- 6 (2) The governing board of the municipality documents the review, any amendment,  
 7 and the intent to continue the tax in the official minutes of the governing board.

8 Any amendment made by the municipality to comply with the provisions of chapter  
 9 10-45C, §§ 10-1-44.3, 10-45-1 to 10-45-1.4, inclusive, 10-45-2.3, 10-45-3.4, 10-45-5,  
 10 10-45-5.3, 10-45-8, 10-45-24, 10-45-30, 10-45-61, 10-45-108 and 10-45-109, 10-46-  
 11 1, 10-46-17.6, 10-52-2, 10-52-2.10, 10-52-3, 10-52-9, 10-52-13 ~~to 10-52-16, inclusive~~  
 12 through 10-52-15, and 10-59-27 or the determination to continue the tax under the  
 13 provisions of this chapter is deemed to be an administrative decision pursuant to § 9-20-  
 14 19 and is not subject to referendum.

15 **Section 25.** That § 11-3-1.1 be AMENDED:

16 **11-3-1.1. Definitions.**

17 Terms used in this chapter mean:

- 18 (1) "Governing body," the board of county commissioners, the city council, city  
 19 commission, or town board;
- 20 (2) "Improvement district," an improvement district constituted under authority of  
 21 chapter 7-25A;
- 22 (3) "Municipality," an incorporated city or town;
- 23 (4) "Planning commission," a planning commission constituted under authority of  
 24 chapters 11-2, 11-4, and 11-6;
- 25 (5) "Plat," a map, or representation on paper, of a piece of land subdivided into lots,  
 26 parcels, tracts, or blocks, including streets, commons, and public grounds, if any,  
 27 all drawn to scale;
- 28 (6) "Registered land surveyor," a registered land surveyor, registered in good standing  
 29 and legally authorized to practice land surveying ~~under the provisions of § 36-18-~~  
 30 ~~6~~;
- 31 (7) "Streets," streets, avenues, boulevards, roads, lanes, alleys, or other ways.

32 **Section 26.** That § 11-11-179 be AMENDED:

1           **11-11-179. Retirement and redemption of investments in sponsor of**  
 2           **multifamily units and day-care facilities.**

3           The authority shall have the power, in the supervision of housing sponsors of  
 4           multifamily residential housing units and day-care facilities and their real and personal  
 5           property, to regulate the retirement of any capital investment or the redemption of stock  
 6           where any such retirement or redemption when added to any dividend or other distribution  
 7           shall exceed in any one fiscal year such percentage, as may be determined by rules and  
 8           ~~regulations of the authority or as may be specified in the agreement required by § 11-11-~~  
 9           ~~156 of the original face amount of any investment or equity in any housing sponsor or as~~  
 10          specified in the agreement between the authority and the housing sponsor of the original  
 11          face amount of any investment or equity in any housing sponsor. Projects whose rents or  
 12          income limits applicable to project residents are established, subsidized or regulated by  
 13          federal law, or whose loans are insured or guaranteed by the federal government shall be  
 14          subject to an agreement between the authority and the housing sponsor which will subject  
 15          said sponsor and its principals or stockholders, if any, to those limitations established by  
 16          federal law, or such lower limitation as shall be prescribed by the authority, in regulating  
 17          the retirement of any capital investment or the redemption of stock of the original face  
 18          amount of any investment or equity in any housing sponsor.

19          **Section 27.** That § 12-6-6 be AMENDED:

20                   **12-6-6. Joint petitions for delegate and legislative candidates--Individual**  
 21                   **petitions.**

22           Two or more candidates for delegates to the state convention of the party, and  
 23           except as to candidates in joint legislative districts, candidates for two or more legislative  
 24           offices may be included in one nominating petition. Except as provided ~~herein and in § 12-~~  
 25           ~~5-3 under this section,~~ individual nominating petitions shall be filed.

26          **Section 28.** That § 12-20-48.1 be AMENDED:

27                   **12-20-48.1. Certification to state party chairman of votes for national**  
 28                   **convention slates.**

29           Upon the completion of the state canvass of the results of the primary election for  
 30           delegates and alternates to the national convention, the State Canvassing Board shall  
 31           certify to the state chairman of each political party the slates (groups of delegates and  
 32           alternates) entered in the primary for each political party and the number of votes in the  
 33           primary for each slate ~~pursuant to § 12-5-3.10.~~

1 **Section 29.** That § 12-27-43 be AMENDED:

2 **12-27-43. Action for civil penalty--Limitation.**

3 The attorney general may bring an action for a civil penalty against any person,  
4 political committee, political party, or organization that violates § 12-27-16 ~~or 12-27-17~~,  
5 in addition to any other penalties provided by law. The civil penalty may not exceed two  
6 thousand dollars for each violation.

7 **Section 30.** That § 13-6-13.1 be AMENDED:

8 **13-6-13.1. Former school district representation areas for consolidated**  
9 **districts--Establishment--Election of board members.**

10 When the reorganization plan is submitted, the school board or the electors of the  
11 district may establish school board representation areas to represent each former school  
12 district which consolidated to form the reorganized school district. Each former school  
13 district representation area shall be formed by adhering to standards of population  
14 deviance as established by judicial precedence. The former school district representation  
15 areas shall be established after an election is called and held pursuant to §§ 13-8-3 to 13-  
16 8-5, inclusive, by a majority vote of the electors voting at the election. The former school  
17 district representation areas, if established, shall become effective January first of the  
18 following year. ~~If so established, the representation areas supersede the provisions of~~  
19 ~~§ 13-8-7 regarding representation from incorporated and nonincorporated areas.~~ If former  
20 board member representation areas are established, the school board member candidate  
21 shall be a resident voter and reside within the representation area to qualify. The  
22 reorganization plan shall state whether the school board member candidates shall be  
23 elected at large or elected by the voters who reside within the representation area.

24 Any current board members shall serve the balance of their term. At the time of an  
25 election or vacancy, board members shall be elected or appointed in order that each  
26 representation area shall have a resident board member.

27 **Section 31.** That § 13-13-10.1 be AMENDED:

28 **13-13-10.1. Definitions.**

 11 misdemeanor.

4 The liquidator may permit a claimant making a late filing to share in distributions,

7 payment of claims, punitive or exemplary damages, or attorneys' fees and costs;

9 insurer, and is placed under an order of rehabilitation or conservation by a court of  
10 competent jurisdiction;

12 order of liquidation by a court of competent jurisdiction with a finding of insolvency;
- 13 (12) "Member insurer," an insurer licensed or that holds a certificate of authority to  
14 transact in this state any kind of insurance for which coverage is provided under  
15 § 58-29C-46, and includes an insurer whose license or certificate of authority in this  
16 state may have been suspended, revoked, not renewed, or voluntarily withdrawn,  
17 but does not include:

29 published by Moody's Investors Service, Inc., or any successor thereto;
- 30 (14) "Owner" of a policy or contract and "policy owner" and "contract owner," the person  
31 who is identified as the legal owner under the terms of the policy or contract or who  
32 is otherwise vested with legal title to the policy or contract through a valid  
33 assignment completed in accordance with the terms of the policy or contract and  
34 properly recorded as the owner on the books of the insurer. The terms owner,  
35 contract owner, and policy owner do not include persons with a mere beneficial

- 1 interest in a policy or contract;
- 2 (15) "Person," an individual, corporation, limited liability company, partnership,  
3 association, governmental body or entity, or voluntary organization;
- 4 (16) "Premiums," amounts or considerations (by whatever name called) received on  
5 covered policies or contracts less returned premiums, considerations, and deposits  
6 and less dividends and experience credits. The term, premiums, does not include  
7 amounts or considerations received for policies or contracts or for the portions of  
8 policies or contracts for which coverage is not provided under subpart B of § 58-  
9 29C-46 except that assessable premium may not be reduced on account of  
10 subsection ~~58-29C-46B(2)(c)~~58-29C-46(B)(2)(c) relating to interest limitations  
11 and subdivision ~~58-29C-46C(2)~~58-29C-46(C)(2) relating to limitations with respect  
12 to one individual, one participant, and one contract owner. Premiums do not  
13 include:
- 14 (a) Premiums on an unallocated annuity contract; or
- 15 (b) With respect to multiple nongroup policies of life insurance owned by one  
16 owner, whether the policy owner is an individual, firm, corporation, or other  
17 person, and whether the persons insured are officers, managers, employees,  
18 or other persons, premiums in excess of five million dollars with respect to  
19 these policies or contracts, regardless of the number of policies or contracts  
20 held by the owner;
- 21 (17) "Principal place of business" of a plan sponsor or a person other than a natural  
22 person, the single state in which the natural persons who establish policy for the  
23 direction, control, and coordination of the operations of the entity as a whole  
24 primarily exercise that function, determined by the association in its reasonable  
25 judgment by considering the following factors:
- 26 (a) The state in which the primary executive and administrative headquarters of  
27 the entity is located;
- 28 (b) The state in which the principal office of the chief executive officer of the  
29 entity is located;
- 30 (c) The state in which the board of directors (or similar governing person or  
31 persons) of the entity conducts the majority of its meetings;
- 32 (d) The state in which the executive or management committee of the board of  
33 directors (or similar governing person or persons) of the entity conducts the  
34 majority of its meetings;
- 35 (e) The state from which the management of the overall operations of the entity

1 is directed; and

2 (f) In the case of a benefit plan sponsored by affiliated companies comprising a  
3 consolidated corporation, the state in which the holding company or  
4 controlling affiliate has its principal place of business as determined using the

9 The principal place of business of a plan sponsor of a benefit plan shall be deemed  
10 to be the principal place of business of the association, committee, joint board of

12 maintain the benefit plan that, in lieu of a specific or clear designation of a principal  
13 place of business, shall be deemed to be the principal place of business of the  
14 employer or employee organization that has the largest investment in the benefit  
15 plan in question;

16 (18) "Receivership court," the court in the insolvent or impaired insurer's state having  
17 jurisdiction over the conservation, rehabilitation, or liquidation of the insurer;

18 (19) "Resident," a person to whom a contractual obligation is owed and who resides in  
19 this state on the date of entry of a court order that determines a member insurer  
20 to be an impaired insurer or a court order that determines a member insurer to be  
21 an insolvent insurer. A person may be a resident of only one state, which in the  
22 case of a person other than a natural person shall be its principal place of business.  
23 Citizens of the United States that are either (i) residents of foreign countries, or (ii)  
24 residents of United States possessions, territories, or protectorates that do not have  
25 an association similar to the association created by this chapter, shall be deemed  
26 residents of the state of domicile of the insurer that issued the policies or contracts;

27 (20) "Structured settlement annuity," an annuity purchased in order to fund periodic  
28 payments for a plaintiff or other claimant in payment for or with respect to personal  
29 injury suffered by the plaintiff or other claimant;

30 (21) "State," a state, the District of Columbia, Puerto Rico, and a United States  
31 possession, territory, or protectorate;

32 (22) "Supplemental contact," a written agreement entered into for the distribution of  
33 proceeds under a life, health, or annuity policy or contract;

34 (23) "Unallocated annuity contract," an annuity contract or group annuity certificate  
35 which is not issued to and owned by an individual, except to the extent of any

1 annuity benefits guaranteed to an individual by an insurer under the contract or  
2 certificate.

3 **Section 159.** That § 58-29C-49 be AMENDED:

4 **58-29C-49. Continuation of association--Membership--Function and**  
5 **organization--Accounts--Supervision--Meetings.**

6 A. There is hereby continued the nonprofit legal entity known as the South Dakota  
7 Life and Health Insurance Guaranty Association ~~as created by former § 58-29C-1~~. All  
8 member insurers shall be and remain members of the association as a condition of their  
9 authority to transact insurance in this state. The association shall perform its functions  
10 under the plan of operation established and approved under § 58-29C-53 and shall  
11 exercise its powers through a board of directors established under § 58-29C-50. For  
12 purposes of administration and assessment, the association shall maintain two accounts:

13 (1) The life insurance and annuity account which includes the following subaccounts:

28 disapproved within thirty days.

18 (8) Establish procedures whereby a director may be removed for cause, including in the  
19 case where a member insurer director becomes an impaired or insolvent insurer;

20 (9) Require the board of directors to establish a policy and procedures for addressing  
21 conflicts of interests.

22 D. The plan of operation may provide that any or all powers and duties of the  
23 association, except those under subdivision ~~58-29C-51L(3)~~ 58-29C-51(L)(3) and § 58-  
24 29C-52, are delegated to a corporation, association, or other organization which performs  
25 or will perform functions similar to those of this association, or its equivalent, in two or  
26 more states. Such a corporation, association, or organization shall be reimbursed for any  
27 payments made on behalf of the association and shall be paid for its performance of any  
28 function of the association. A delegation under this subpart shall take effect only with the  
29 approval of both the board of directors and the director, and may be made only to a  
30 corporation, association, or organization which extends protection not substantially less  
31 favorable and effective than that provided by this chapter.

32 **Section 161.** That § 58-29C-56 be AMENDED:

1           **58-29C-56. Member assessment as offset against premium tax liability.**

2           A. A member insurer may offset against its premium tax liability to this state an  
3 assessment described in subpart ~~58-29C-52H-H~~ of § 58-29C-52 to the extent of twenty  
4 percent of the amount of the assessment for each of the five calendar years following the  
5 year in which the assessment was paid. If the assessment is five hundred dollars or less,  
6 the member insurer shall take the total offset in the first year following the year in which  
7 the assessment was paid. However, total assessments offset against premium taxes may  
8 not exceed two million dollars in any year. If offsets exceed the annual limitation in this  
9 section, the excess may be carried forward to a subsequent year in which the annual  
10 limitation has not been exceeded. Any excess shall be apportioned among the contributing  
11 insurers in relation to their assessment that caused the limit to be exceeded. In the event  
12 a member insurer should cease doing business, all uncredited assessments may be  
13 credited against its premium tax liability for the year it ceases doing business.

16 premium taxes as provided in subpart A of this section, shall be paid by the insurers to

27 of the association in carrying out its powers and duties under § 58-29C-51. The records  
28 of the association with respect to an impaired or insolvent insurer may not be disclosed  
29 prior to the termination of a liquidation, rehabilitation, or conservation proceeding  
30 involving the impaired or insolvent insurer, except (i) upon the termination of the  
31 impairment or insolvency of the insurer, or (ii) upon the order of a court of competent  
32 jurisdiction. Nothing in this subpart shall limit the duty of the association to render a report  
33 of its activities under § 58-29C-58.

1 C. For the purpose of carrying out its obligations under this chapter, the association  
2 shall be deemed to be a creditor of the impaired or insolvent insurer to the extent of assets  
3 attributable to covered policies reduced by any amounts to which the association is entitled  
4 as subrogee pursuant to subpart ~~§ 58-29C-51K~~ K of § 58-29C-51. Assets of the impaired  
5 or insolvent insurer attributable to covered policies shall be used to continue all covered  
6 policies and pay all contractual obligations of the impaired or insolvent insurer as required  
7 by this chapter. Assets attributable to covered policies, as used in this subpart, are that  
8 proportion of the assets which the reserves that should have been established for such  
9 policies bear to the reserves that should have been established for all policies of insurance  
10 written by the impaired or insolvent insurer.

11 D. As a creditor of the impaired or insolvent insurer as established in subpart C of this  
12 section and consistent with § 58-29B-98, the association and other similar associations  
13 shall be entitled to receive a disbursement of assets out of the marshaled assets, from  
14 time to time as the assets become available to reimburse it, as a credit against contractual  
15 obligations under this chapter. If the liquidator has not, within one hundred twenty days  
16 of a final determination of insolvency of an insurer by the receivership court, made an  
17 application to the court for the approval of a proposal to disburse assets out of marshaled  
18 assets to guaranty associations having obligations because of the insolvency, then the  
19 association shall be entitled to make application to the receivership court for approval of  
20 its own proposal to disburse these assets.

21 E. (1) Prior to the termination of any liquidation, rehabilitation, or conservation  
22 proceeding, the court may take into consideration the contributions of the respective  
23 parties, including the association, the shareholders, and policy owners of the insolvent  
24 insurer, and any other party with a bona fide interest, in making an equitable distribution  
25 of the ownership rights of the insolvent insurer. In such a determination, consideration  
26 shall be given to the welfare of the policy owners of the continuing or successor insurer.

27 (2) No distribution to stockholders, if any, of an impaired or insolvent insurer shall be  
28 made until and unless the total amount of valid claims of the association with  
29 interest thereon for funds expended in carrying out its powers and duties under  
30 § 58-29C-51 with respect to the insurer have been fully recovered by the  
31 association.

32 F. (1) If an order for liquidation or rehabilitation of an insurer domiciled in this state  
33 has been entered, the receiver appointed under the order has a right to recover on behalf  
34 of the insurer, from any affiliate that controlled it, the amount of distributions, other than  
35 stock dividends paid by the insurer on its capital stock, made at any time during the five



1 years preceding the petition for liquidation or rehabilitation subject to the limitations of  
2 subdivisions (2) to (4), inclusive.

3 (2) No such distribution is recoverable if the insurer shows that when paid the  
4 distribution was lawful and reasonable, and that the insurer did not know and could  
5 not reasonably have known that the distribution might adversely affect the ability  
6 of the insurer to fulfill its contractual obligations.

7 (3) Any person who was an affiliate that controlled the insurer at the time the  
8 distributions were paid is liable up to the amount of distributions received. Any  
9 person who was an affiliate that controlled the insurer at the time the distributions  
10 were declared, shall be liable up to the amount of distributions which would have  
11 been received if they had been paid immediately. If two or more persons are liable  
12 with respect to the same distributions, they shall be jointly and severally liable.

13 (4) The maximum amount recoverable under this subpart shall be the amount needed  
14 in excess of all other available assets of the insolvent insurer to pay the contractual  
15 obligations of the insolvent insurer.

16 (5) If any person liable under subdivision (3) is insolvent, all its affiliates that controlled  
17 it at the time the distribution was paid, shall be jointly and severally liable for any  
18 resulting deficiency in the amount recovered from the insolvent affiliate.

22 The administrator may not pay any claim by withdrawals from a fiduciary account
