1 FOR AN ACT ENTITLED, An Act to provide certain provisions regarding the requirements 2 for postsecondary institutions to participate in a multistate state authorization reciprocity 3 agreement for distance education activities. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA: 5 Section 1. That chapter 13-48 be amended by adding thereto a NEW SECTION to read as 6 follows: 7 The secretary of state and the attorney general shall provide information requested by the 8 Board of Regents in order to carry out administrative, oversight, information sharing, and 9 reporting responsibilities on behalf of South Dakota under the Western Interstate Commission 10 for Higher Education State Authorization Reciprocity Agreement, dated November 1, 2013, and 11 the National Council for State Authorization Reciprocity Agreement's Policies and Standards, 12 dated November 18, 2013. With respect to any postsecondary institution authorized under this 13 chapter that is not controlled by the Board of Regents, the information requested by the Board

14 of Regents from the secretary of state and the attorney general may not exceed that which is



specifically required for a postsecondary institution to receive reciprocal authorizations to
conduct distance education activities in other states under the Western Interstate Commission
for Higher Education State Authorization Reciprocity Agreement, dated November 1, 2013, and
the National Council for State Authorization Reciprocity Agreement's Policies and Standards,
dated November 18, 2013.

6 Section 2. That chapter 13-48 be amended by adding thereto a NEW SECTION to read as7 follows:

8 For the purposes of this chapter, physical location in this state, means the ongoing 9 occupation of a physical location in South Dakota for instructional purposes or the maintenance 10 of an administrative office to facilitate instruction. The following activities do not constitute the 11 use of a physical location in this state: delivering of distance education courses online, through 12 correspondence or broadcast; advertising; recruiting; contractual arrangements to acquire goods 13 or services, including educational or examination proctoring services, with institutions or 14 businesses physically located in South Dakota; courses delivered on military installations by an 15 accredited institution limited to active and reserve military personnel, dependents of military 16 personnel, and civilian employees of the military installation; field trips; operation of a server 17 or other electronic service device; short courses (twenty classroom hours or less, or the 18 equivalent thereof); courses for which fewer than twenty-five percent of class requirements take 19 place in a setting where the instructor and students physically meet together; and experiential 20 learning opportunities, such as a clinical, practicum, residency, or internship, if the offering 21 institution has already obtained all the necessary professional and licensure approvals necessary 22 to conduct the learning opportunity in the state, and that only ten students from each institution 23 are physically present simultaneously at a single field site.
