- Section 146. That chapter 30 of the 2012 Session Laws be amended by adding thereto a
- 14 NEW SECTION to read as follows:
- 15 Section 45. The state treasurer shall transfer to the state general fund one million eight
- hundred thirty-nine thousand nine hundred ninety dollars (\$1,839,990) from the budgetary
- 17 accounting fund.
- Section 147. Funds appropriated by this Act which are unspent at the end of fiscal year
- 19 2013 may be carried over to fiscal year 2014.
- Section 148. This Act is effective June 26, 2013.
