# House Bill 1087

HOUSE COMMERCE AND ENERGY ENGROSSED

#### 1 An Act to prohibit certain restrictive employment contracts.

## 2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 Section 1. That § 53-9-11 be AMENDED:

4 53-9-11. Except as otherwise provided in § 53-9-11.1 and section 4 of this Act, 5 an employee may agree with an employer at the time of employment or at any time during 6 employment not to engage directly or indirectly in the same business or profession as that 7 of the employer for any period not exceeding two years from the date of termination of 8 the agreement and not to solicit existing customers of the employer within a specified 9 county, first- or second-class municipality, or other specified area for any period not 10 exceeding two years from the date of termination of the agreement, if the employer 11 continues to carry on a like business therein.

#### 12 Section 2. That § 53-9-11.1 be AMENDED:

53-9-11.1. A contract that creates or establishes the terms of employment, a
 partnership, or any other form of professional relationship, with a health care provider, <u>as</u>
 <u>defined in section 3 of this Act,</u> may not restrict the right of the health care provider to:

- 16 (1) Practice or provide services for which the provider is licensed, in any geographic
  17 area and for any period of time, after the termination of the employment,
  18 partnership, or other form of professional relationship;
- 19 (2) Treat, advise, consult with, or establish a provider-patient relationship with any
   20 current patient of the employer, or with a patient affiliated with a partnership or
   21 other form of professional relationship; or
- 22 (3) Solicit or seek to establish a provider-patient relationship with any current patient
   23 of the employer, or with a patient affiliated with a partnership or other form of
   24 professional relationship.

1		The prohibition of this section does not apply to a contract in connection with the
2	sale ar	nd purchase of a practice.

## 1 Section 4. That chapter 53-9 be amended with a NEW SECTION:

2	A contract that creates or establishes the terms of employment, a partnership, or
3	any other form of professional relationship, with a social worker licensed in accordance
4	with chapter 36-26, may not restrict the right of the social worker to:
5	(1) Practice or provide services for which the social worker is licensed, in any
6	geographic area and for any period of time, after the termination of the
7	employment, partnership, or other form of professional relationship; or
8	(2) Treat, advise, consult with, or establish a relationship with any current client of the
9	employer, or solicit or seek to establish a relationship with a client affiliated with a
10	partnership or other form of professional relationship.
11	The prohibition of this section does not apply to a contract in connection with the
12	sale and purchase of a practice.
