- 1 FOR AN ACT ENTITLED, An Act to revise the consignment sales requirements for dealers of
- 2 motorcycles, off-road vehicles, snowmobiles, and boats.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That chapter 32-6B be amended by adding a NEW SECTION to read:
- 5 In addition to the consignment sales requirements provided in this chapter, any dealer or
- 6 public auction may sell, or offer to sell, used motorcycles and used off-road vehicles as defined
- 7 in § 32-3-1 on consignment if the dealer has in possession a South Dakota title for the vehicle
- 8 or a state title for the vehicle from a bordering state.
- 9 Section 2. That § 32-7B-26 be amended to read:
- 10 32-7B-26. Any boat dealer or public auction may sell, or offer to sell, new, or used boats on
- 11 consignment. For the purposes of this chapter, consignment means the delivery of a boat by the
- 12 owner into the possession of another without transfer of title for the purpose of sale or where
- 13 there is any condition that the purchaser does not have an absolute obligation to pay for the boat



or has a right to return the boat to the seller. Any boat dealer or public auction who sells, or offers to sell, South Dakota titled boats <u>or used boats titled in a bordering state</u> on consignment shall enter into a contract with the consignor. The department shall prescribe the form of the contract.

5 Section 3. That § 32-7B-28 be amended to read:

32-7B-28. Before a South Dakota titled boat <u>or a used boat titled in a bordering state</u> may
be sold by a consignee or at a public auction pursuant to this chapter, the consignee or
auctioneer shall have in possession a South Dakota title <u>or a state title from a bordering state</u> for
the boat. A violation of this section is a Class 2 misdemeanor.

10 Section 4. That § 32-6C-5.1 be amended to read:

11 32-6C-5.1. Any snowmobile dealer or public auction may sell, or offer to sell, new or used 12 snowmobiles on consignment. For the purposes of this chapter, consignment means the delivery 13 of a snowmobile by the owner into the possession of another without transfer of title for the 14 purpose of sale or where there is any condition that the purchaser does not have an absolute 15 obligation to pay for the snowmobile or has a right to return the snowmobile to the seller. Any 16 snowmobile dealer or public auction who sells, or offers to sell, a South Dakota titled 17 snowmobile or a used snowmobile titled in a bordering state on consignment shall enter into a 18 contract with the consignor. The department shall prescribe the form of the contract.
