- 1 FOR AN ACT ENTITLED, An Act to revise certain provisions regarding the use and display
- 2 of the great seal of South Dakota.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That § 1-6-1 be amended to read:
- 5 1-6-1. There is hereby adopted as the official colored seal of the State of South Dakota, a
- 6 reproduction of the seal, described in article XXI, section 1 of the Constitution of the State of
- 7 South Dakota, and made in conformity therewith but whose with the Constitution. The
- 8 proportions and colored detail are set out specifically in accord with an original painting of the
- 9 great seal produced by John G. Moisan of Fort Pierre and shall be the basis for all reproductions

- of the great seal of the State of South Dakota. Any replica, facsimile, or reproduction of the state
- 2 <u>seal that is greater than one inch in diameter and used for an official purpose or a for-profit</u>
- 3 commercial use shall be a representation of the full and complete seal based upon S.D. Const.,
- 4 Art. XXI, § 1 and this section and shall include the state motto "Under God The People Rule."
- 5 These requirements do not infringe upon or limit any artistic or satirical use of the seal. The
- 6 secretary of state shall conduct an investigation for any violation of this section. If the secretary
- 7 of state confirms that a violation has been committed, the secretary of state shall issue a cease
- 8 and desist letter.
- 9 Section 2. That the code be amended by adding a NEW SECTION to read:
- Any use of the state seal by a state agency after July 1, 2018, shall comply with S.D. Const.,
- Art. XXI, § 1 and §§ 1-6-1 and 1-6-2. Any use of the seal existing prior to that date may
- 12 continue to be used.
