- 1 FOR AN ACT ENTITLED, An Act to require that a doctor provide a woman additional
- 2 information as a part of informed consent prior to performing an abortion.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 34-23A-10.1 be amended to read:

5 34-23A-10.1. No abortion may be performed unless the physician first obtains a voluntary 6 and informed written consent of the pregnant woman upon whom the physician intends to 7 perform the abortion, unless the physician determines that obtaining an informed consent is 8 impossible due to a medical emergency and further determines that delaying in performing the 9 procedure until an informed consent can be obtained from the pregnant woman or her next of 10 kin in accordance with chapter 34-12C is impossible due to the medical emergency, which 11 determinations shall then be documented in the medical records of the patient. A consent to an 12 abortion is not voluntary and informed, unless, in addition to any other information that must

(f) The probable gestational age of the unborn child at the time the abortion is tobe performed, and a scientifically accurate statement describing the

1		development of the unborn child at that age; and
2		(g) The statistically significant medical risks associated with carrying her child to
3		term compared to undergoing an induced abortion; and
4		(h) That even after a pregnant mother takes Mifeprostone it is still possible to
5		discontinue a drug-induced abortion by not taking the prescribed Misoprostol;
6		(i) That information on discontinuing a drug-induced abortion is available on the
7		Department of Health website.
8		The disclosures set forth above shall be provided to the pregnant woman in writing
9		and in person no later than two hours before the procedure is to be performed. The
10		physician shall ensure that the pregnant woman signs each page of the written
11		disclosure with the certification that she has read and understands all of the
12		disclosures, prior to the patient signing a consent for the procedure. If the pregnant
13		woman asks for a clarification or explanation of any particular disclosure, or asks any
14		other question about a matter of significance to her, the explanation or answer shall
15		be made in writing and be given to the pregnant woman before signing a consent for
16		the procedure and shall be made part of the permanent medical record of the patient;
17	(2)	A statement by telephone or in person, by the physician who is to perform the
18		abortion, or by the referring physician, or by an agent of both, at least twenty-four
19		hours before the abortion, providing the following information:
20		(a) That medical assistance benefits may be available for prenatal care, childbirth,
21		and neonatal care;
22		(b) That the father of the unborn child is legally responsible to provide financial
23		support for her child following birth, and that this legal obligation of the father
24		exists in all instances, even in instances in which the father has offered to pay

for the abortion;

2 (c) The name, address, and telephone number of a pregnancy help center in
3 reasonable proximity of the abortion facility where the abortion will be
4 performed; and

5 (d) That she has a right to review all of the material and information described in 6 § 34-23A-1, §§ 34-23A-1.2 to 34-23A-1.7, inclusive, § 34-23A-10.1, and 7 § 34-23A-10.3, as well as the printed materials described in § 34-23A-10.3, 8 and the website described in § 34-23A-10.4. The physician or the physician's 9 agent shall inform the pregnant woman, orally or in writing, that the materials 10 have been provided by the State of South Dakota at no charge to the pregnant 11 woman. If the pregnant woman indicates, at any time, that she wants to review 12 any of the materials described, such disclosures shall be either given to her at 13 least twenty-four hours before the abortion or mailed to her at least seventy-14 two hours before the abortion by certified mail, restricted delivery to 15 addressee, which means the postal employee can only deliver the mail to the 16 addressee;

A written statement that sex-selective abortions are illegal in the State of South
Dakota and that a pregnant mother cannot have an abortion, either solely or partly,
due to the unborn child's sex, regardless of whether that unborn child is a girl or a
boy or whether it is of the pregnant mother's free will or the result of the use of
pressure and coercion.

Prior to the pregnant woman signing a consent to the abortion, she shall sign a written statement that indicates that the requirements of this section have been complied with. Prior to the performance of the abortion, the physician who is to perform the abortion shall receive a

7	34-23A-10.4. The Department of Health shall, by January 1, 2004, develop and maintain a					
8	8 multi-media website that contains web pages covering each of the following topics:					
9	(1)	Embryonic and fetal development at various gestational stages;				
10		(a) Anatomical and physiological characteristics; and				
11		(b) Survival possibilities of the unborn child;				
12	(2)	Abortion methods commonly used for each trimester of pregnancy;				
13	(3)	Statistically significant abortion method risks, including infection, hemorrhage,				
14		danger to subsequent pregnancies, and infertility;				
15	(4)	Important pre-abortion procedures;				
16		(a) Confirmation of pregnancy via sonogram; and				
17		(b) Counseling and discussion of medical history to detect possible abortion risks;
