## 1 FOR AN ACT ENTITLED, An Act to include certain speeding offenses in the point system for

2 traffic violations for the purposes of driver license records.

## 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

- 4 Section 1. That § 32-12-49.1 be amended to read as follows:
- 5 32-12-49.1. The following is <del>a</del> <u>the</u> listing of moving traffic offenses <u>for which points may</u>
- 6 <u>be assessed</u> and the number of points assessed for a conviction for each offense:

7	(1)	Driving while intoxicated	ten points
8	(2)	Reckless driving	eight points
9	(3)	Eluding/attempting to elude a police officer	six points
10	(4)	Drag racing	six points
11	(5)	Failure to yield right-of-way	four points
12	(6)	Improper passing	four points
13	(7)	Driving on wrong side of roadway	four points
14	(8)	Stop sign/light violation	three points

8		<u>(c)</u>	In excess of twenty mph over posted limit	three points			
9	<u>(11)</u>	<u>Spee</u>	ding in school or construction zone	three points

12	Section 2. That § 32-12-49.2 be amended to read as follows:						
13	32-12-49.2. Any motor vehicle operator is subject to driver license or driving privilege						
14	suspension who, in accordance with the schedule provided in § 32-12-49.1, has been convicted						
15	of traffic violations resulting in the accumulation of fifteen twelve points within any twelve						
16	consecutive months, or twenty-two eighteen points within any twenty-four consecutive months.
