1 FOR AN ACT ENTITLED, An Act to revise certain provisions regarding power of attorney.

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 Section 1. That the code be amended by adding a NEW SECTION to read:

4 Terms used in this Act mean:

5 (1) "Agent," a person granted authority to act for a principal under a power of attorney,  
6 whether denominated an agent, attorney-in-fact, or otherwise. The term includes an  
7 original agent, co-agent, successor agent, and a person to whom an agent's authority  
8 is delegated;

9 (2) "Durable," not terminated by the principal's incapacity;

10 (3) "Electronic," relating to technology having electrical, digital, magnetic, wireless,  
11 optical, electromagnetic, or similar capabilities;

12 (4) "Good faith," honesty in fact;

13 (5) "Incapacity," inability of an individual to manage property, business, or financial  
14 affairs because the individual:



- 1 (a) Has an impairment or other deficit in the ability to receive and evaluate
- 2 information or to make or communicate any decision even with the use of
- 3 technological assistance; or
- 4 (b) Is:
  - 5 (i) Missing or has disappeared;
  - 6 (ii) Detained, including incarcerated in a penal system; or
  - 7 (iii) Outside the United States and unable to return;
- 8 (6) "Person," an individual, corporation, business trust, estate, trust, partnership, limited
- 9 liability company, association, joint venture, public corporation, government or
- 10 governmental subdivision, agency or instrumentality, or any other legal or
- 11 commercial entity;
- 12 (7) "Power of attorney," a writing or other record that grants authority to an agent to act
- 13 in the place of the principal, whether or not the term, power of attorney, is used;
- 14 (8) "Presently exercisable general power of appointment," regarding property or an
- 15 interest in property that is subject to a power of appointment, a power to vest absolute
- 16 ownership in a principal individually, a principal's estate, a principal's creditors, or
- 17 the creditors of a principal's estate. The term includes a power of appointment not
- 18 exercisable until the occurrence of a specified event, the satisfaction of an
- 19 ascertainable standard, or the passage of a specified period only after the occurrence
- 20 of the specified event, the satisfaction of the ascertainable standard, or the passage
- 21 of the specified period. The term does not include a power exercisable in a fiduciary
- 22 capacity or only by will;
- 23 (9) "Principal," an individual who grants authority to an agent in a power of attorney;
- 24 (10) "Property," anything that may be the subject of ownership, whether real or personal,

1 legal or equitable, or any interest or right in the subject;

2 (11) "Record," information that is inscribed on a tangible medium or that is stored in an  
3 electronic or other medium and is retrievable in perceivable form;

4 (12) "Sign," with present intent to authenticate or adopt a record:

5 (a) To execute or adopt a tangible symbol; or

6 (b) To attach to or logically associate with the record an electronic sound, symbol,  
7 or process;

8 (13) "State," a state of the United States, the District of Columbia, Puerto Rico, the United  
9 States Virgin Islands, or any territory or insular possession subject to the jurisdiction  
10 of the United States;

11 (14) "Stocks and bonds," stocks, bonds, mutual funds, and any other type of securities and  
12 financial instrument, whether held directly, indirectly, or in any other manner. The  
13 term does not include commodity futures contracts and call or put options on stocks  
14 or stock indexes.

15 Section 2. That the code be amended by adding a NEW SECTION to read:

16 This Act applies to all powers of attorney other than:

17 (1) A power to the extent it is coupled with an interest in the subject of the power,  
18 including a power given to or for the benefit of a creditor in connection with a credit  
19 transaction;

20 (2) A power to make health care decisions;

21 (3) A proxy or other delegation to exercise voting rights or management rights with  
22 respect to an entity; and

23 (4) A power created on a form prescribed by a government or governmental subdivision,  
24 agency, or instrumentality for a governmental purpose.

1 Section 3. That the code be amended by adding a NEW SECTION to read:

2 A power of attorney created under this Act is durable unless it expressly provides that it is  
3 terminated by the incapacity of the principal.

4 Section 4. That the code be amended by adding a NEW SECTION to read:

5 A power of attorney shall be signed by the principal or in the principal's conscious presence  
6 by another individual directed by the principal to sign the principal's name on the power of  
7 attorney. Any signature under this section shall be witnessed by two other adult individuals or  
8 acknowledged before a notary public or other individual authorized by law to take  
9 acknowledgments, or both.

10 Section 5. That the code be amended by adding a NEW SECTION to read:

11 (1) A power of attorney executed in this state on or after July 1, 2018, is valid if its  
12 execution complies with section 4 of this Act.

13 (2) A power of attorney executed in this state before July 1, 2018, is valid if its execution  
14 complied with the law of this state as it existed at the time of execution.

15 (3) A power of attorney executed other than in this state is valid in this state if, when the  
16 power of attorney was executed, the execution complied with:

17 (a) The law of the jurisdiction that determines the meaning and effect of the  
18 power of attorney pursuant to section 6 of this Act; or

19 (b) The requirements for a military power of attorney pursuant to 10 U.S.C.  
20 § 1044(b).

21 (4) Except as otherwise provided by law, a photocopy or electronically transmitted copy  
22 of an original power of attorney has the same effect as the original.

23 Section 6. That the code be amended by adding a NEW SECTION to read:

24 The meaning and effect of a power of attorney is determined by the law of the jurisdiction

1 indicated in the power of attorney and, in the absence of an indication of jurisdiction, by the law  
2 of the jurisdiction in which the power of attorney was executed.

3 Section 7. That the code be amended by adding a NEW SECTION to read:

4 (1) In a power of attorney, a principal may nominate a conservator or guardian for  
5 consideration by the court if protective proceedings for the principal's estate or person  
6 are begun after the principal executes the power of attorney. Except for good cause  
7 shown or disqualification, the court shall make its appointment in accordance with  
8 the principal's most recent nomination. A guardian appointed under this section shall  
9 be subject to the provisions of § 59-7-11.

10 (2) If, after a principal executes a power of attorney, a court appoints a conservator or  
11 other fiduciary charged with the management of some or all of the principal's  
12 property, the power of attorney is terminated and the agent shall account to the  
13 conservator or other court-appointed fiduciary and promptly deliver any property of  
14 the principal in the agent's possession to the conservator or other court-appointed  
15 fiduciary unless otherwise ordered by the court.

16 Section 8. That the code be amended by adding a NEW SECTION to read:

17 (1) A power of attorney is effective when executed unless the principal provides in the  
18 power of attorney that it becomes effective at a future date or upon the occurrence of  
19 a future event or contingency.

20 (2) If a power of attorney becomes effective upon the occurrence of a future event or  
21 contingency, the principal, in the power of attorney, may authorize one or more  
22 persons to determine in a writing or other record that the event or contingency has  
23 occurred.

24 (3) If a power of attorney becomes effective upon the principal's incapacity and the

1 principal has not authorized a person to determine whether the principal is  
2 incapacitated, or the person authorized is unable or unwilling to make the  
3 determination, the power of attorney becomes effective upon a determination in a  
4 writing or other record by:

5 (a) A physician or licensed psychologist that the principal is incapacitated within  
6 the meaning of subsection (5)(a) of section 1 of this Act; or

7 (b) An attorney at law, a judge, or an appropriate governmental official that the  
8 principal is incapacitated within the meaning of subsection (5)(b) of section  
9 1 of this Act.

10 (4) A person authorized by the principal in the power of attorney to determine that the  
11 principal is incapacitated may act as the principal's personal representative pursuant  
12 to the Health Insurance Portability and Accountability Act, Sections 1171 through  
13 1179 of the Social Security Act, 42 U.S.C. § 1320(d), and applicable regulations, to  
14 obtain access to the principal's health care information and communicate with the  
15 principal's health care provider.

16 Section 9. That the code be amended by adding a NEW SECTION to read:

17 (1) A power of attorney terminates when:

18 (a) The principal dies;

19 (b) The principal becomes incapacitated, if the power of attorney is not durable;

20 (c) The principal revokes the power of attorney;

21 (d) The power of attorney provides that it terminates;

22 (e) The purpose of a limited or special power of attorney is accomplished;

23 (f) The principal revokes the agent's authority or the agent dies, becomes  
24 incapacitated, or resigns, and the power of attorney does not provide for

- 1 another agent to act under the power of attorney; or
- 2 (g) Pursuant to subdivision (2) of section 7 of this Act.
- 3 (2) An agent's authority terminates when:
- 4 (a) The principal revokes the authority;
- 5 (b) The agent dies, becomes incapacitated, or resigns;
- 6 (c) An action is filed for divorce or annulment of the agent's marriage to the
- 7 principal, or for their legal separation, unless the power of attorney otherwise
- 8 provides; or
- 9 (d) The power of attorney terminates.
- 10 (3) Unless the power of attorney otherwise provides, an agent's authority is exercisable
- 11 until the authority terminates under subdivision (2) of this section, notwithstanding
- 12 a lapse of time since the execution of the power of attorney.
- 13 (4) Termination of an agent's authority or of a power of attorney is not effective as to the
- 14 agent or any other person that, without actual knowledge of the termination, acts in
- 15 good faith under the power of attorney. An act performed under this section, unless
- 16 otherwise invalid or unenforceable, binds the principal and the principal's successors
- 17 in interest.
- 18 (5) Incapacity of the principal of a power of attorney that is not durable does not revoke
- 19 or terminate the power of attorney as to an agent or other person that, without actual
- 20 knowledge of the incapacity, acts in good faith under the power of attorney. An act
- 21 performed under this section, unless otherwise invalid or unenforceable, binds the
- 22 principal and the principal's successors in interest.
- 23 (6) The execution of a power of attorney does not revoke a power of attorney previously
- 24 executed by the principal unless the subsequent power of attorney provides that the

1 previous power of attorney is revoked or that all other powers of attorney are  
2 revoked.

3 Section 10. That the code be amended by adding a NEW SECTION to read:

4 (1) A principal may designate two or more persons to act as co-agents. Unless the power  
5 of attorney otherwise provides, each co-agent may exercise the co-agent's authority  
6 independently.

7 (2) A principal may designate one or more successor agents to act if an agent resigns,  
8 dies, becomes incapacitated, is not qualified to serve, or declines to serve. A principal  
9 may grant authority to designate one or more successor agents to an agent or other  
10 person designated by name, office, or function. Unless the power of attorney  
11 otherwise provides, a successor agent:

12 (a) Has the same authority granted to the original agent; and

13 (b) May not act until all predecessor agents have resigned, died, become  
14 incapacitated, are no longer qualified to serve, or have declined to serve.

15 (3) Except as otherwise provided in the power of attorney and subdivision (4), an agent  
16 that does not participate in or conceal a breach of fiduciary duty committed by  
17 another agent, including a predecessor agent, is not liable for the actions of the other  
18 agent.

19 (4) An agent that has actual knowledge of a breach or imminent breach of fiduciary duty  
20 by another agent shall notify the principal and, if the principal is incapacitated, take  
21 any action reasonably appropriate in the circumstances to safeguard the principal's  
22 best interest. An agent that fails to notify the principal or take action as required by  
23 this subdivision is liable for any reasonably foreseeable damages that could have  
24 been avoided if the agent had notified the principal or taken any action under this



1 section.

2 Section 11. That the code be amended by adding a NEW SECTION to read:

3 Unless the power of attorney otherwise provides, an agent who is an individual is entitled  
4 to reimbursement of expenses reasonably incurred on behalf of the principal, but not to  
5 compensation. If a power of attorney provides for compensation or if the agent is a bank or trust  
6 company authorized to administer trusts in South Dakota, the compensation shall be reasonable  
7 under the circumstances.

8 Section 12. That the code be amended by adding a NEW SECTION to read:

9 Except as otherwise provided in the power of attorney, a person accepts appointment as an  
10 agent under a power of attorney by exercising authority or performing duties as an agent or by  
11 any other assertion or conduct indicating acceptance.

12 Section 13. That the code be amended by adding a NEW SECTION to read:

13 (1) Notwithstanding provisions in the power of attorney, an agent that has accepted  
14 appointment shall:

15 (a) Act in accordance with the principal's reasonable expectations to the extent  
16 actually known by the agent and otherwise in the principal's best interest;

17 (b) Act in good faith;

18 (c) Act only within the scope of authority granted in the power of attorney; and

19 (d) If feasible, encourage the principal to participate in decisions, to act on the  
20 principal's own behalf, and to develop or regain the capacity to manage the  
21 principal's own affairs, if the principal is incapacitated.

22 (2) Except as otherwise provided in the power of attorney, an agent that has accepted  
23 appointment shall:

24 (a) Act loyally for the principal's benefit;

- 1 (b) Act so as not to create a conflict of interest that impairs the agent's ability to  
2 act impartially in the principal's best interest;
- 3 (c) Act with the care, competence, and diligence ordinarily exercised by agents  
4 in similar circumstances;
- 5 (d) Keep an accurate and contemporaneous record of any receipt, disbursement,  
6 and transaction made on behalf of the principal including any reimbursement  
7 or compensation pursuant to section 11 of this Act;
- 8 (e) Cooperate with a person that has authority to make health care decisions for  
9 the principal to carry out the principal's reasonable expectations to the extent  
10 actually known by the agent and otherwise act in the principal's best interest;  
11 and
- 12 (f) Attempt to preserve the principal's estate plan, to the extent actually known by  
13 the agent, if preserving the plan is consistent with the principal's best interest  
14 based on all relevant factors, including:
  - 15 (i) The value and nature of the principal's property;
  - 16 (ii) The principal's foreseeable obligations and need for maintenance;
  - 17 (iii) Minimization of taxes, including income, estate, inheritance,  
18 generation-skipping transfer, and gift taxes; and
  - 19 (iv) Eligibility for a benefit, a program, or assistance under a statute or  
20 regulation.
- 21 (3) An agent that acts in good faith is not liable to any beneficiary of the principal's estate  
22 plan for failure to preserve the plan.
- 23 (4) An agent that acts with care, competence, and diligence for the best interest of the  
24 principal is not liable solely because the agent also benefits from the act or has an

1 individual or conflicting interest in relation to the property or affairs of the principal.

2 (5) If an agent is selected by the principal because of the agent's special skills or  
3 expertise or in reliance on the agent's representation that the agent has special skills  
4 or expertise, the special skills or expertise shall be considered in determining whether  
5 the agent has acted with care, competence, and diligence under the circumstances.

6 (6) Absent a breach of duty to the principal, an agent is not liable if the value of the  
7 principal's property declines.

8 (7) An agent that exercises authority to delegate to another person the authority granted  
9 by the principal or that engages another person on behalf of the principal is not liable  
10 for an act, error of judgment, or default of that person if the agent exercises care,  
11 competence, and diligence in selecting, instructing, and monitoring the person.

12 (8) Except as otherwise provided in the power of attorney, an agent is not required to  
13 disclose receipts, disbursements, or transactions conducted on behalf of the principal  
14 unless ordered by a court or requested by the principal, a guardian, a conservator,  
15 another fiduciary acting for the principal, a governmental agency having authority to  
16 protect the welfare of the principal, or, upon the death of the principal, by the  
17 personal representative or successor in interest of the principal's estate. The agent  
18 shall comply within thirty days with the request under this section or provide a  
19 writing or other record explaining why additional time is needed and shall comply  
20 with the request under this section within thirty days from the writing or other record.

21 Section 14. That the code be amended by adding a NEW SECTION to read:

22 A provision in a power of attorney relieving an agent of liability for breach of duty is  
23 binding on the principal and the principal's successors in interest except to the extent the  
24 provision:

- 1 (1) Relieves the agent of liability for breach of duty committed dishonestly, with an  
2 improper motive, or with reckless indifference to the purposes of the power of  
3 attorney or the best interest of the principal; or
- 4 (2) Was inserted as a result of an abuse of a confidential or fiduciary relationship with  
5 the principal.

6 Section 15. That the code be amended by adding a NEW SECTION to read:

- 7 (1) In addition to any petition under chapter 21-65, the following persons may petition  
8 a court to construe a power of attorney or review the agent's conduct, and grant  
9 appropriate relief:
  - 10 (a) The principal or the agent;
  - 11 (b) A guardian, conservator, or other fiduciary acting for the principal;
  - 12 (c) A person authorized to make health care decisions for the principal;
  - 13 (d) The principal's spouse, parent, or descendant;
  - 14 (e) An individual who would qualify as a presumptive heir of the principal;
  - 15 (f) A person named as a beneficiary to receive any property, benefit, or  
16 contractual right on the principal's death or as a beneficiary of a trust created  
17 by or for the principal that has a financial interest in the principal's estate;
  - 18 (g) A governmental agency having regulatory authority to protect the welfare of  
19 the principal;
  - 20 (h) The principal's caregiver or another person that demonstrates sufficient interest  
21 in the principal's welfare; and
  - 22 (i) A person asked to accept the power of attorney.
- 23 (2) Upon motion by the principal, the court shall dismiss a petition filed under this  
24 section, unless the court finds that the principal lacks capacity to revoke the agent's

1 authority or the power of attorney.

2 Section 16. That the code be amended by adding a NEW SECTION to read:

3 An agent that violates the provisions of this Act is liable to the principal or the principal's  
4 successors in interest for the amount required to:

5 (1) Restore the value of the principal's property to its value had the violation not  
6 occurred; and

7 (2) Reimburse the principal or the principal's successors in interest for any attorney's fees  
8 and costs paid on the agent's behalf.

9 Section 17. That the code be amended by adding a NEW SECTION to read:

10 Unless otherwise provided in the power of attorney, an agent may resign by giving notice  
11 to the principal and, if the principal is incapacitated, to the guardian, if any, and any co-agent  
12 or successor agent, or to:

13 (1) The principal's caregiver; or

14 (2) If there is no principal caregiver, to:

15 (a) Another person reasonably believed by the agent to have sufficient interest in  
16 the principal's welfare; or

17 (b) A governmental agency having authority to protect the welfare of the  
18 principal.

19 Section 18. That the code be amended by adding a NEW SECTION to read:

20 (1) For purposes of this section and section 19 of this Act, the term, South Dakota  
21 compliant, means a power of attorney signed by the principal and substantially in the  
22 form provided in section 41 of this Act and witnessed by two or more other adult  
23 individuals, or purportedly verified before a notary public or other individual  
24 authorized to take acknowledgements, or both.

- 1 (2) A person that in good faith accepts a South Dakota compliant power of attorney  
2 without actual knowledge that the signature is not genuine may rely upon a  
3 presumption that the signature is genuine.
- 4 (3) A person that in good faith accepts a South Dakota compliant power of attorney  
5 without actual knowledge that the power of attorney is void, invalid, or terminated;  
6 that the purported agent's authority is void, invalid, or terminated; or that the agent  
7 is exceeding or improperly exercising the agent's authority may rely upon the power  
8 of attorney as if the power of attorney were genuine, valid, and still in effect; the  
9 agent's authority were genuine, valid, and still in effect; and the agent had not  
10 exceeded and had properly exercised the authority.
- 11 (4) A person that is asked to accept a South Dakota compliant power of attorney may  
12 request, and rely upon, without further investigation:
- 13 (a) An agent's certification under penalty of perjury of any factual matter  
14 concerning the principal, agent, or power of attorney;
- 15 (b) An English translation of the power of attorney if the power of attorney  
16 contains, in whole or in part, language other than English; and
- 17 (c) An opinion of counsel as to any matter of law concerning the power of  
18 attorney if the person making the request provides in a writing or other record  
19 the reason for the request.
- 20 (5) An English translation or an opinion of counsel requested under this section shall be  
21 provided at the principal's expense unless the request is made more than seven  
22 business days after the power of attorney is presented for acceptance.
- 23 (6) For purposes of this section and section 19 of this Act, a person that conducts  
24 activities through employees is without actual knowledge of a fact relating to a power

1 of attorney, a principal, or an agent if the employee conducting the transaction  
2 involving the power of attorney is without actual knowledge of the fact.

3 Section 19. That the code be amended by adding a NEW SECTION to read:

4 (1) A person shall accept a South Dakota compliant power of attorney or request a  
5 certification, a translation, or an opinion of counsel under subdivision (4) of section  
6 18 of this Act no later than seven business days after presentation of the power of  
7 attorney for acceptance. If a person requests a certification, a translation, or an  
8 opinion of counsel under subdivision (4) of section 18 of this Act, the person shall  
9 accept the power of attorney no later than five business days after receipt of the  
10 certification, translation, or opinion of counsel. A person may not require an  
11 additional or different form of power of attorney for authority granted in the power  
12 of attorney presented.

13 (2) A person is not required to accept a South Dakota compliant power of attorney if:  
14 (a) The person is not otherwise required to engage in a transaction with the  
15 principal in the same circumstances;  
16 (b) Engaging in a transaction with the agent or the principal in the same  
17 circumstances would be inconsistent with federal law;  
18 (c) The person has actual knowledge of the termination of the agent's authority or  
19 of the power of attorney before exercise of the power;  
20 (d) A request for a certification, a translation, or an opinion of counsel under  
21 subdivision (4) of section 18 of this Act is refused;  
22 (e) The person in good faith believes that the power is not valid or that the agent  
23 does not have the authority to perform the act requested, whether or not a  
24 certification, a translation, or an opinion of counsel under subdivision (4) of

1 section 18 of this Act has been requested or provided; or

2 (f) The person makes, or has actual knowledge that another person has made, a  
3 report to the South Dakota Department of Social Services or an office of a  
4 state's attorney stating a good faith belief that the principal may be subject to  
5 physical or financial abuse, neglect, exploitation, or abandonment by the agent  
6 or a person acting for or with the agent.

7 (3) A person that refuses in violation of this section to accept a South Dakota compliant  
8 power of attorney is subject to:

9 (a) A court order mandating acceptance of the power of attorney; and

10 (b) Liability for reasonable attorney's fees and costs incurred in any action or  
11 proceeding that confirms the validity of the power of attorney or mandates  
12 acceptance of the power of attorney.

13 Section 20. That the code be amended by adding a NEW SECTION to read:

14 Unless otherwise required under this Act, the principles of law and equity apply to the  
15 provisions of this Act.

16 Section 21. That the code be amended by adding a NEW SECTION to read:

17 Nothing in this Act may be interpreted to amend or supersede any other law applicable to  
18 financial institutions or other entities.

19 Section 22. That the code be amended by adding a NEW SECTION to read:

20 The remedies under this Act are not exclusive and do not abrogate any right or remedy under  
21 the laws of this state.

22 Section 23. That the code be amended by adding a NEW SECTION to read:

23 (1) An agent under a power of attorney may do the following on behalf of the principal  
24 or with the principal's property only if the power of attorney expressly grants the



1 agent the authority and exercise of the authority is not otherwise prohibited by  
2 another agreement or instrument to which the authority or property is subject:

- 3 (a) Create, amend, revoke, or terminate an inter vivos trust;
- 4 (b) Make a gift;
- 5 (c) Create or change rights of survivorship;
- 6 (d) Create or change a beneficiary designation;
- 7 (e) Delegate authority granted under the power of attorney;
- 8 (f) Waive the principal's right to be a beneficiary of a joint and survivor annuity,  
9 including a survivor benefit under a retirement plan;
- 10 (g) Exercise fiduciary powers that the principal has authority to delegate;
- 11 (h) Exercise authority over the content of electronic communications, as defined  
12 in 18 U.S.C. § 2510(12) and as provided under chapter 55-19, which are sent  
13 or received by the principal; or
- 14 (i) Disclaim property, including a power of appointment.

15 (2) Notwithstanding a grant of authority to do an act described in subdivision (1), unless  
16 the power of attorney otherwise provides, an agent that is not an ancestor, spouse, or  
17 descendant of the principal, may not exercise authority under a power of attorney to  
18 create in the agent, or in an individual to whom the agent owes a legal obligation of  
19 support, an interest in the principal's property, whether by gift, right of survivorship,  
20 beneficiary designation, disclaimer, or otherwise.

21 (3) Subject to subdivisions (1), (2), (4), and (5) of this section, if a power of attorney  
22 grants to an agent authority to do all acts that a principal could do, the agent has the  
23 general authority described in sections 26 to 38 of this Act, inclusive.

24 (4) Unless otherwise provided by the power of attorney, a grant of authority to make a

1 gift is subject to section 39 of this Act.

2 (5) Subject to subdivisions (1), (2), and (4) of this section, if the subjects over which  
3 authority is granted in a power of attorney are similar or overlap, the broadest  
4 authority controls.

5 (6) Authority granted in a power of attorney is exercisable with respect to property that
