- 1 FOR AN ACT ENTITLED, An Act to provide procedures by which adopted persons may obtain
- 2 their original birth certificates and the contact preference of birth parents.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That § 34-25-16.4 be amended to read as follows:
- 5 34-25-16.4. When a new certificate of birth is established pursuant to §§ 34-25-15 to 34-25-
- 6 16.2, inclusive, the original certificate of birth together with the adoption information or other
- 7 evidence upon which a new certificate is made shall be sealed, filed, and may be opened only
- 8 upon order of a court of competent jurisdiction, or by the secretary of health for purposes of
- 9 properly administering the vital registration system or for purposes of complying with section
- 10 2 of this Act.
- 11 Section 2. That chapter 34-25 be amended by adding thereto a NEW SECTION to read as
- 12 follows:
- Any adopted person who is at least eighteen years of age and who was born in this state,
- such adopted person's attorney, or if such adopted person is deceased, any descendant of such

adopted person may obtain a copy of that person's original certificate of birth from the

- 2 Department of Health. The adopted person shall file a written application with, and provide
- 3 appropriate proof of identification to, the department. Upon receipt of the written application
- 4 and proof of identification, the department shall issue a noncertified copy of the unaltered
- 5 original certificate of birth to the applicant. The department may charge the same fee as
- 6 provided pursuant to § 34-25-52.
- 7 Section 3. That chapter 34-25 be amended by adding thereto a NEW SECTION to read as
- 8 follows:
- 9 The Department of Health shall develop a contact preference form on which a birth parent
- may state a preference regarding contact by an adopted person. The form shall contain the
- following statements from which the birth parent may choose only one:
- 12 (1) "I would like to be contacted. I have completed this contact preference form and am
- filing it with the Department of Health."
- 14 (2) "I would prefer to be contacted only through an intermediary. I have completed this
- 15 contact preference form and am filing it with the Department of Health."
- 16 (3) "Do not contact me. I may change this preference by filling out another contact
- preference form. I have completed this contact preference form and am filing it with
- the Department of Health."
- 19 Upon receipt of a completed contact preference form, the Department of Health shall attach
- 20 the completed form to the original birth certificate of the adopted person. A completed contact
- 21 preference form has the same level of confidentiality as the original birth certificate. The
- Department of Health shall promulgate rules, pursuant to chapter 1-26, for the administration
- 23 of this section.
