- 1 FOR AN ACT ENTITLED, An Act to provide for revised dates to prefile legislation.
- 2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 3 Section 1. That § 2-7-4 be amended to read:
- 4 2-7-4. Any person who has been duly elected or appointed to serve during a regular session
- 5 of the Legislature may file no more than ten bills and resolutions with the State Legislative
- 6 Research Council at any time ~~within thirty days~~ beginning the day after the completion of the
- 7 official canvass by the State Canvassing Board during an election year prior to the convening
- 8 of ~~such~~ the following regular session or at any time beginning the first day of July during an
- 9 odd-numbered year prior to the convening of the following regular session. Notwithstanding the



1 provisions of § 2-7-6.1, any interim committee of the Legislative Research Council may file  
2 bills and resolutions under the provisions of this section. The Executive Board of the State  
3 Legislative Research Council shall prescribe rules for the handling and placing in proper form  
4 of such bills and resolutions, subject to the provisions of §§ 2-7-4 to 2-7-6, inclusive.
