## HOUSE BILL NO. 1307

1 FOR AN ACT ENTITLED, An Act to appropriate money for the ordinary expenses of the

- 2 legislative, judicial, and executive departments of the state, the expenses of state institutions,
- 3 interest on the public debt, and for common schools.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 Section 1. There is hereby appropriated out of any money in the state treasury not otherwise

6 appropriated the following sums of money or expenditure authority, or so much thereof as may

7 be necessary, for the ordinary expenses of the legislative, judicial, and executive departments

8 of the state, certain officers, boards, and commissions, and support and maintenance of the

9 educational, charitable, and penal institutions of the state for the fiscal year ending June 30,

10 2019.
