## House Bill 1337

## **HOUSE EDUCATION ENGROSSED**

Introduced by: Representative Stevens at the request of the Office of the Governor

- 1 An Act to to protect elementary and secondary students from political indoctrination.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That chapter 13-1 be amended with a NEW SECTION:
- 5 For the purposes of this Act, a divisive concept is any of the following: (1) 6 That any race, color, religion, sex, ethnicity, or national origin is inherently superior 7 or inferior; 8 (2) That individuals should be discriminated against or adversely treated on the basis of race, color, religion, sex, ethnicity, or national origin; 9 That an individual's moral character is inherently determined on the basis of race, 10 (3) color, religion, sex, ethnicity, or national origin; 11
  - (4) That an individual, by virtue of the individual's race, color, religion, sex, ethnicity, or national origin, is inherently racist, sexist, or oppressive, whether consciously or subconsciously;
  - (5) That individuals, by virtue of race, color, religion, sex, ethnicity, or national origin, are inherently responsible for actions committed in the past by other members of the same race, color, religion, sex, ethnicity, or national origin;
- 18 (6) An individual should feel discomfort, guilt, anguish, or any other form of
  19 psychological distress on account of the individual's race, color, religion, ethnicity
  20 or national origin;
- 21 (7) Meritocracy or traits such as a hard work ethic are racist or sexist, or were created
  22 by members of a particular race or sex to oppress members of another race or sex;

- 24 (8) With respect to their relationship to American values, slavery and racism are anything other than deviations from, betrayals of, or failures to live up to America's

founding principles of liberty and equality, as stated in the Declaration of 1 2 Independence. 3 Section 2. That chapter 13-1 be amended with a NEW SECTION: 4 A state agency or public school district may not allow any curricula, instruction, 5 standards, or training that promotes a divisive concept, or which directs or compels 6 students or employees to personally affirm, adopt, or adhere to a divisive concept. 7 Nothing in this section prohibits a school district employee from: 8 (1) Discussing, as part of a larger course of academic instruction, a divisive concept in 9 an objective manner and without endorsement; or 10 (2) Permitting or presiding over student debate, regarding a divisive concept, in an 11 objective manner and without endorsement. 12 Section 3. That chapter 13-1 be amended with a NEW SECTION: 13 A state agency, school board, school district, or public school may not authorize or 14 expend any money for any purpose prohibited in this Act. 15 Section 4. That chapter 13-1 be amended with a NEW SECTION: 16 Nothing in sections 2 and 3 of this Act applies to a nonpublic school or an employee of a nonpublic school. 17 18 For purposes of this Act, the term, state agency, does not include the Board of 19 Regents, the South Dakota Board of Technical Education, or any institution under their
