2	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:			
3	Section 1. That chapter 41-6 be amended by adding thereto a NEW SECTION to read as			
4	follows:			
5	No license to take fur-bearing animals may be issued to any nonresident unless the			
6	nonresident resides in a state that allows nonresidents of that state, including South Dakota			
7	residents, to take fur-bearing animals within that state.			
8	Section 2. That § 41-6-10 be amended to read as follows:			
9	41-6-10. Licenses, permits, and stamps issued under this title are classified as follows:			
10	(1)	Disabled hunter permit;		
11	(2)	Export bait dealer license;		
12	(2A)	Fall three-day temporary nonresident waterfowl license;
