1 FOR AN ACT ENTITLED, An Act to increase state aid to education and revise certain
2 provisions related to education funding.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That subdivision (4) of 13-13-10.1 be amended to read as follows:

5 (4) "Per student allocation," for school fiscal year ~~2012 is \$4,389.95~~ 2014 is \$4,626.65.

6 Each school fiscal year thereafter, the per student allocation is the previous fiscal
7 year's per student allocation increased by the index factor;

8 Section 2. That § 13-13-72 be amended to read as follows:

9 13-13-72. It is the policy of the Legislature that the appropriation for the state aid to
10 education foundation program increase on an annual basis by the percentage increase in local



1 need on an aggregate statewide basis so that the relative proportion of local need paid by local
2 effort and state aid shall remain constant. ~~For school fiscal year 2013, it is the policy of the~~
3 ~~Legislature that the relative proportion of the total local need paid by state aid shall be amended~~
4 ~~by adjusting the proportion of state aid to fifty-three and eight-tenths percent of the total local~~
5 ~~need.~~ However, the increase in the per student allocation on an annual basis that exceeds three
6 percent shall be paid solely by the state and is not a factor in this policy.
