AN ACT

ENTITLED, An Act to appropriate money for the ordinary expenses of the legislative, judicial, and executive departments of the state, the expenses of state institutions, interest on the public debt, and for common schools.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

Section 1. There is hereby appropriated out of any money in the state treasury not otherwise appropriated the following sums of money or expenditure authority, or so much thereof as may be necessary, for the ordinary expenses of the legislative, judicial, and executive departments of the state, certain officers, boards, and commissions, and support and maintenance of the educational, charitable, and penal institutions of the state for the fiscal year ending June 30, 2011.

Section 28. The state treasurer shall transfer to the state general fund one million five hundred thousand dollars (\$1,500,000), from the tobacco prevention and reduction trust fund.

Section 29. The state treasurer shall transfer to the state general fund twelve million dollars

(\$12,000,000) from the dakota cement trust fund.

Section 30. The state treasurer shall transfer to the state general fund money from the health care trust fund, the amount identified by notice of the state investment officer pursuant to § 4-5-29.1, for the Department of Social Services - medical services.

Section 31. The state treasurer shall transfer to the state general fund money from the education enhancement trust fund, the amount identified by notice of the state investment officer pursuant to § 4-5-29.2, for the Department of Education - state aid to education and technology in schools.

Section 32. The state treasurer shall transfer to the state general fund all moneys available from the health care tobacco tax fund created by § 4-5-46, for the Department of Social Services - medical services.

Section 33. The state treasurer shall transfer to the state general fund all moneys available from the education enhancement tobacco tax fund created by § 4-5-45, for the Department of Education state aid to education and technology in schools.

Section 34. The state treasurer shall transfer to the state general fund the principal amount of three million eight hundred fifty-five thousand seven hundred sixty-seven dollars (\$3,855,767) plus interest from the Custer State Park improvement fund which completes repayment of the appropriation from chapter 35 of the 2007 Session Laws. The interest shall be calculated based on the earnings of the cash flow fund.

Section 35. The state treasurer shall transfer to the state general fund two hundred ninety-two thousand eight hundred sixty-one dollars (\$292,861) from the other disease control fund.

Section 36. The state treasurer shall transfer to the South Dakota Science and Technology Authority one million five hundred thousand dollars (\$1,500,000) from the state aeronautics fund established in § 50-4-8.

Section 37. The state treasurer shall transfer to the South Dakota Science and Technology

Authority one million dollars (\$1,000,000) from the tax relief fund established in § 10-45C-14.

Section 38. The state treasurer shall transfer to the South Dakota Science and Technology Authority two million dollars (\$2,000,000) from the petroleum release compensation fund established in § 34A-13-18.

Section 39. The state treasurer shall transfer to the South Dakota Science and Technology Authority four hundred thousand dollars (\$400,000) from the private activity bond fees fund established in § 1-7-10.

Section 40. The state treasurer shall transfer to the South Dakota Science and Technology Authority five hundred thousand dollars (\$500,000) from the telecommunications fund for the deaf and the telecommunications fund for other disabilities established in § 49-31-50.

Section 41. Notwithstanding the provisions of § 10-45C-14, the state treasurer shall transfer to the state general fund one million seventeen thousand nine hundred seventy-nine dollars (\$1,017,979), or so much thereof as may be necessary, from the tax relief fund created pursuant to § 10-45C-14.

Section 42. The state treasurer shall transfer to the state general fund one million dollars (\$1,000,000), or so much thereof as may be necessary, from the petroleum release compensation fund.

Section 43. The state treasurer shall transfer to the state general fund six hundred ninety-eight thousand three hundred thirty-one dollars (\$698,331), or so much thereof as may be necessary, from the private activity bond fees fund.

Section 44. The state treasurer shall transfer to the state general fund six hundred fifty thousand dollars (\$650,000), or so much thereof as may be necessary, from the Department of Corrections local and endowment funds.

Section 45. The state treasurer shall transfer to the state general fund three hundred ten thousand

four hundred eighty-seven dollars (\$310,487), or so much thereof as may be necessary, from the budgetary accounting fund.

Section 46. All members of state boards, councils, commissions, and advisory bodies listed in this section, or created by law during the Eighty-fifth and Eighty-sixth Legislative Sessions, are entitled to reimbursement for allowable expenses as approved by the Board of Finance under the provisions of chapter 3-9. The salary or per diem compensation for members of state boards, councils, commissions, and advisory bodies for their work in actual performance of their duties or responsibilities is as follows:
