1 FOR AN ACT ENTITLED, An Act to revise certain provisions concerning campaign finance.

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 Section 1. That § 12-27-16 be amended to read as follows:

4 12-27-16. The following apply to independent expenditures by individuals and organizations
5 related to communications advocating for or against candidates, public office holders, ballot
6 questions, or political parties, ~~and expenditures by individuals and organizations within sixty~~
7 ~~days of an election that clearly identify a candidate or public office holder but do not expressly~~
8 ~~advocate the election of the candidate or public office holder:~~

9 (1) Any person or organization that makes an independent expenditure of one hundred
10 dollars or more for a communication which expressly advocates for or against a
11 candidate, public office holder, ballot question, or political party, ~~regardless of the~~
12 ~~amount of the expenditure~~, shall append to or include in each communication a
13 disclaimer that clearly and forthrightly:



1 (a) Identifies the person or organization making the independent expenditure for
2 that communication;

3 (b) States the address or website address of the person or organization; and

4 (c) States that the communication is independently funded and not made in
5 consultation with any candidate, political party, or political committee.

6 A violation of this subdivision is a Class 1 misdemeanor;

7 ~~(2) Any person or organization that makes an expenditure, including the payment of
8 money or exchange of other valuable consideration or promise, for a communication
9 that clearly identifies a candidate or public office holder, but does not expressly
10 advocate the election or defeat of the candidate or public office holder, and that is
11 disseminated, broadcast, or otherwise published within sixty days of an election shall
12 append to or include in the communication a disclaimer that clearly and forthrightly:~~

13 ~~———— (a) Identifies the person or organization making the expenditure for that
14 communication; and~~

15 ~~———— (b) States the address or website address of the person or organization.~~

16 ~~———— A violation of this subdivision is a Class 1 misdemeanor;~~

17 ~~— (3) — Any person or organization which is not a recognized business entity and which
18 makes an independent expenditure of one hundred dollars or more for a
19 communication described in subdivision (1) ~~or (2)~~ shall file a statement within forty-
20 eight hours of the time that the communication is disseminated, broadcast, or
21 otherwise published;~~

22 ~~— (4) — Any person or recognized business entity that makes expenditures in excess of two
23 thousand dollars during any calendar year for communications described in
24 subdivision (1) or (2) shall file a statement with the secretary of state that is received~~

1 ~~within forty-eight hours of the time that the person's or organization's expenditures~~
2 ~~exceed two thousand dollars, and thereafter, within forty-eight hours of the time that~~
3 ~~any such subsequent communication is disseminated, broadcast, or otherwise~~
4 ~~published during the remainder of that calendar year;~~

5 ~~(5)~~(3) The statements required by this section shall include the name, street address, city,
6 and state of the person or organization and, ~~for~~ any expenditures made for
7 communications described in subdivision (1) ~~or (2)~~ during that calendar year but not
8 yet reported on a prior statement, the name of each candidate, public office holder,
9 ballot question, or political party mentioned or identified in each communication, the
10 amount spent on each communication, and a description of the content of each
11 communication.

12 For an organization, the statement shall also include the name and title of the person
13 filing the report, the name of its chief executive, if any, and the name of the person
14 who authorized the expenditures on behalf of the organization;

15 ~~(6)~~(4) For an organization whose majority ownership is owned by, controlled by, held for
16 the benefit of, or comprised of twenty or fewer persons, partners, owners, trustees,
17 beneficiaries, participants, members, or shareholders, the statement shall identify by
18 name and address each person, partner, owner, trustee, beneficiary, participant,
19 shareholder, or member who owns, controls, or comprises ten percent or more of the
20 organization;

21 ~~(7)~~(5) An organization shall also provide supplemental statements, as defined in subdivision
22 ~~(5)~~(3), for any of its partners, owners, trustees, beneficiaries, participants, members,
23 or shareholders identified pursuant to subdivision ~~(6)~~ (4) which are owned by,
24 controlled by, held for the benefit of, or comprised of twenty or fewer persons,

1 partners, owners, trustees, beneficiaries, participants, members, or shareholders, until
 2 no organization identified in the supplemental statements meets the ownership test
 3 set forth in subdivision ~~(6)~~ (4);

4 ~~(8)~~(6) For the purposes of this section, the term, communication, does not include:

5 (a) Any news articles, editorial endorsements, opinion, or commentary writings,
 6 or letter to the editor printed in a newspaper, magazine, flyer, pamphlet, or
 7 other periodical not owned or controlled by a candidate, political committee,
 8 or political party;

9 (b) Any editorial endorsements or opinions aired by a broadcast facility not owned
 10 or controlled by a candidate, political committee, or political party;

11 (c) Any communication by a person made in the regular course and scope of the
 12 person's business or ministry or any communication made by a membership
 13 organization solely to members of the organization and the members' families;
 14 and

15 (d) Any communication that refers to any candidate only as part of the popular
 16 name of a bill or statute.

17 Section 2. That § 12-27-17 be amended to read as follows:

18 12-27-17. Any political committee, organization, person, or political party that makes a
 19 payment or promise of payment totaling one ~~thousand~~ hundred dollars or more for a
 20 communication that clearly identifies a candidate or public office holder, but does not expressly
 21 advocate the election or defeat of the candidate or public office holder, and that is disseminated,
 22 broadcast, or otherwise published ~~within sixty days of an election,~~ shall file a statement with the
 23 secretary of state disclosing the name, street address, city, and state of such political committee,
 24 organization, person, or political party. The statement shall also include the name of the

1 candidate or public office holder mentioned in the communication, the amount spent on the
2 communication, and a description of the content of the communication. The statement shall be
3 received and filed within forty-eight hours of the time that the communication is disseminated,
4 broadcast, or otherwise published.

5 For the purposes of this section, the term, communication, does not include:

- 6 (1) Any news articles, editorial endorsements, opinion or commentary writings, or letter
7 to the editor printed in a newspaper, magazine, flyer, pamphlet, or other periodical
8 not owned or controlled by a candidate, political committee, or political party;
- 9 (2) Any editorial endorsements or opinions aired by a broadcast facility not owned or
10 controlled by a candidate, political committee, or political party;
- 11 (3) Any communication by a person made in the regular course and scope of the person's
12 business or ministry or any communication made by a membership organization
13 solely to members of the organization and the members' families; and
- 14 (4) Any communication that refers to any candidate only as part of the popular name of
15 a bill or statute.

16 Section 3. That chapter 12-27 be amended by adding thereto a NEW SECTION to read as
17 follows:

18 Any political committee, organization, person, or political party that makes a
19 communication as defined in § 12-27-17, which does not expressly advocate for or against a
20 candidate, public office holder, ballot question, or political party, shall append to or include in
21 each communication a disclaimer that:

- 22 (1) Identifies the political committee, organization, person, or political party making the
23 communication; and
- 24 (2) States the address or website address of the political committee, organization, person,

1 or political party.

2 If the communication is an independent expenditure made by a person or organization, then
3 the disclaimer shall include the following: "This communication is independently funded and
4 not made in consultation with any candidate, political party, or political committee."

5 Section 4. That § 12-27-3 be amended to read as follows:

6 12-27-3. The treasurer for a political action committee shall file a statement of organization
7 with the secretary of state not later than fifteen days after the date upon which the committee
8 made contributions, received contributions, or paid expenses in excess of five hundred dollars.
9 However, if such activity falls within thirty days of any statewide election, the statement of
10 organization shall be filed within forty-eight hours. A candidate shall file a statement of
11 organization for a candidate campaign committee with the secretary of state not later than fifteen
12 days after becoming a candidate pursuant to this chapter. ~~Notwithstanding the provisions of~~
13 ~~§ 12-27-41, the statement of organization shall include the original signature of each person~~
14 ~~filing the statement.~~ The statement or organization may be filed electronically pursuant to § 12-
15 27-41. A political committee that regularly files a campaign finance disclosure statement with
16 another state or the Federal Election Commission or a report of contributions and expenditures
17 with the Internal Revenue Service is not required to file a statement of organization. A violation
18 of this section is a Class 2 misdemeanor.

19 Section 5. That § 12-27-6 be amended to read as follows:

20 12-27-6. The statement of organization shall include:

- 21 (1) The name, street address, postal address, and daytime telephone number of the
22 committee;
- 23 (2) The name, street address, postal address, and daytime telephone number of the chair
24 and the treasurer of the committee;

- 1 (3) A statement of the type of political committee that has been or is being organized;
- 2 (4) In the case of a candidate campaign committee, the name, street address, and postal
3 address of the candidate;
- 4 (5) In the case of a political action committee or ballot question committee, a concise
5 statement of its purpose and goals, and the full name, street address, and postal
6 address of the organization with which the committee is connected or affiliated, or
7 if the committee is not connected or affiliated with any one organization, the trade,
8 profession, or primary interest of the committee;
- 9 (6) If the committee is organized as a corporation under federal or state laws for liability
10 purposes only as authorized by § 12-27-4, a statement affirming such organization;
11 and
- 12 (7) The name, street address, postal address, and telephone number of each financial
13 institution where an account or depository is maintained.

14 The statement shall be signed by the candidate and treasurer for a candidate campaign
15 committee and by the chair and treasurer for other political committees or filed electronically
16 pursuant to § 12-27-41. A political committee continues to exist until a termination statement
17 is filed pursuant to §§ 12-27-25 and 12-27-26.

18 The treasurer of a political committee shall file an updated statement of organization not
19 later than fifteen days after any change in the information contained on the most recently filed
20 statement of organization.
