# Senate Bill 40

HOUSE COMMERCE AND ENERGY ENGROSSED

This bill has been extensively amended (hoghoused) and may no longer be consistent with the original intention of the sponsor.

Introduced by: The Committee on Commerce and Energy at the request of the South Dakota Public Utilities Commission

#### 1 An Act to to establish safety standards regarding biogas gathering lines.

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

### 3 Section 1. That a NEW SECTION be added to title 49:

- 4 <u>Terms used in this chapter mean:</u>
- 5 (1) "Biogas gathering line," new and existing gathering pipeline facilities in South
- 6 <u>Dakota that transport gas from a bio-methane producer to an interstate or</u> 7 <u>intrastate gas pipeline;</u>
- 8 (2) "Commission," the Public Utilities Commission;
- 9 <u>(3)</u> "Gas," natural gas, liquefied natural gas, flammable gas, gas which is toxic or 10 <u>corrosive, or liquefied petroleum gas in distribution systems.</u>

#### 11 Section 2. That a NEW SECTION be added to title 49:

- 12 <u>Any person who operates an intrastate biogas gathering line shall prior to operation</u>
- 13 provide written notice of the location and existence of the biogas gathering line to:
- 14 (1) Any county and township where the biogas gathering line is located;
- 15 (2) The county emergency management office or county equivalent in those counties;
- 16 (3) Any fire department or ambulance service located within ten miles of the biogas
  17 gathering line;
- 18 (4) South Dakota One-Call;
- 19 <u>(5) The Commission;</u>
- 20 (6) All landowners of record who own land within six hundred and sixty feet of the
  21 biogas gathering line.
- 22 <u>All notices must warn of the hazards and dangers associated with the biogas</u>
- 23 gathering line and its contents.

#### 24 Section 3. That a NEW SECTION be added to title 49:

1 Any person who operates a biogas gathering line on an easement or in public right 2 of way must place and maintain signage marking the biogas gathering line for the life of 3 the biogas gathering line. Signage must be in the rights-of-way and placed at all public 4 road crossings and railroad crossings and in sufficient numbers so that the biogas 5 gathering line location is accurately and easily known. Signage must prominently display 6 the operator's name, a twenty-four-hour emergency telephone number for the operator, 7 the word, warning, or danger, and the phrase, biogas pipeline. Prior to commencement of 8 operation, the operator shall certify to the Commission that the operator has completed 9 the requirements of this chapter.

- 10 Section 4. That a NEW SECTION be added to title 49:
- 11 If the Commission finds, after notice and opportunity for hearing, that a person 12 has failed to comply with any requirement of this chapter, the Commission may suspend 13 or restrict the operation of the pipeline and may order the person to comply with this 14 chapter. The Commission may issue a temporary exparte order to suspend or restrict operation if the Commission determines a likelihood of immediate serious harm to life, 15 16 health, environment, or property exists. The operator has the right of appeal from such 17 decisions as provided by chapter 1-26. The Commission may apply to the circuit court in 18 any county in which the biogas gathering line operates for orders that enjoin operation.

## 19 Section 5. That a NEW SECTION be added to title 49:

Any person who operates a biogas gathering line other than in compliance with this
 chapter is guilty of a Class 1 misdemeanor and is subject to a civil penalty of not more
 than ten thousand dollars.
