- 1 FOR AN ACT ENTITLED, An Act to authorize the Department of Veterans Affairs to provide
- for the design, construction, and equipping of a state veterans cemetery in Sioux Falls, to
- 3 make an appropriation therefor, and to declare an emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 5 Section 1. That the code be amended by adding a NEW SECTION to read:
- The Department of Veterans Affairs is hereby authorized to contract for the design,
- 7 construction, equipping, and any other action that may be required to provide for a state veterans
- 8 cemetery in Minnehaha County, South Dakota, at an estimated cost of six million dollars.

- 1 Section 2. That the code be amended by adding a NEW SECTION to read:
- 2 The State of South Dakota may accept the donation of suitable land from the city of Sioux
- 3 Falls, South Dakota, for the purposes of establishing and maintaining a state veterans cemetery.
- 4 Section 3. That the code be amended by adding a NEW SECTION to read:
- 5 The secretary of veterans affairs is hereby authorized to submit, prior to July 1, 2018, a state
- 6 cemetery pre-application to the National Cemetery Administration as provided in 38 CFR 39.31
- as amended to January 1, 2018, and to apply for a veterans cemetery grant.
- 8 Section 4. There is hereby appropriated from the general fund the sum of six hundred
- 9 thousand dollars (\$600,000), or so much thereof as may be necessary, to the Department of
- Veterans Affairs to provide for the design and planning work necessary for a state veterans
- 11 cemetery.
- Section 5. The secretary of veterans affairs shall approve vouchers and the state auditor shall
- draw warrants to pay expenditures authorized by this Act.
- Section 6. Any amounts appropriated in this Act not lawfully expended or obligated by
- June 30, 2019, shall revert in accordance with the procedures prescribed in chapter 4-8.
- Section 7. That the code be amended by adding a NEW SECTION to read:
- Once the application submitted pursuant to section 3 of this Act is approved, the entire
- amount appropriated pursuant to section 4 of this Act shall be repaid with grant funds received
- 19 from the United States Department of Veterans Affairs.
- Section 8. That the code be amended by adding a NEW SECTION to read:
- No indebtedness or obligation incurred or created under the authority of this Act may be or
- 22 may become a lien, charge, or liability against the State of South Dakota, nor against the
- property or funds of the State of South Dakota within the meaning of the Constitution or statutes
- of the state.

- 1 Section 9. That the code be amended by adding a NEW SECTION to read:
- 2 The Department of Veterans Affairs may accept, transfer, and expend any property or funds
- 3 obtained for these purposes from federal sources, gifts, contributions, or any other source, all
- 4 of which shall be appropriated to the project authorized by this Act in addition to the amounts
- 5 otherwise authorized by this Act.
- 6 Section 10. That the code be amended by adding a NEW SECTION to read:
- 7 The administration of the design and construction of the project authorized by this Act shall
- 8 be under the general charge and supervision of the Bureau of Administration as provided in
- 9 chapter 5-14.
- Section 11. Whereas, this Act is necessary for the support of the state government and its
- existing public institutions, an emergency is hereby declared to exist, and this Act shall be in
- 12 full force and effect from and after its passage and approval.
