

HOUSE BILL 504

AN ACT to amend Tennessee Code Annotated, Title 3; Title 4; Title 5; Title 6; Title 7; Title 8; Title 9; Title 12; Title 16; Title 30; Title 36; Title 39; Title 40; Title 43; Title 45; Title 47; Title 48; Title 49; Title 55; Title 56; Title 57; Title 61; Title 62; Title 67; Title 68; Title 69; Title 70 and Title 71, relative to the functions of governmental entities.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 43-38-1107, is amended by deleting the language "which may be in facsimile" and by substituting instead the language "which may be in electronic format".

SECTION 2. Tennessee Code Annotated, Section 48-51-308, is amended by deleting the language "(which may be in facsimile)" and by substituting instead the language "(which may be in electronic format)".

SECTION 3. Tennessee Code Annotated, Section 48-247-107, is amended by deleting the language "(which may be in facsimile)" and by substituting instead the language "(which may be in electronic format)".

SECTION 4. Tennessee Code Annotated, Section 48-249-1011, is amended by deleting the language "which may be in facsimile" and by substituting instead the language "which may be in electronic format".

SECTION 5. Tennessee Code Annotated, Section 61-1-1208(e), is amended by deleting the language "(which may be in facsimile)" and by substituting instead the language "(which may be in electronic format)".

SECTION 6. Tennessee Code Annotated, Section 61-2-1108, is amended by deleting the language "(which may be in facsimile)" and by substituting instead the language "(which may be in electronic format)".

SECTION 7. Tennessee Code Annotated, Section 67-3-704(c), is amended by deleting the language "shall immediately notify the department by facsimile of the delivery, if facsimile service is reasonably available; but if not, by the next quickest means available" and by substituting instead the language "shall immediately notify the department of the delivery by electronic transmission, if reasonably available; but if not, by the next quickest means available".

SECTION 8. Tennessee Code Annotated, Section 67-3-801(d), is amended by deleting the language "provided, that such operator shall, prior to manually preparing such papers, provide facsimile notice to the department," and by substituting instead the language "provided, that the operator shall, prior to manually preparing the papers, provide electronic notice to the department,".

SECTION 9. Tennessee Code Annotated, Section 67-3-808(b), is amended by deleting the language "shall immediately notify the department by facsimile of the delivery" and by substituting instead the language "shall immediately notify the department of the delivery by electronic transmission".

SECTION 10. This act shall take effect January 1, 2016, the public welfare requiring it.
