AN ACT to amend Tennessee Code Annotated, Title 2; Title 3; Title 4; Title 6; Title 7; Title 8; Title 10; Title 12; Title 13; Title 35; Title 47; Title 48; Title 64; Title 65; Title 68 and Title 71, relative to changing the name of the Tennessee Regulatory Authority.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 82. The Tennessee Code Commission is requested to change appropriate references from the "Tennessee regulatory authority," "TRA," "regulatory authority," and "authority," when those terms are referring specifically to the name of the Tennessee regulatory authority, to "Tennessee public utilities commission," "public utilities commission," and "commission," as appropriate, as sections are amended and volumes are replaced.

SECTION 83. This act shall take effect upon becoming law, the public welfare requiring it.
