## **HOUSE BILL 1254**

## By Curtiss

AN ACT to amend Tennessee Code Annotated, Title 3, Chapter 6, Part 3, relative to governmental ethics.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

- SECTION 1. Tennessee Code Annotated, Title 3, Chapter 6, Part 3, is amended by adding the following language as new, appropriately designated sections:
