WHEREAS, he also served on the Alamo City Board of Education, the Crockett County Board of Education, and as chair and board member of the Gibson Electric Co-op Board of Trustees, and as an Alamo City alderman; and WHEREAS, Mr. Goode believed in giving back to his community, and he and his wife founded the Mack and Mary June Goode Special Needs Fund, which provides assistance to special needs children and their families; and

WHEREAS, Mack Goode was an avid hunter, golfer, and fisherman; he also enjoyed traveling and participating in politics; and

WHEREAS, Mr. Goode was an active and devout member of the Alamo Church of Christ, which he served faithfully for many years; and

WHEREAS, deeply devoted to his family, Mack Goode always endeavored to remain true to family values of the highest order; and

WHEREAS, Mr. Goode enjoyed the loving companionship of Mary June, his wife of sixty years, and was the proud father of Reecha Goode Black and Bobby Mack (Melinda) Goode, and a loving grandfather and great-grandfather; and

WHEREAS, Mack Goode leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and

WHEREAS, it is fitting that this General Assembly should pause to remember the bountiful life of this exceptional public servant and human being; now, therefore,
